

## LOCATION

The property is located on the established Dawkins Road Industrial Estate, just off the main A350 Blandford Road which links Poole Town Centre (approx. 2 miles distant), and the A35 with subsequent access to both the M27 and the west.

The unit also has good access to the Port of Poole which provides regular passenger and freight services to the continent and Channel Islands.

#### DESCRIPTION

The property comprises a detached industrial / warehouse property which has recently been comprehensively refurbished. The specification includes the following:

- Steel portal frame with external facing brick and composite cladding.
- Steel clad, composite insulated roof sheets over dual pitch roof, incorporating polycarbonate roof lights.
- LED lighting
- 4 x electrically powered roller shutter doors (5.4m wide by 5.2m high) plus 2 smaller roller shutters at the rear.
- Male & female WC & shower
- 3 phase electricity supply
- Concrete loading aprons & parking
- Large rear yard with dual access.
- 7.5m approximate internal eaves height.
- Ancillary offices & kitchenette.
