LOCATION

Harpenden is an affluent commuter town with excellent transport links situated circa 30 miles north of central London. The property is located just off Luton Road, 1 mile and 20 minutes' walk from Harpenden town centre.

Junction 10 of the M1 is 3 miles to the north, Junction 9 of the M1 is 4 miles to the west and Junction 5 of the A1(M) is 7 miles to the east. The M25 (Junction 21) is approximately 11 miles to the south via the M1.

Harpenden railway station is on the Thameslink line with a fast and frequent service to St Pancras International (fastest journey time 27 minutes), with further stops in the City, Gatwick Airport and Brighton.

Luton airport is approximately 5 miles to the north. Heathrow and Stansted airports are 35 and 45 miles distant from the property.

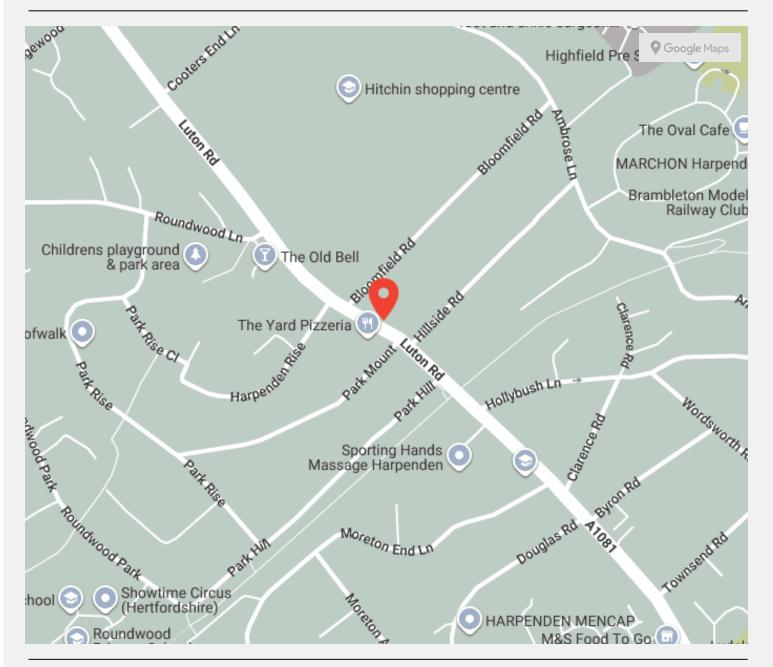
M1 (Junction 10) - 3 miles
