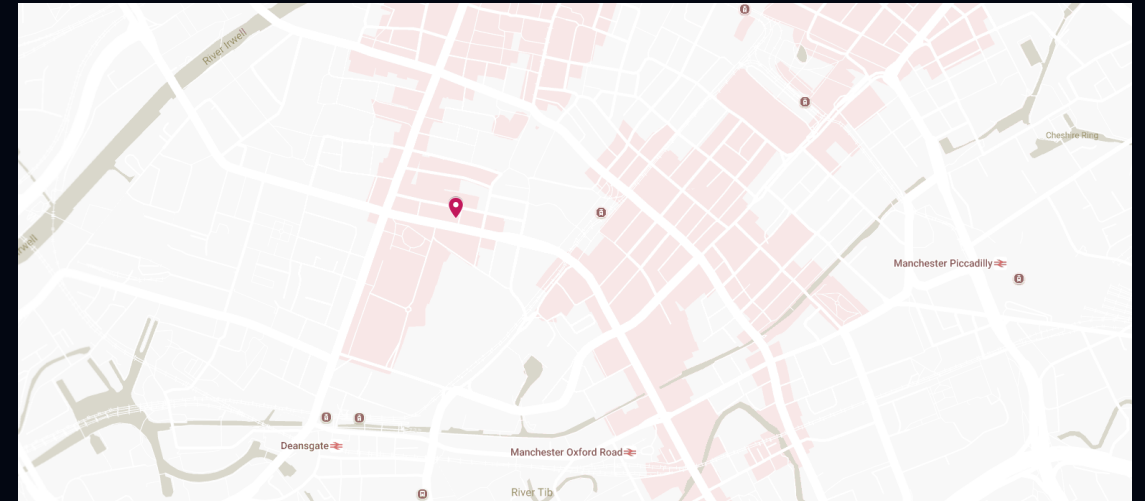
This property comprises a mixed-use building arranged over 7 floors, with a restaurant space on part of the ground floor and basement and office space throughout the 5 floors above.

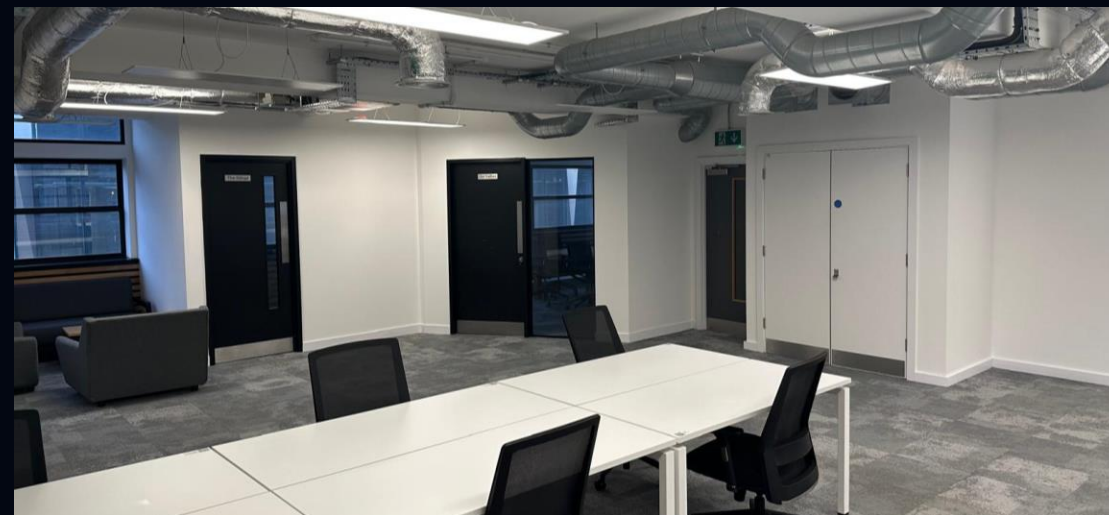
