GENERAL DESCRIPTION

A rare opportunity to obtain a readymade property portfolio of three former terraced houses in a self-contained block. All properties are of brick elevation with slate tile roof coverings originating from the Victorian era.

The portfolio consists of two 1 bedroom flats at 49 Hulton Street, a 2 bedroom terraced house at 51 Hulton Street and two 1 bedroom flats at 53 Hulton Street. The flats at 49 Hulton Street have been redecorated and new tenants have recently moved in on new tenancy agreements and with new EPC's. 51 Hulton Street is rented at £9,000pa to another new tenant and has been recently refurbished. 53 Hulton Street is a double fronted former terraced house with an extension on the ground floor creating a larger than usual 1 bedroom flat with separate entrance at the rear. All of the properties being sold benefit from UPVC double glazed windows, UPVC front doors and gas central heating.

LOCATION

49-53 Hulton Street is located adjacent to Town Road which leads into Hanley city centre at the west and out of the city and past Central Forest Park a short walk to the north. The property is around a third of a mile from the middle of Hanley and on a number of bus routes around Stoke on Trent including access to the main hospital and universities.

SERVICES

All main services are connected. No services have been tested by the agents. All of the flats have recently had new combi boilers installed.

TENANCY DETAILS

Number 49 ground is rented at £550pcm on a new AST and 49 first is rented for £600pcm on a new AST
Number 51 is rented on a new AST at £750pcm.
Number 53 ground is rented at £550pcm and 53 first is rented at £525pcm, both on AST's.

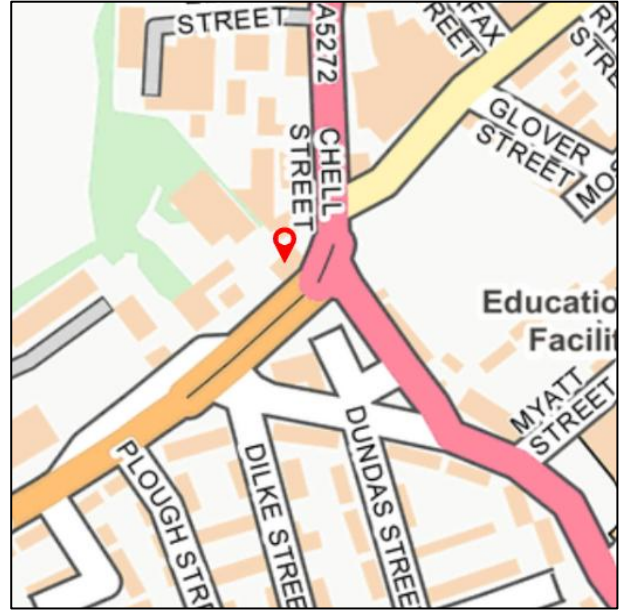
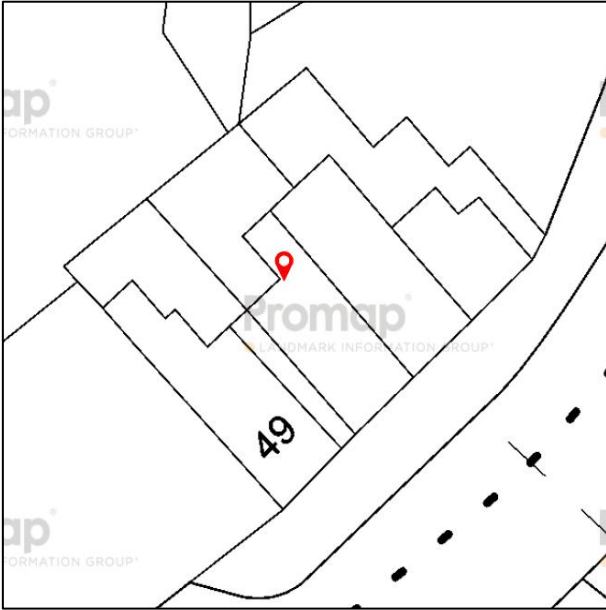
