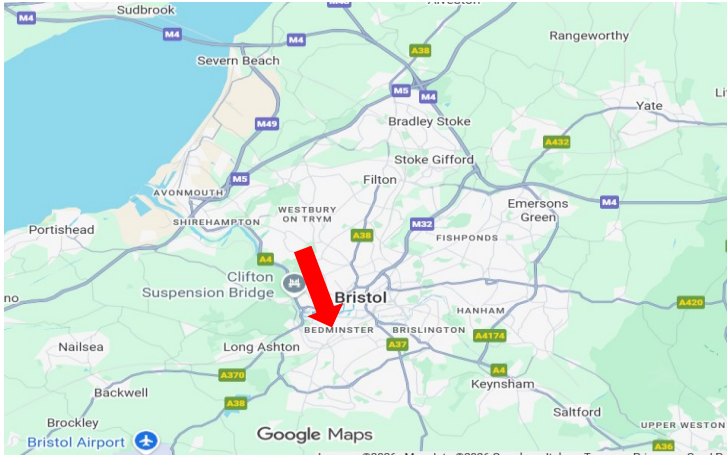

LOCATION



The property is located within 1 mile of Bristol city centre.

Junction 3 of the M32 Motorway is approximately 2 miles from the property, which in turn provides access to Junction 19 of the M4. The Bath Road is 1.5 miles from the property.

Bristol Temple Meads train station is also only 1 mile from the property.

DESCRIPTION

The property totals approximately 1,177 sq ft. There is 1,036 sq ft of industrial / warehousing accommodation on the ground floor, with 141 sq ft of office accommodation to the first floor. The unit benefits from an eaves height of 3.6m and a height to pitch of 6.2m. The loading door is 2.8m high and 3.2m wide.

The building comprises blockwork elevations, underneath a sloped insulated steel profile roof. There is strip lighting throughout the warehouse.

The warehouse benefits from a level loading door, painted walls and a concrete floor.

Externally, the unit has a concrete apron to the front of the building, providing dedicated parking and loading.

We understand the property benefits from a mains gas connection, 3 phase electrical power, mains water and drainage.
