

Location

Crow Arch Lane Industrial Estate is located approximately 1 mile to the east of Ringwood Town Centre with ease of vehicular access through the town or to the main A31 dual carriageway via Crow Arch Lane and Hightown Road/Eastleigh Lane. The A31 connects with the M27/M3 motorway networks to the east and to Dorchester and beyond to the west.

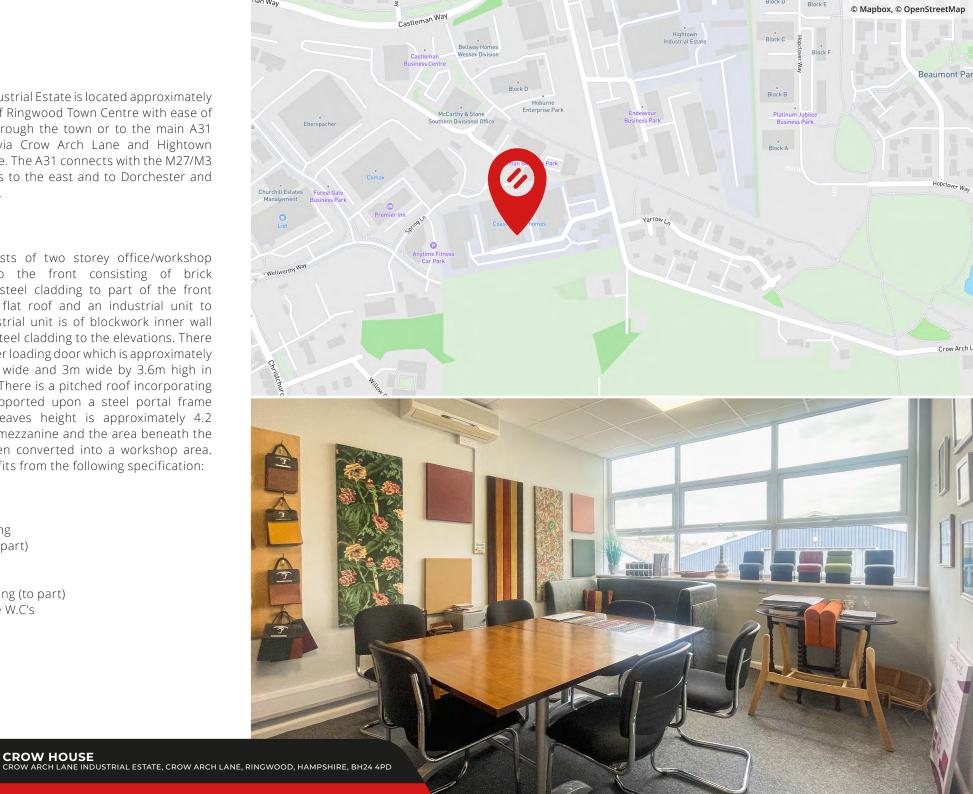
Description

Crow House consists of two storey office/workshop accommodation to the front consisting of brick construction with steel cladding to part of the front elevation under a flat roof and an industrial unit to the rear. The industrial unit is of blockwork inner wall construction with steel cladding to the elevations. There are two roller shutter loading door which is approximately 4.1m high by 3.7m wide and 3m wide by 3.6m high in the rear elevation. There is a pitched roof incorporating daylight panels supported upon a steel portal frame and the internal eaves height is approximately 4.2 metres. There is a mezzanine and the area beneath the mezzanine has been converted into a workshop area. The premises benefits from the following specification:

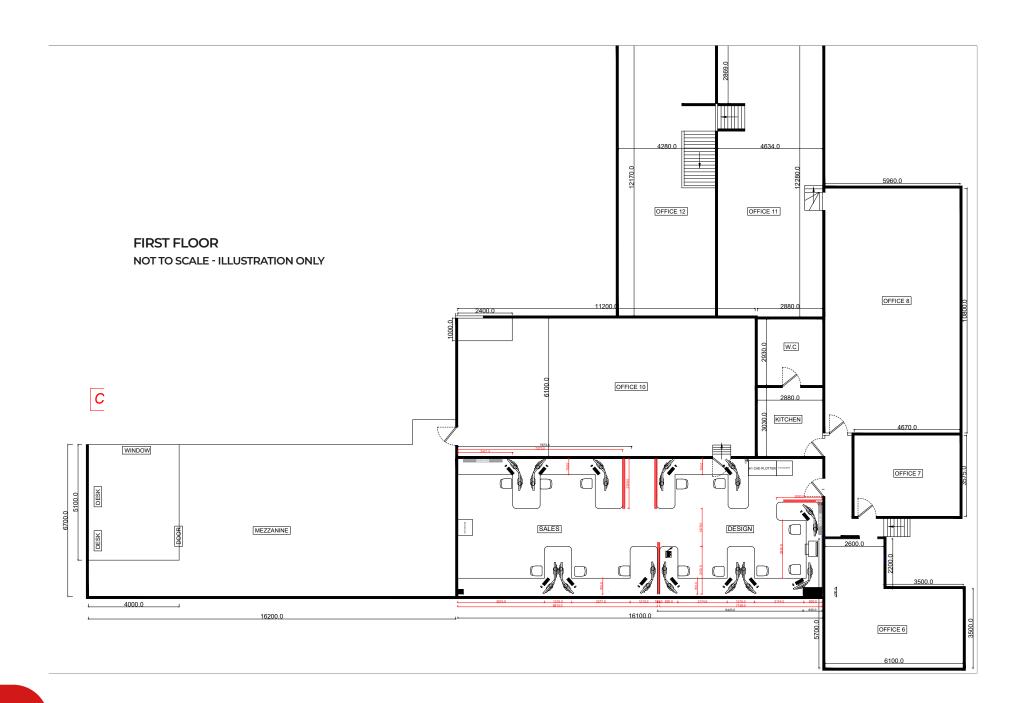
