The property is situated on Reads Road in Fenton Industrial Estate, approximately 1.6 miles from the A50 dual carriageway and approximately 2 miles to the south of Hanley (City Centre).

The estate comprises a total of 25 workspace units of various sizes. Surrounding occupiers to the subject property include Beacon Supplies and MGD Online.

The property comprises of a mid-terrace workspace unit of steel frame and masonry construction beneath a pitched steel profile clad roof surface incorporating sky lights.
