Location

The property occupies a convenient location within the popular Maes-Y-Clawdd Industrial Estate approximately 2 miles south east of Oswestry Town Centre with convenient access to the main A5 and A483 trunk roads.

Oswestry is an important market town and commercial centre within the North Shropshire economy supporting a current population in excess of 18,000 people. 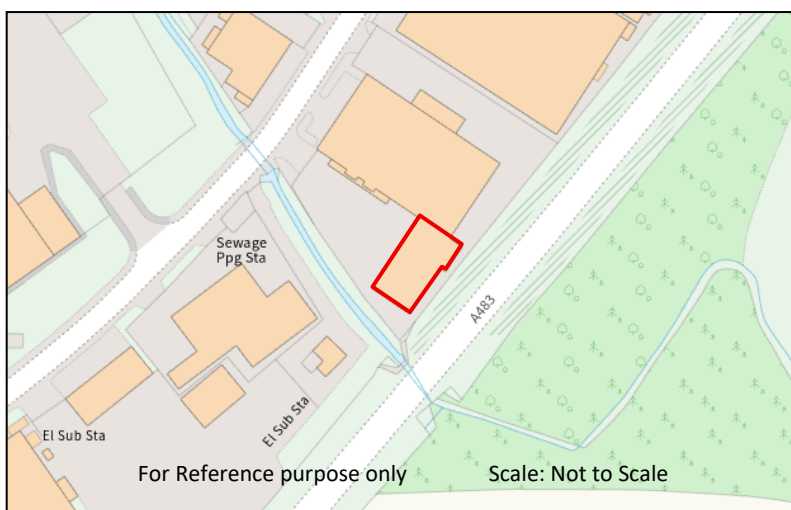
