Location

Trade City Luton is located on Kingsway, which forms part of Dallow Road, the principal industrial area in Luton.

The estate is situated in the heart of the Luton Investment Framework area; a major £1.5bn transformation scheme aiming to improve local infrastructure and connectivity, as well as the development of new housing and employment opportunities across the town. The benefits of this initiative will be enjoyed as early as 2023, when a new high-speed rail link is due to open and enable 30-minute travel from Luton into London St Pancras.

The scheme benefits from a highly prominent and visible position alongside Hatters Way (A5065), one of the main routes into the centre of Luton that has close to 25,000 cars travel along each day, with the spine of the Luton-Dunstable Busway running parallel and accessible via two stops within a 0.6-mile radius of Trade City.

Junction 11 of the M1 is approximately 1.5 miles away – providing access to both the North and to Central London. The M25 is 15 miles away, offering connectivity across the South of England.
