Location

The units are located within the popular and well established Albion Park Industrial Estate, which is accessed from Armley Road via Wellington Street (A58) and Canal Street (A647) and leads to Albion Way.

The site is situated approximately 1 mile south west of Leeds city centre and 1/2 a mile from the Armley Gyratory which provides direct access to junction 2 of the M621 motorway.


