The Site

The site extends to approximately 0.231 acres (0.093 ha) and comprises an industrial building with secure yard. The building comprises a detached industrial unit of steel portal frame construction which is currently split into two units.

Unit 1

Unit 1 comprises a steel portal frame industrial unit with part brick/clad elevations. Internally, the property benefits from a solid concrete floor and suspended strip lighting. The unit offers a minimum eaves height of 4.46m to the haunch rising to 5.54m to the apex. Access is facilitated via two up and over roller shutter doors, each measuring 4.41 meters in height and 4.57 meters in width. The accommodation also features a small office space to the front of the unit.

Unit 2

Unit 2 is a less modern two storey brick-built unit with up and over roller shutter access for vehicles and can also be accessed from the adjoining unit. The building is currently split into two separate units with the smaller unit to the rear benefitting from an office area and WC facilities. The larger unit to the front is currently functioning as a storage area and second floor is currently used as storage space in addition.

The units are equipped with 3-phase electricity throughout. Externally the site is gated and benefits from a secure steel palisade fence surrounding the site.

Location

Craghead Industrial Estate sits on the outskirts of Stanley, offering strong transport links. Other major towns in close proximity include Consett, Chester le Street and Lanchester.

Stanley is conveniently situated just approximately 9 miles north of Durham and 10 miles south of Newcastle upon Tyne. While directly adjacent to the A1(M) which is the region's major motorway providing excellent access north and south.

Other occupiers within Craghead Industrial Estate include L & B Travel, Johnsons Vauxhall Breakers, MD Shotblasting and Durham Artstone.

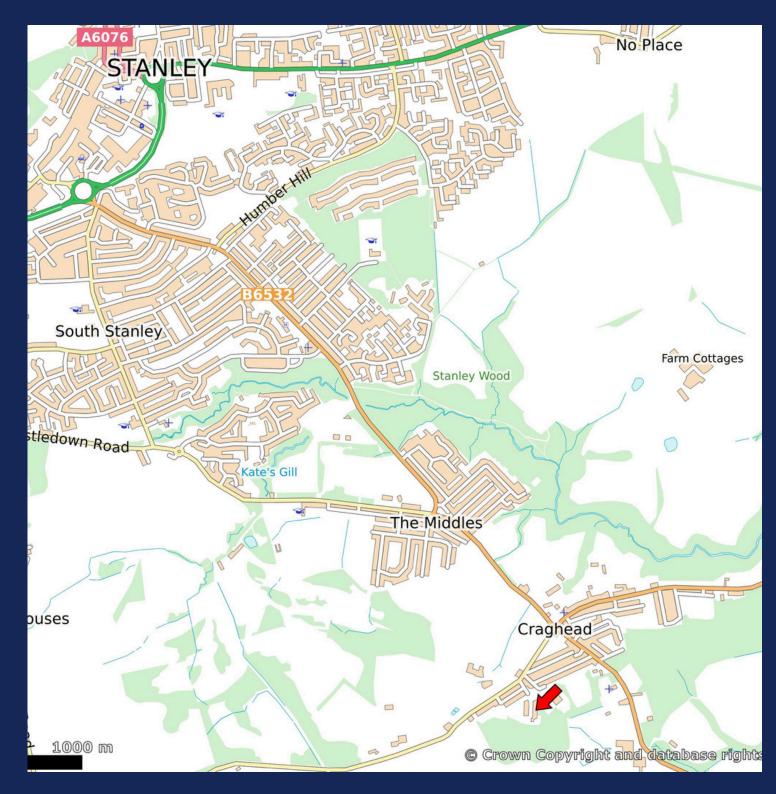

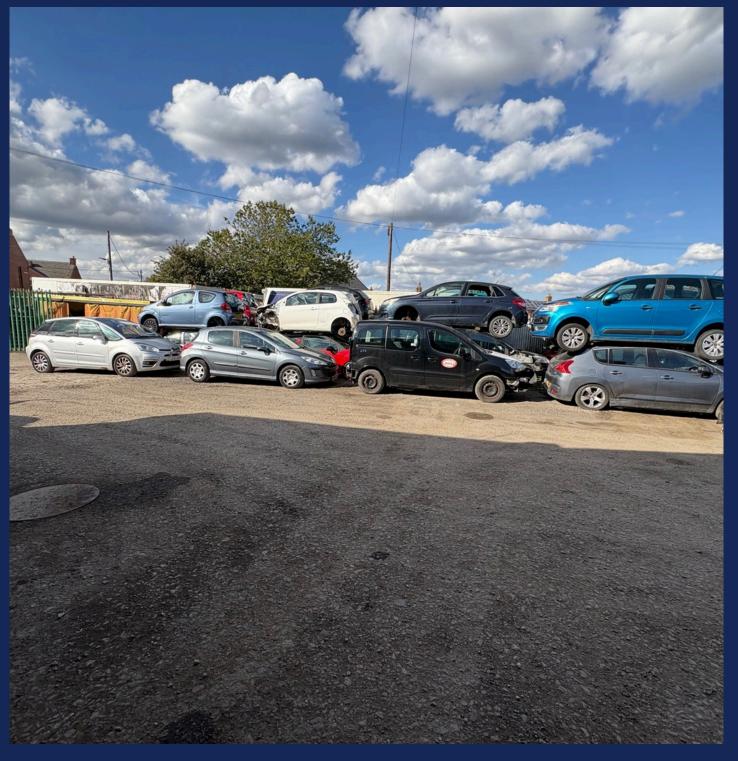
