### Location

Part of the City Trading Estate, which is located 1-mile north of Norwich city centre. It is a prominent edge of city centre location providing direct access onto the city's inner ring road (A147). Close by there are numerous national occupiers including CEF, Screwfix, Huws Gray as well as the likes of Go Outdoors and Halfords.

### Description

The unit faces into Kingsway and backs directly onto Barker Street providing the tenants with excellent roadside prominence.

The property was constructed in the 1970's and is of steel portal frame construction with part brick/blockwork and part profiled steel-clad elevations under a single pitch insulated roof, incorporating roof lights.

The unit has a ground floor office, WCs & kitchen to the front elevation.

The underside ridge height is 7.4 m with perimeter eaves heights of 4.8 m. The roller shutter door has an approx. height of 4m. Externally the unit has 5 car parking spaces.
