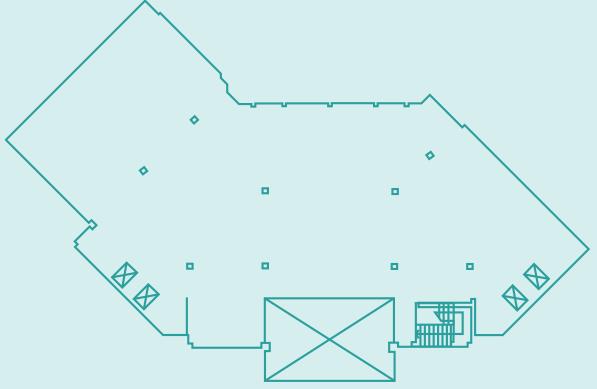

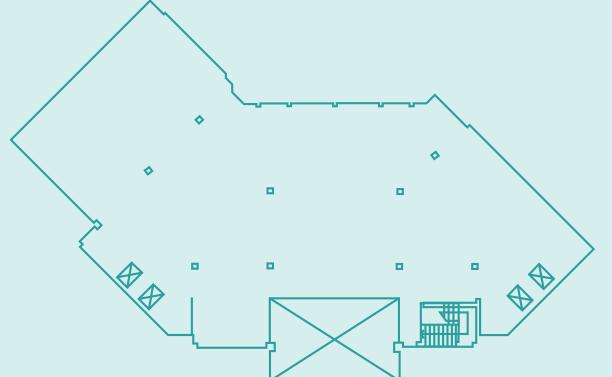
DESCRIPTION

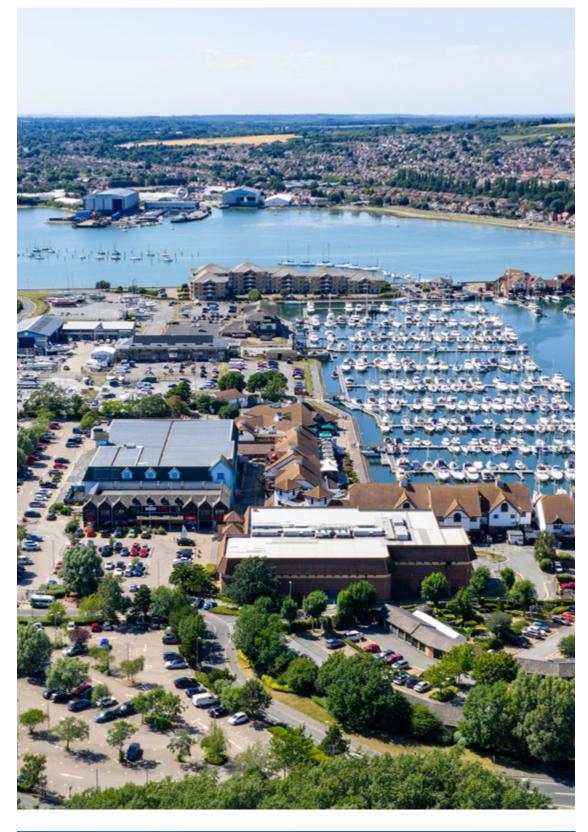


FLOOR PLAN FOR INDICATIVE PURPOSES













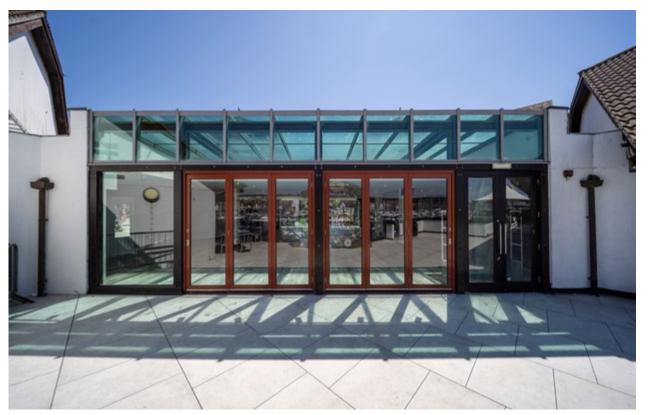
