

**19.5 ACRES

LOCATION

Hartlebury is an established industrial location to the south of Kidderminster, in Worcestershire. Situated close to the A449, the area benefits from strong transport links, with direct access to the strategic road network and onward connectivity to the M5 and M42, providing efficient links to the wider Midlands and national motorway network. In addition to its road connections, the location is supported by nearby rail services via Hartlebury Station, and sits within a well-established commercial environment anchored by Hartlebury Trading Estate and surrounding employment uses.

The immediate locality is characterised by a mix of industrial, warehouse and trade occupiers, benefitting from access to the local labour pool and proximity to the amenities and services of Kidderminster and nearby towns. The wider area provides a practical operating environment for industrial users, combining established infrastructure, a strong occupier base, and convenient access to key regional routes.

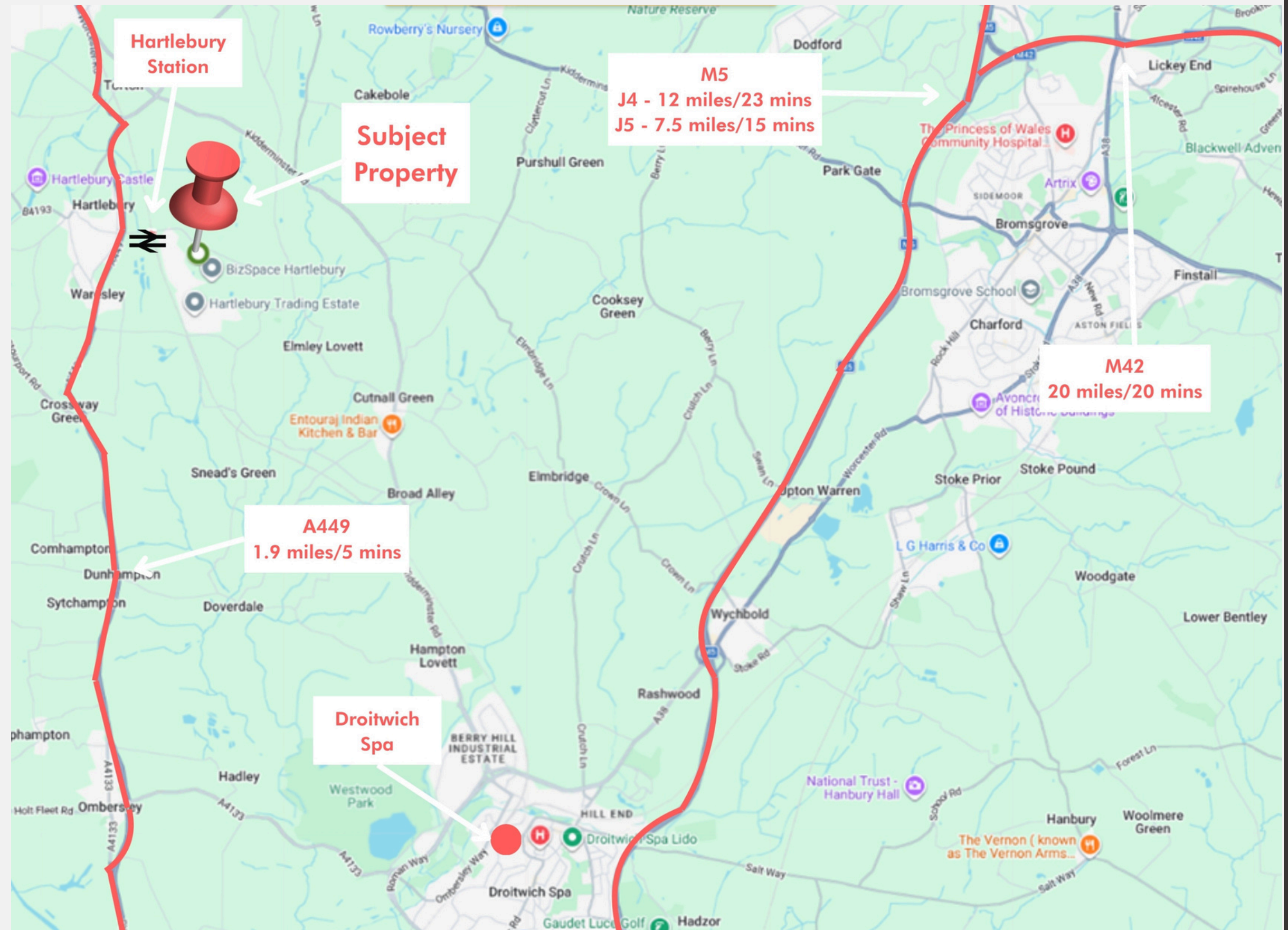
SITUATION

The site is located immediately adjacent to Hartlebury Trading Estate on Walton Road and presents an opportunity for development (subject to planning). The location benefits from excellent access to the strategic road network via the A449 dual carriageway, which connects to Junction 6 of the M5 (approx. 10 miles), with wider connectivity onward to the M42 and the national motorway network. The surrounding area is characterised by established commercial and industrial occupiers, with Kidderminster town centre approximately 5 miles to the north.

DESCRIPTION

The site comprises an area of land extending to approximately 19.5 acres (7.9 hectares). It is predominantly undeveloped land and may be suitable for a range of uses (subject to planning). The site is located in close proximity to Hartlebury Trading Estate, with the surrounding area characterised by a mix of established industrial occupiers and open land.

PLANNING

The principal planning history to the south of the site relates to the continued occupation, redevelopment and expansion of Hartlebury Trading Estate and adjoining commercial land. The surrounding area is therefore characterised predominantly by employment-generating development, including industrial, warehouse and related commercial uses (B1, B2, B8) as well as neighbouring residential.
