

Location

- Totton is a town located to the west of Southampton City Centre and within the New Forest District
- The railway station, which is very close to the property links it to Southampton Central Station and thereafter on the mainline Waterloo
- Transport links lead to the M271, M27, M3 and the A35 leads west into the New Forest

Description

- The property comprises one unit in a row of four similar ground floor lock-up office/retail units
- The property is fitted out as offices on both floors, with rear access to an enclosed yard. A kitchenette and WC are located on the first floor
- The lay-by to the front allows a 'short stop' for visiting customers and there is an abundance of short and long stay car parking very close by

Lease

The premises are to be let on a new effectively full repairing and insuring lease for a term to be agreed. A 3 month rent free period subject to lease terms agreed..

These premises have most recently been used as an office which is a Class E Use and other uses within this class may be considered such as retail, medical, leisure and light industrial.




