DESCRIPTION

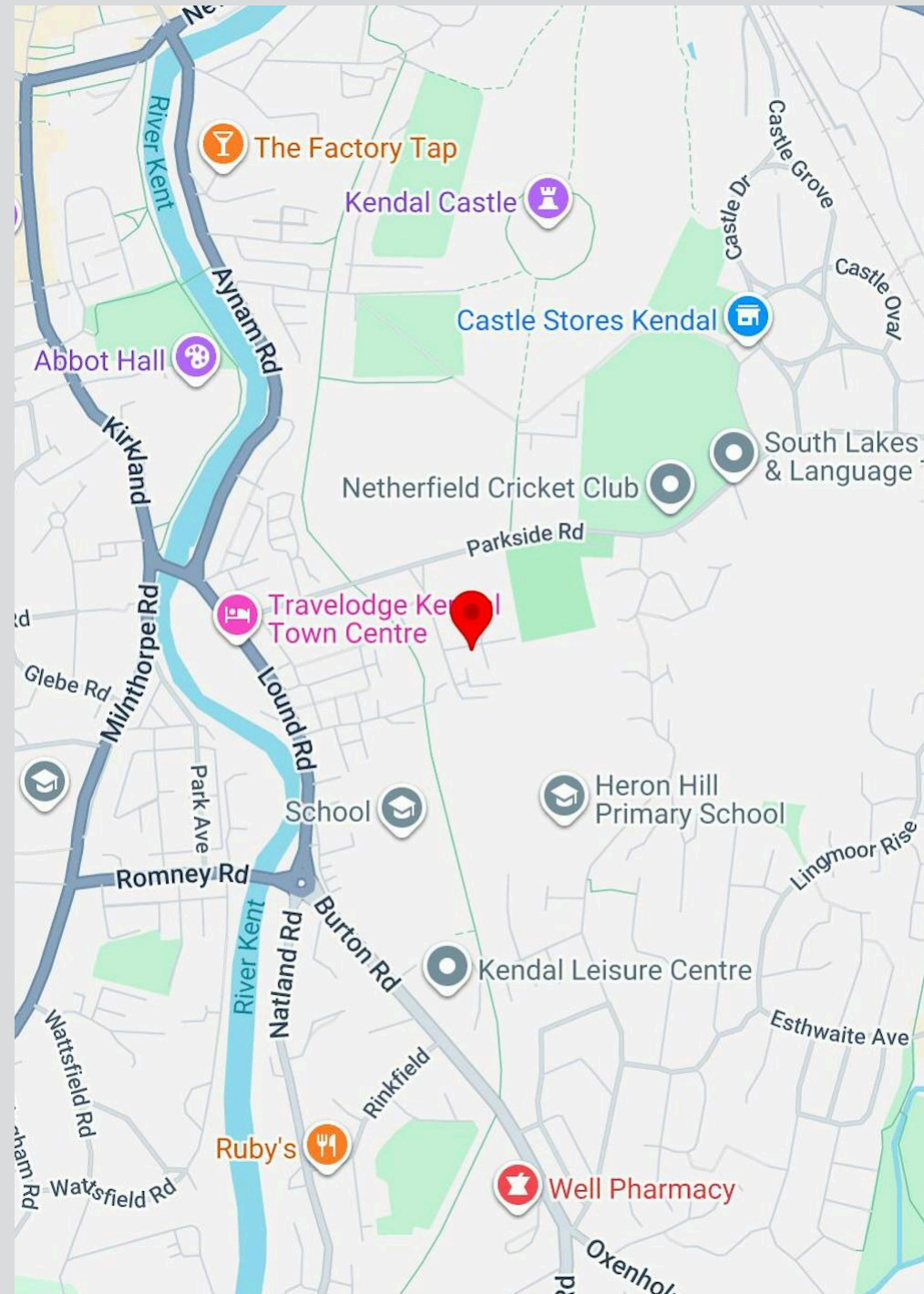
An opportunity to lease a modern single-storey warehouse unit with integral two-storey office accommodation.

The property is of modern construction, incorporating a steel portal frame with lined and insulated profile sheet cladding. The external elevations are part rendered with profile sheet cladding above, providing an attractive and practical finish.

Internally, the workshop/warehouse offers excellent open-plan accommodation with a full eaves height of approximately 5 metres, making it suitable for a variety of industrial, storage and distribution uses. To the front of the property are a number of ground-floor offices, with additional office and storage accommodation situated on the first floor.

The property further benefits from a security alarm system and CCTV coverage throughout, providing enhanced security for occupiers.

LOCATION

The property is located on Parkside Business Park, to the south of Kendal, and benefits from excellent transport links to Kendal town centre and Junction 36 of the M6 motorway.

The unit forms part of a well-established industrial and business park, occupied by a range of local and regional businesses, including Kendal Judo Club, SBS and Cumbria Heating Components. The location provides a convenient and accessible base for a variety of industrial, trade counter, warehouse and office occupiers.
