Location

The property is situated in Mexborough, a town in the City of Doncaster District in South Yorkshire. Located between Manvers and Denaby Main on the River Don. Mexborough is 7 miles south-west of Doncaster, 6 miles north-east of Rotherham and 10 miles south-east of Barnsley. Neighbouring properties include Co-op Food, St John's Methodist Church, The Robin Hood Inn and Swinton Primary School.

Mexborough has a history of settlement dating back to at least Norman times and is home to a number of historic landmarks, including the Mexborough Castle. The town is historically known

for its glass bottle and pottery industries, along with coal mining, brickwork's and quarrying.

Station Road benefits from a good road network with the M18 being within 6.8 miles, M1 Junction 35 and the A1(M) Junction 36 being within 7.1 miles. Mexborough train station is approximately 1.3 miles away with direct links to Sheffield, Doncaster and Leeds.

Located within the Mexborough Conservation area, planning permission is needed for improvement works to the property within the removal of most permitted development rights (PDRs) under Article 4(2) Directions.

Description

This property presents an exciting and rare development opportunity in the heart of Swinton, with planning permission granted for the creation of 17 residential flats.

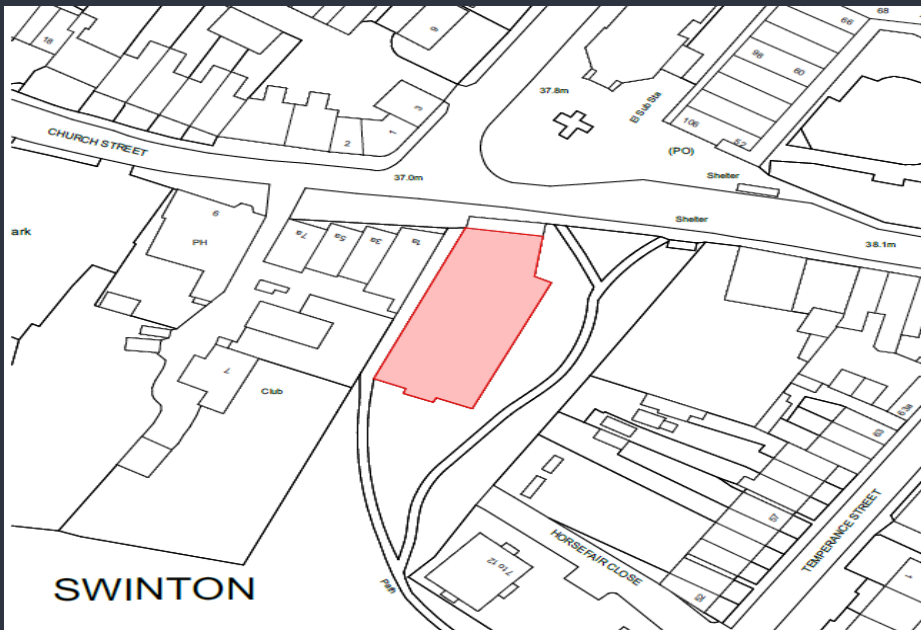
Two storey building is situated directly to the south and east of a public open space which forms the northern area of Swinton Park. The detached premises comprises a brick structure beneath a flat and pitched roof. The property extends across approximately 11,000 Sq Ft (1,021.93 Sq M). The total site boundary extends across 0.22 acres (0.08 Ha).

Planning Permission

Since 1993, the premises on the southern side of Station Street has been referred to as Cafe Sport. The former sports bar was granted conditional planning permission (Application Reference RB2024/0341) in September 2024 for the conversion of 12 flats, of which comprises two 2 bedroom, 8 one bedroom and 2 studio flats.

The application reference RB2025/0401 sought full planning permission for external alterations to the building which includes an increase in building height to create a second floor over the existing ground and first floor. The application sought approval for 5 additional units in the newly created second floor, comprising four 1 bedroom and one 2 bedroom flats.

The applications (RB2024/0341 and RB2025/0401) were granted conditional with the development permitted to commence before the expiration of 3 years from the date of the permission granted.

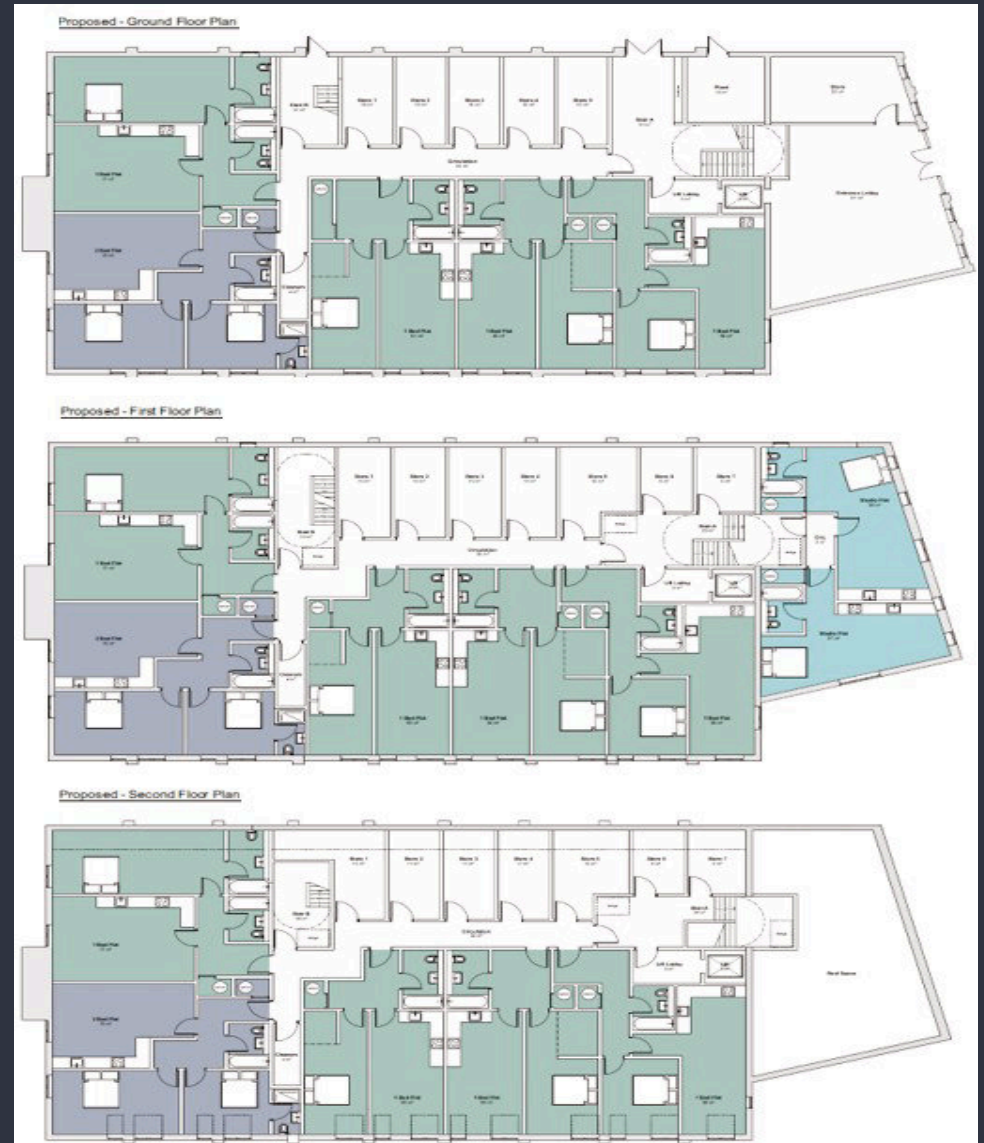
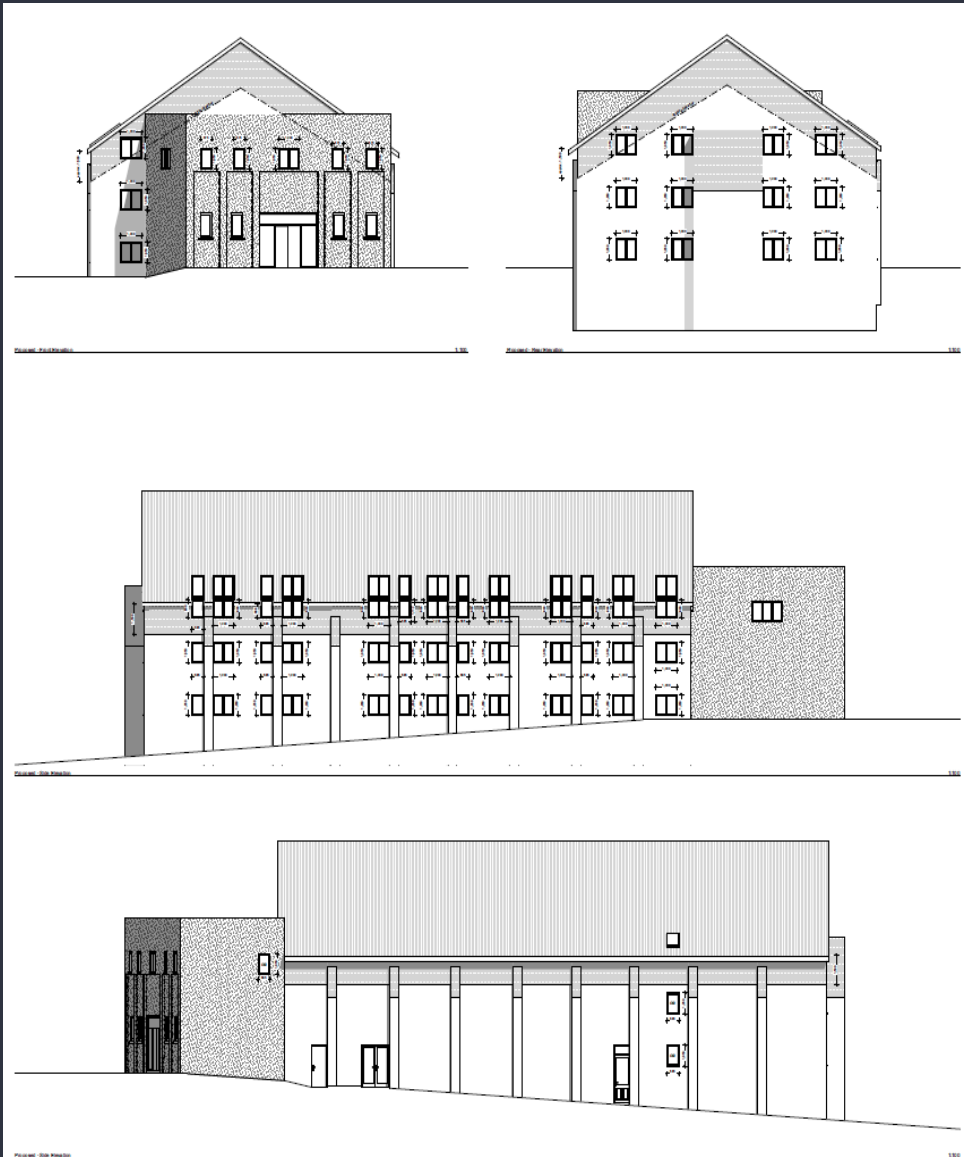

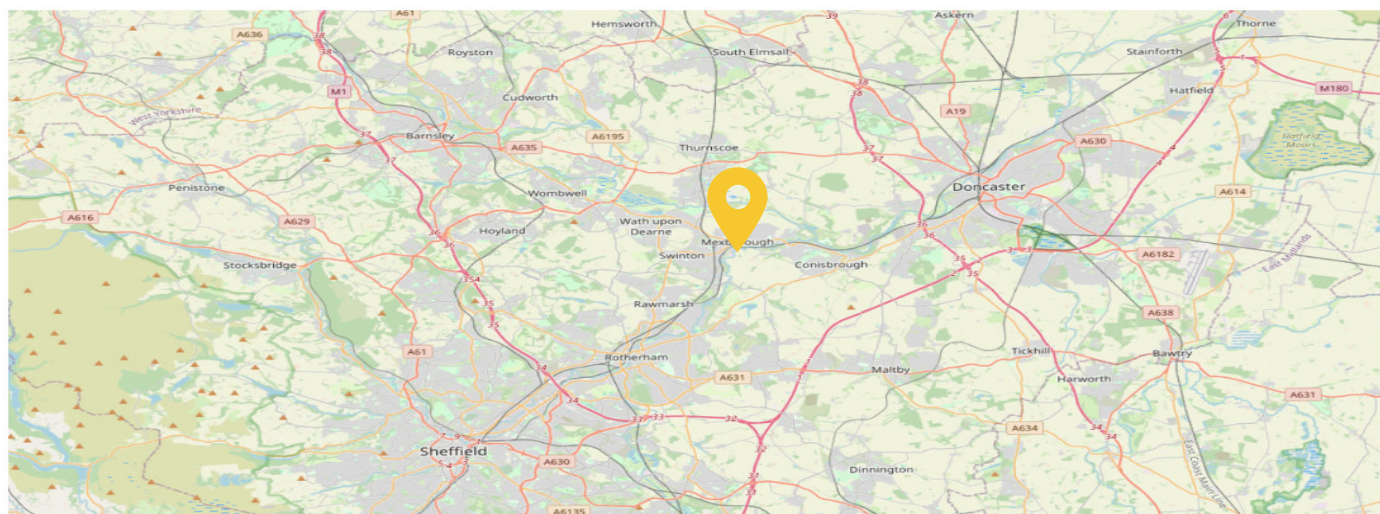
