DESCRIPTION

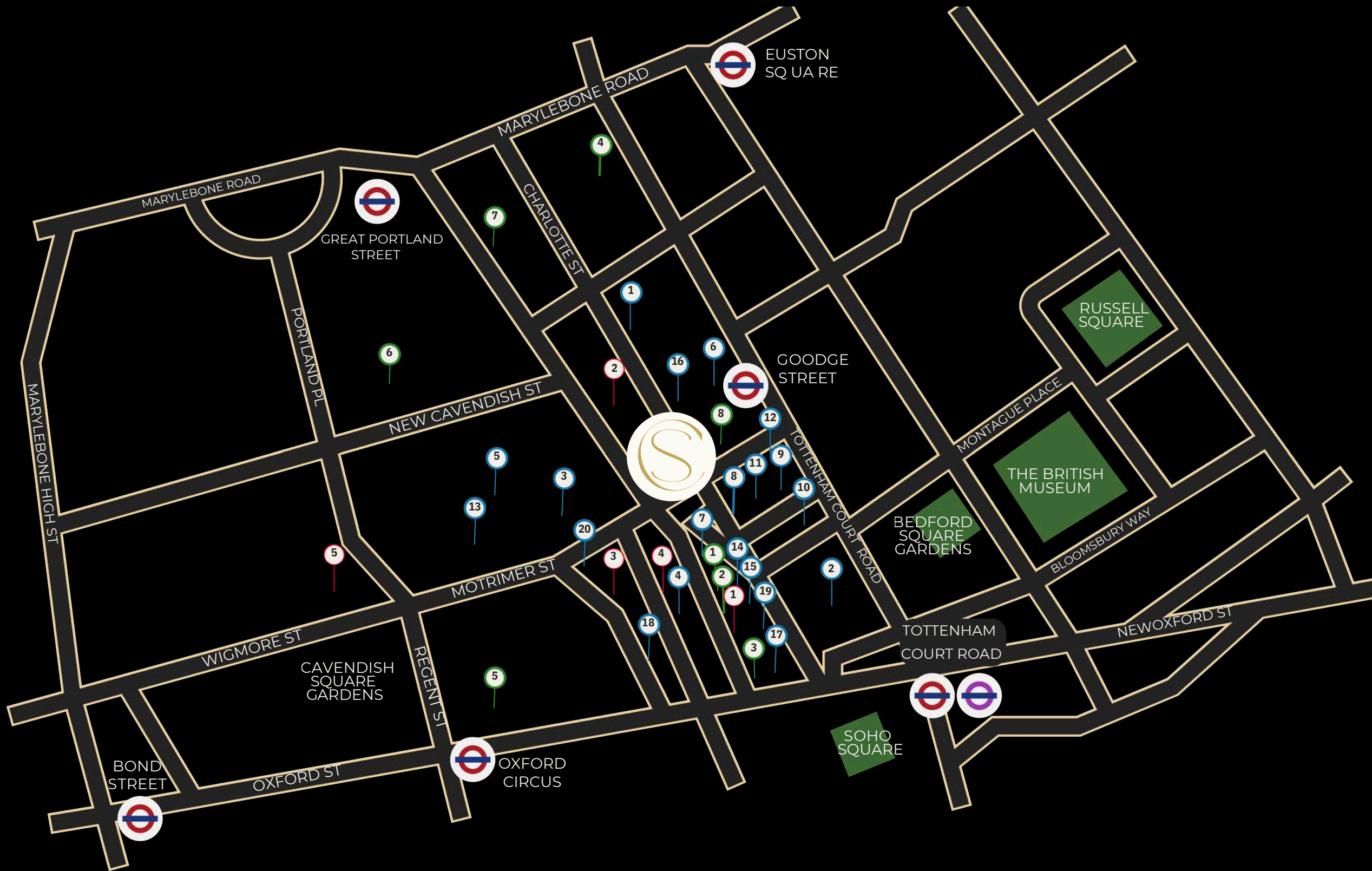
The opportunity occupies a highly prominent corner position within an attractive and characterful period building, arranged over lower ground and ground floors.

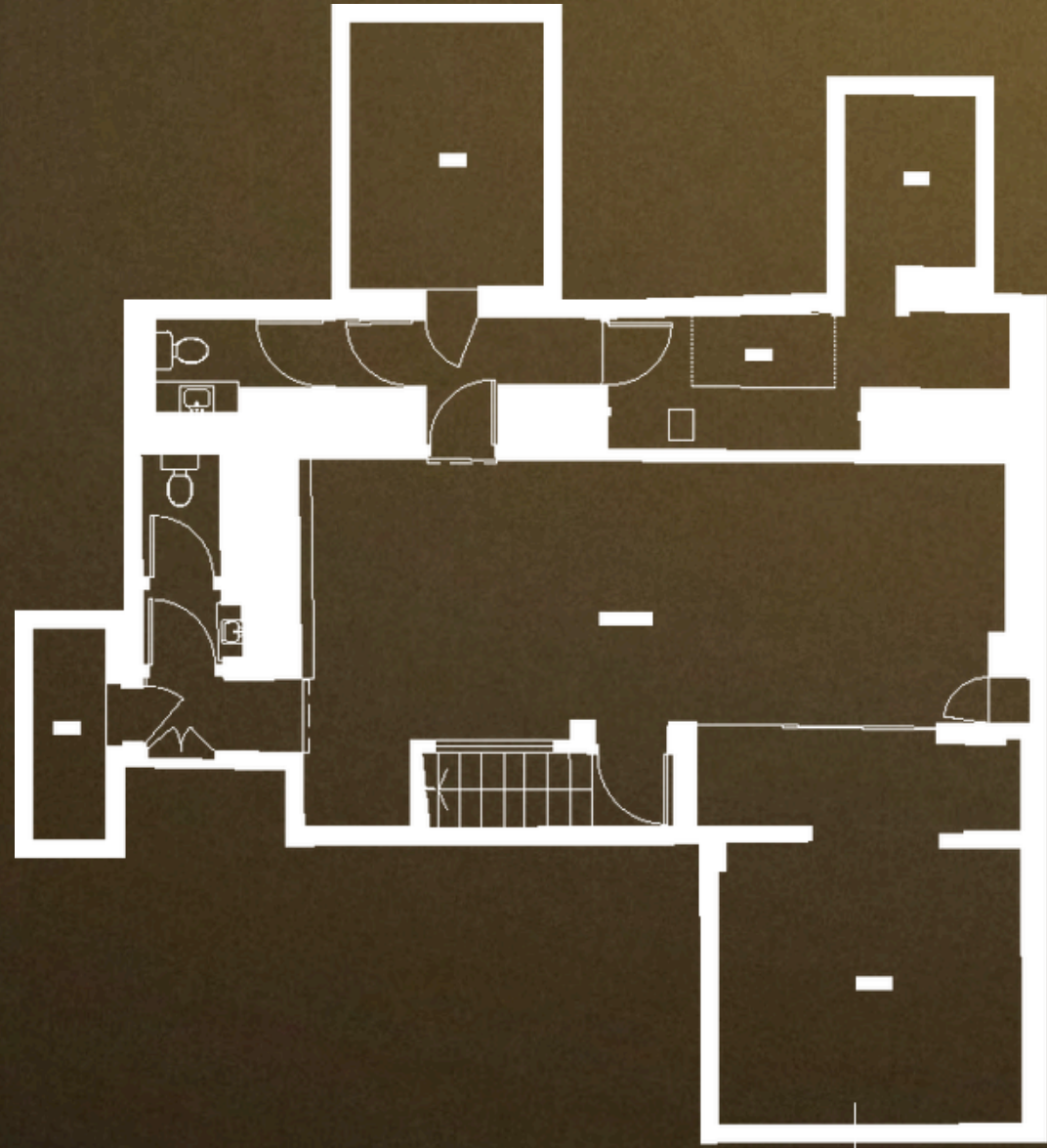

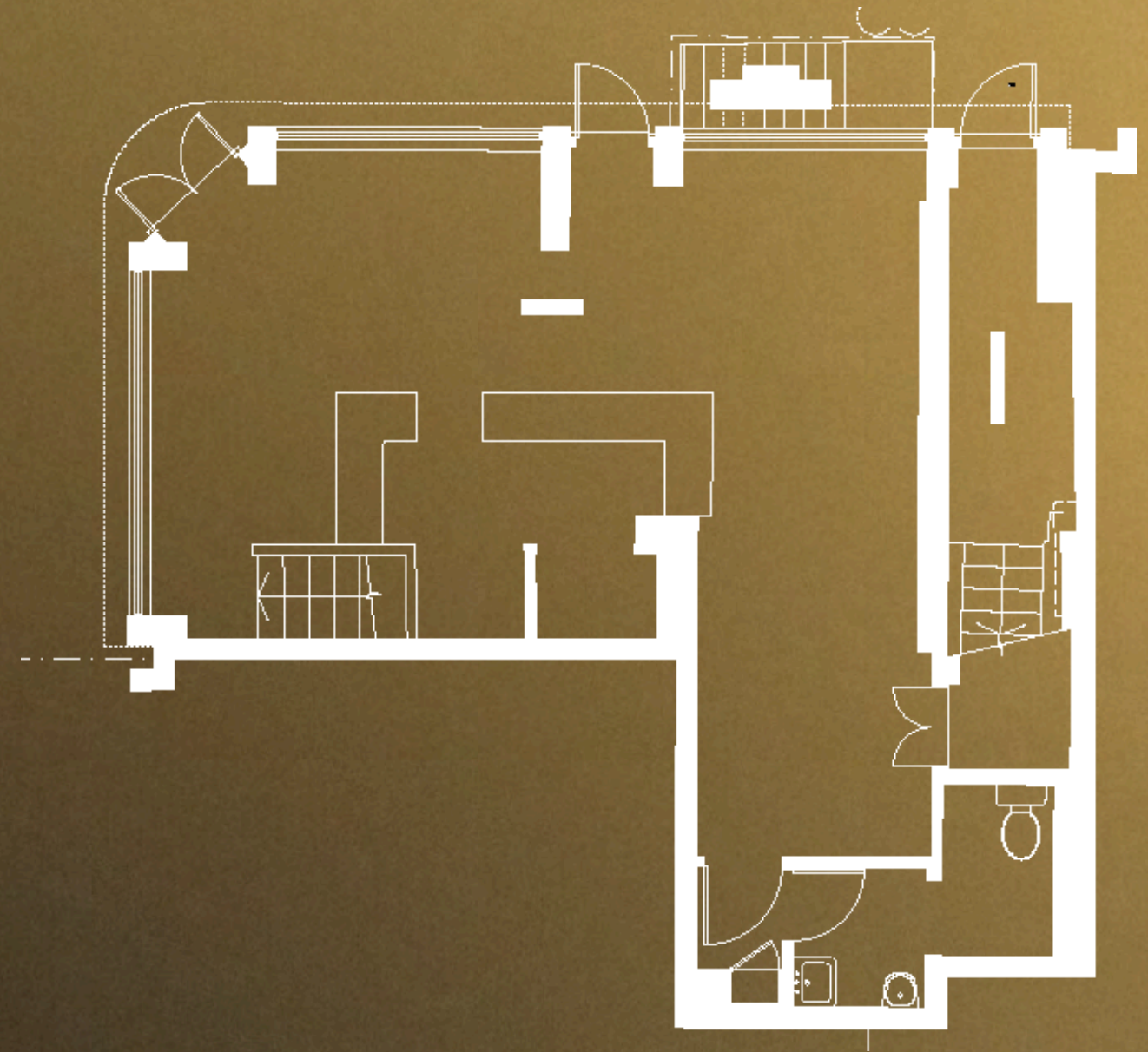
