DESCRIPTION

The property comprises a substantial steel portal frame warehouse with integrated offices, welfare and customer showroom, situated on a self-contained site located immediately off the A4260 Oxford Road.

The building presents well, benefiting from a modern and well-specified showroom and reception area, along with a mix of open-plan offices, private offices, meeting rooms, WC facilities and canteen. Heating is electric, with warm air / cooling provided to the offices and showroom areas.

The warehouse benefits from 9m eaves arranged as one large bay plus ancillary stores, and is serviced by four loading doors, with good HGV circulation to the rear yard and fitted warehouse lighting. Extensive customer / staff parking is provided to the front of the site, with further yard and parking areas to the rear.

In addition, there is a separate detached showroom / storage building located to the front of the site, providing further flexible accommodation.



ACCOMMODATION

Warehouse

A substantial steel portal frame warehouse providing the majority of the accommodation, with high eaves and four loading doors.

The property incorporates a prominent customer-facing showroom, arranged over ground and first floor levels, suitable for trade counter, display or customer use.

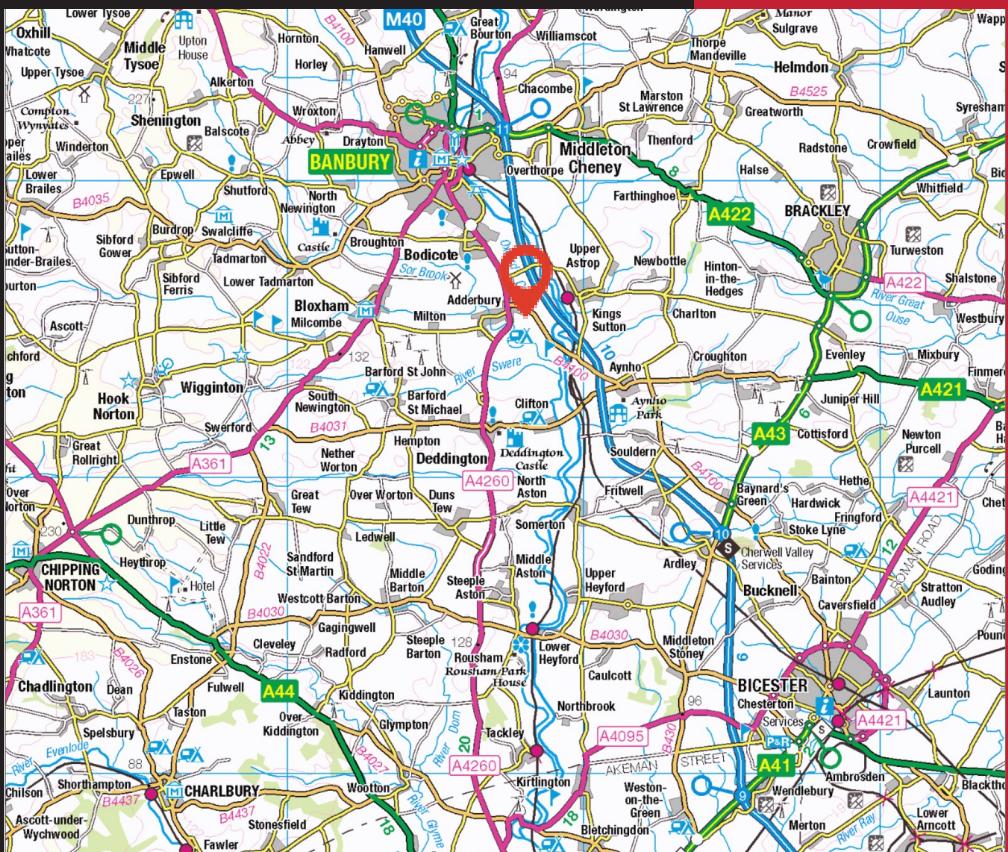

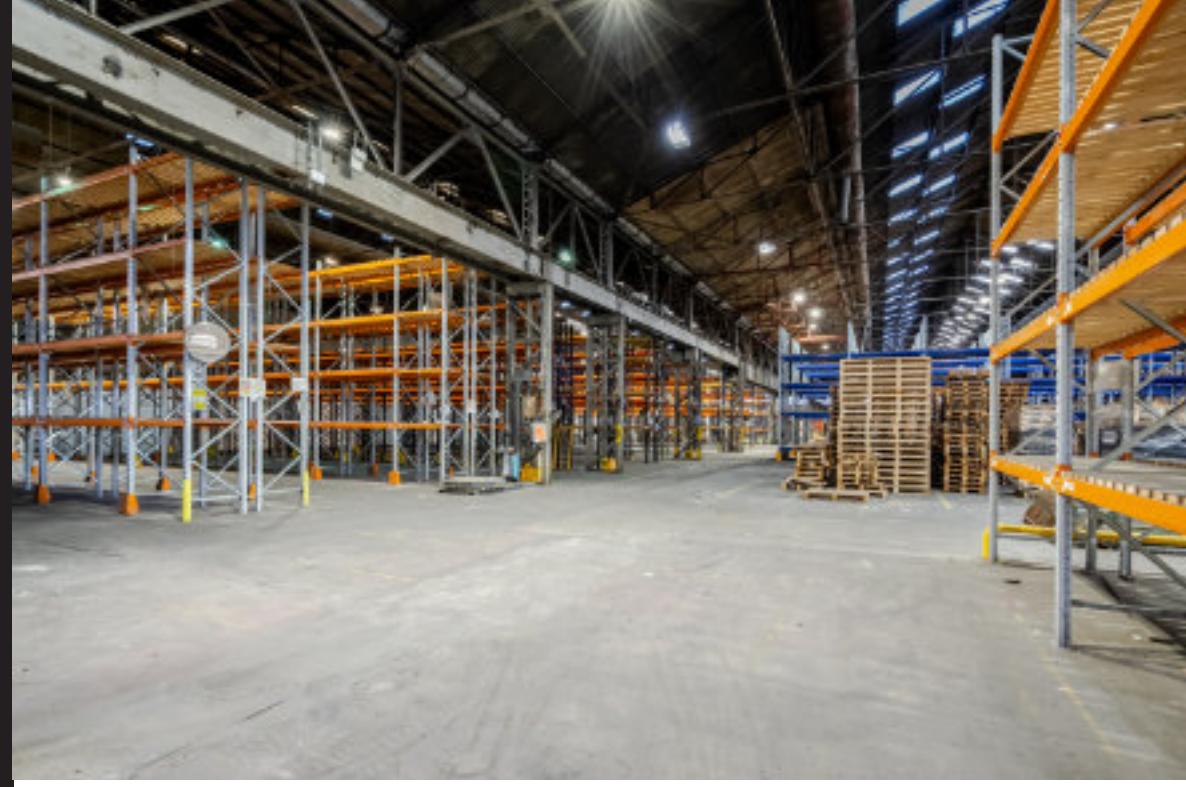
