Location

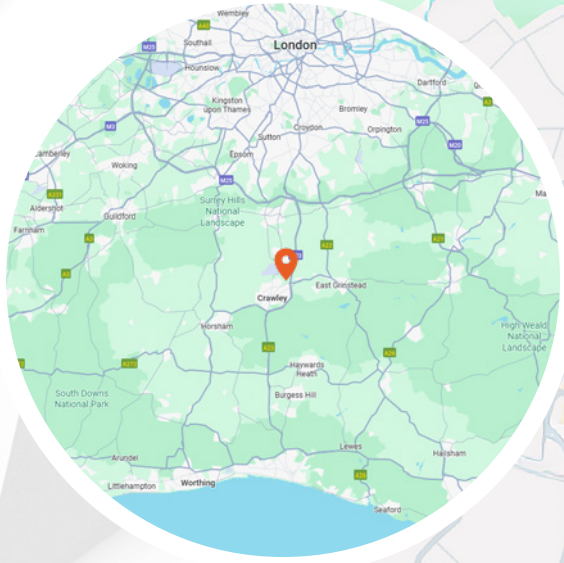

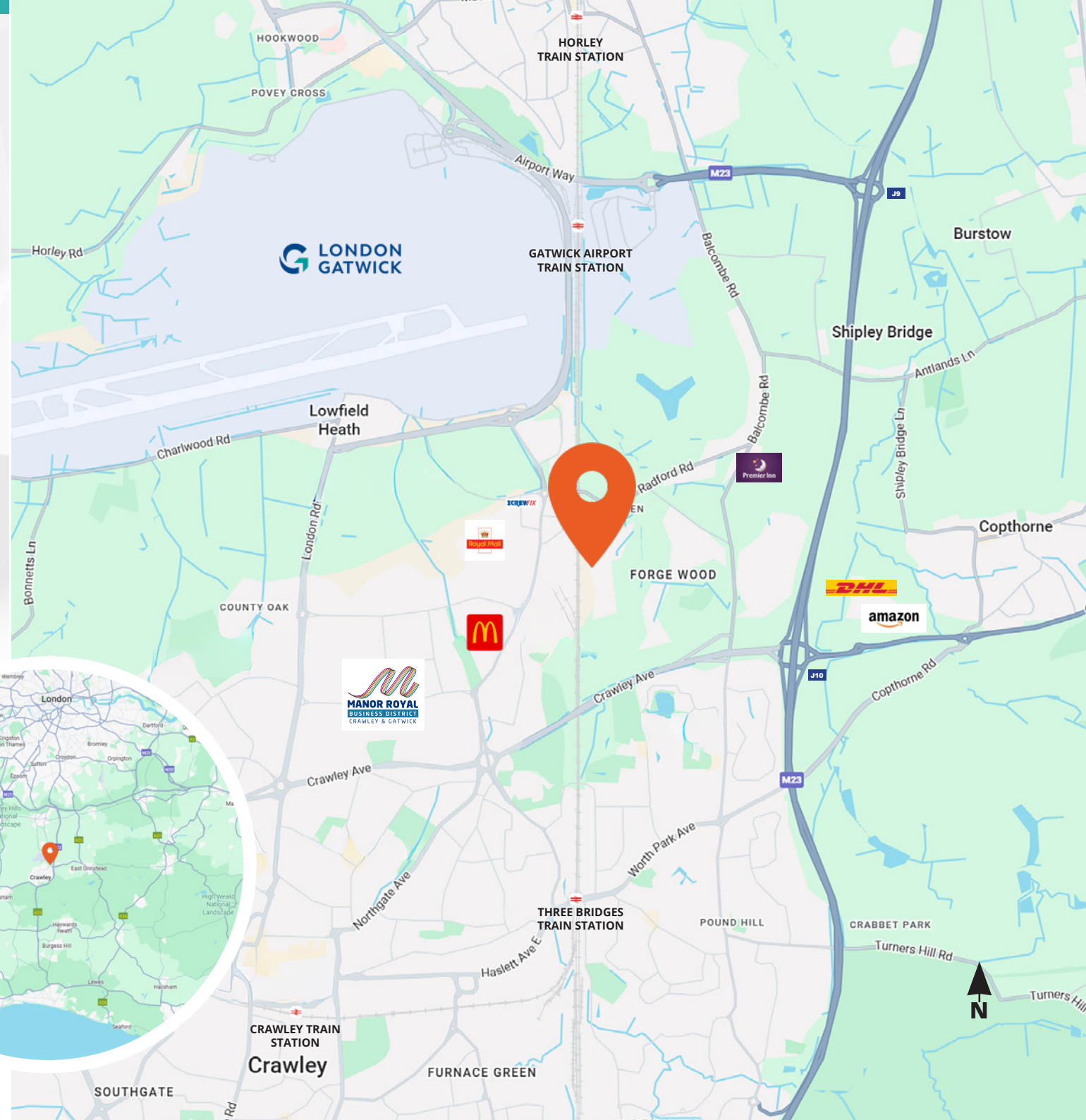

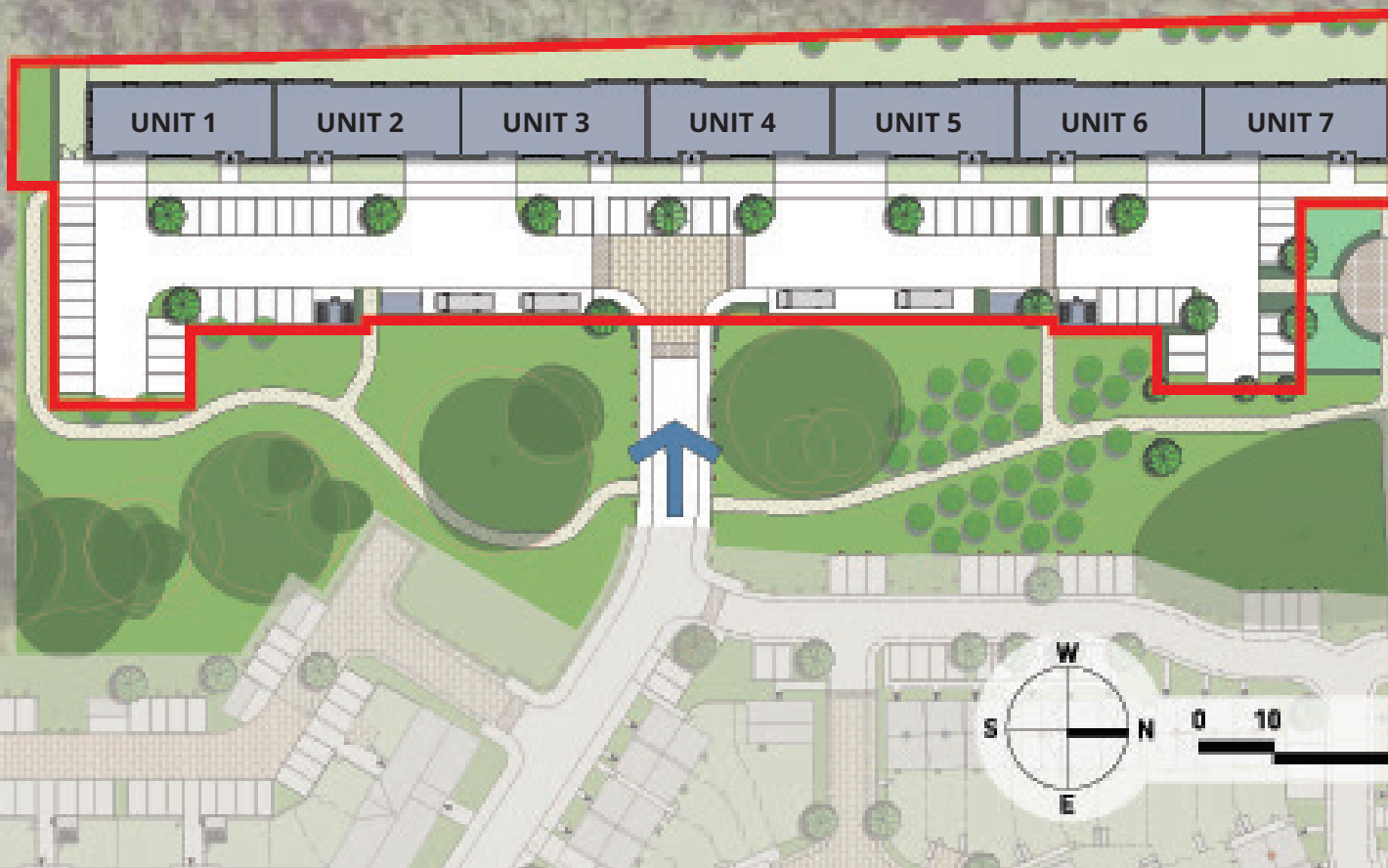
