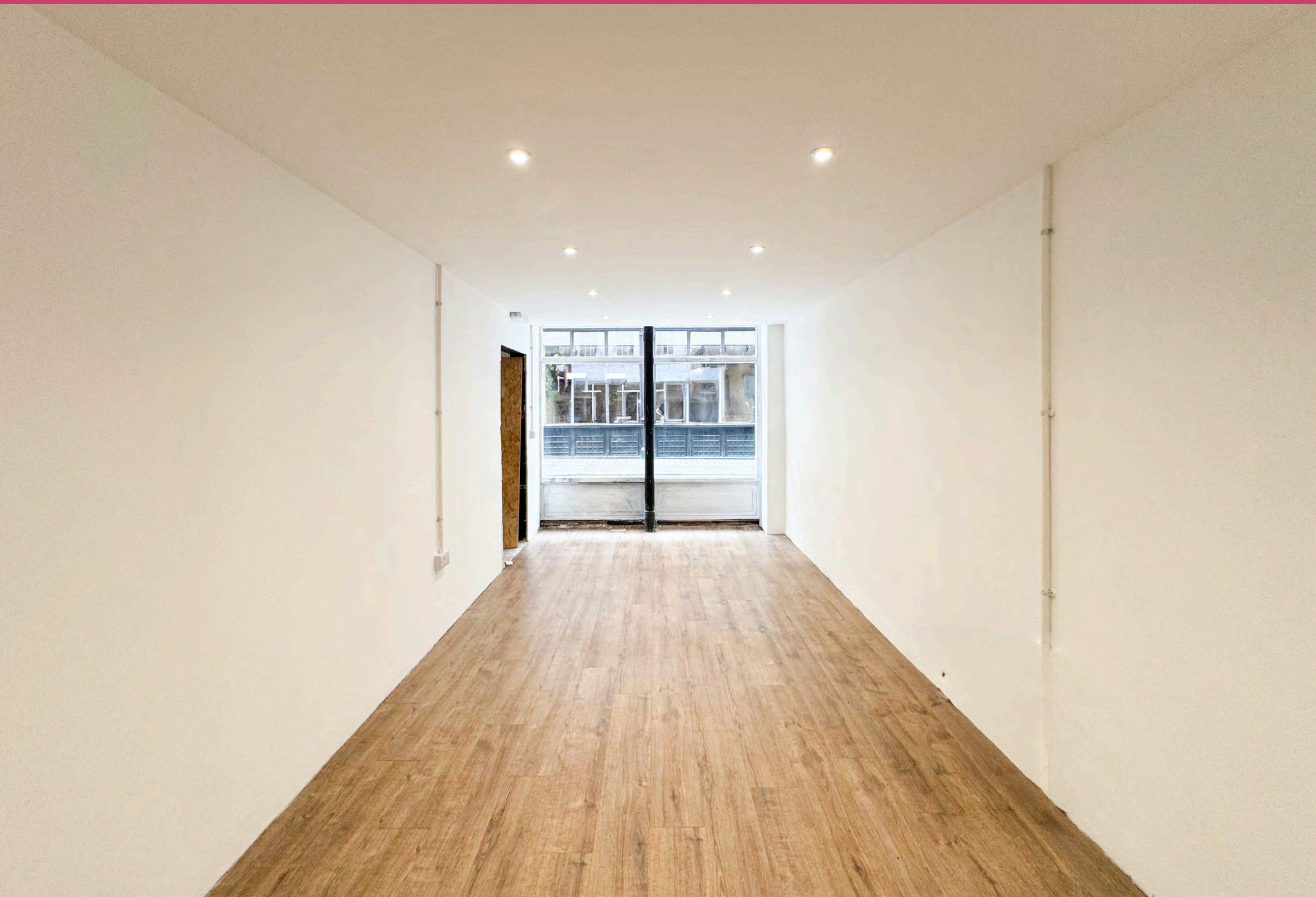
Ground Floor



Lower Ground Floor

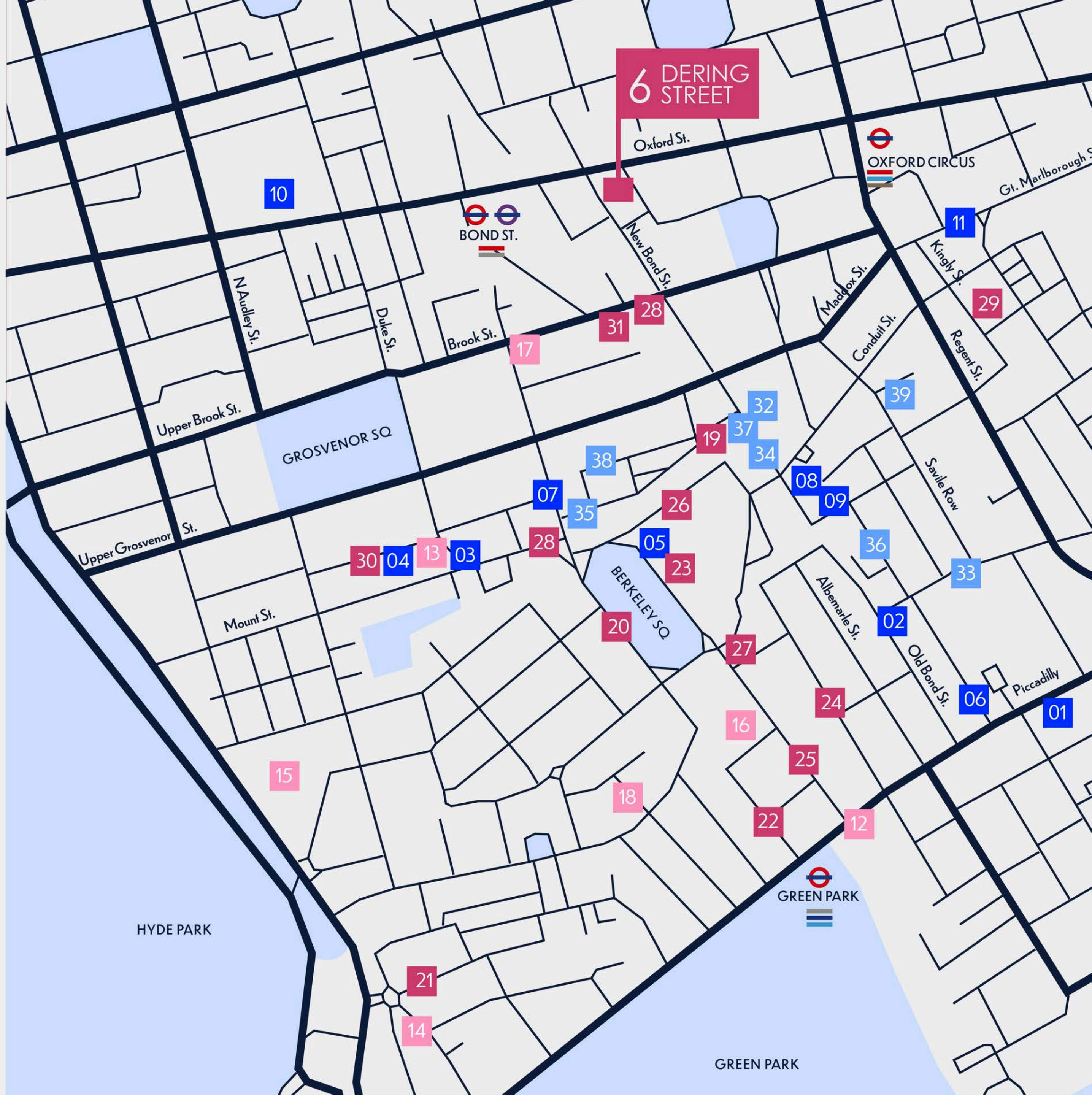
