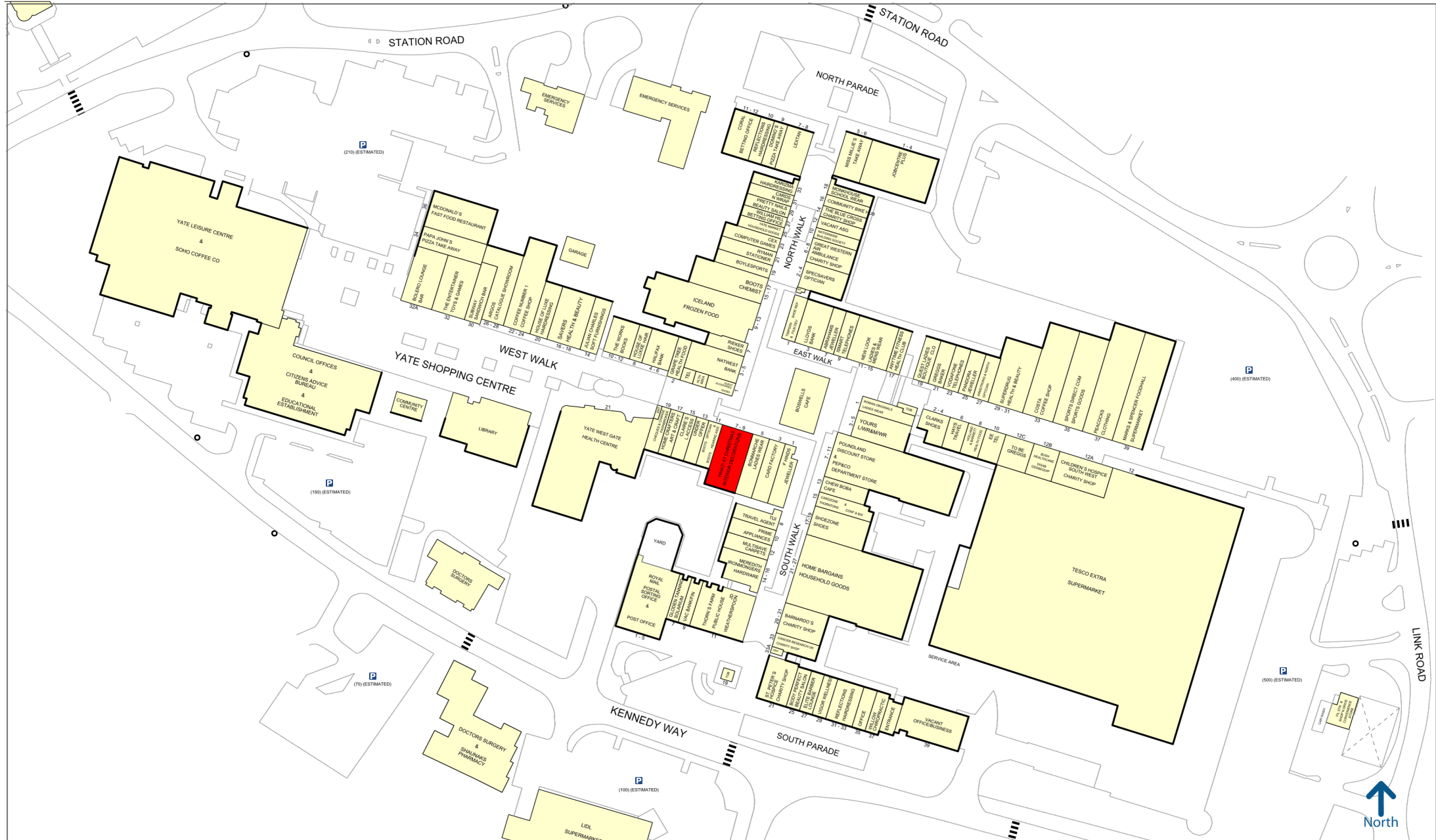
### Description
