Portlaoise was the fastest growing of the top 20 largest towns and cities in Ireland from 2011 to 2016. The 2022 census shows that the town's population increased by 6.6% to 23,494. It is the most populous and also the most densely populated town in the Midland Region, which has a total population of 317,999 at the 2022 census.



Portlaoise has long been a major commercial and retail hub for the Midlands. Due to its location and transport connections, the National Spatial Strategy chose Portlaoise as the location for Ireland's first "Inland Port".



The town stands at a major crossroads in the Irish roads network (major roads to Dublin, Limerick, Cork) although construction of the M7 motorway, which bypasses the town, has reduced traffic congestion in the town centre. It is located 94 km west-southwest from Dublin on the M7, 170 km north-east from Cork on the M8/M7 and 114 km east-northeast from Limerick on the M7.
