## Location

Fleet is an affluent town in north east Hampshire, situated close to the Surrey/Berkshire borders. It is approximately 3 miles south of Junction 4a of the M3.

The subject premises occupies a prominent corner position opposite the entrance to **WAITROSE SUPERMARKET**, forming part of The Hart Shopping Centre.

## Description

This lock up retail premises benefits from excellent return frontage and comprises a main open plan sales area with additional back of house/storage facilities to the rear together with a single WC.

## Terms

The premises are held on the residue of an effective full repairing and insuring lease which expires on 31<sup>st</sup> August 2030. The lease provides for a tenant only break option upon the 31<sup>st</sup> August 2026. The current rent passing is **£28,000 per annum, exclusive** of all other outgoings.
