Location

The premises form part of the established West Howe Industrial Estate located with access onto the main A348 Ringwood Road. The A348 affords good road communications throughout Poole, Bournemouth, northwards towards Ferndown and the A31/M27 and westward towards Dorchester via the A35.

Description

These mid terrace premises are of brick outer, blockwork inner wall construction with steel cladding to upper elevations with a mono pitched roof supported upon a steel portal frame. The ground floor is concrete, the eaves height is approximately 4m and loading is by way of a roller shutter door measuring approximately 3m wide x 3.6m high. Internally, there is a separate personnel door and a unisex WC, kitchenette and lighting. 3 phase electricity is available.

Externally there is a concrete forecourt providing parking.

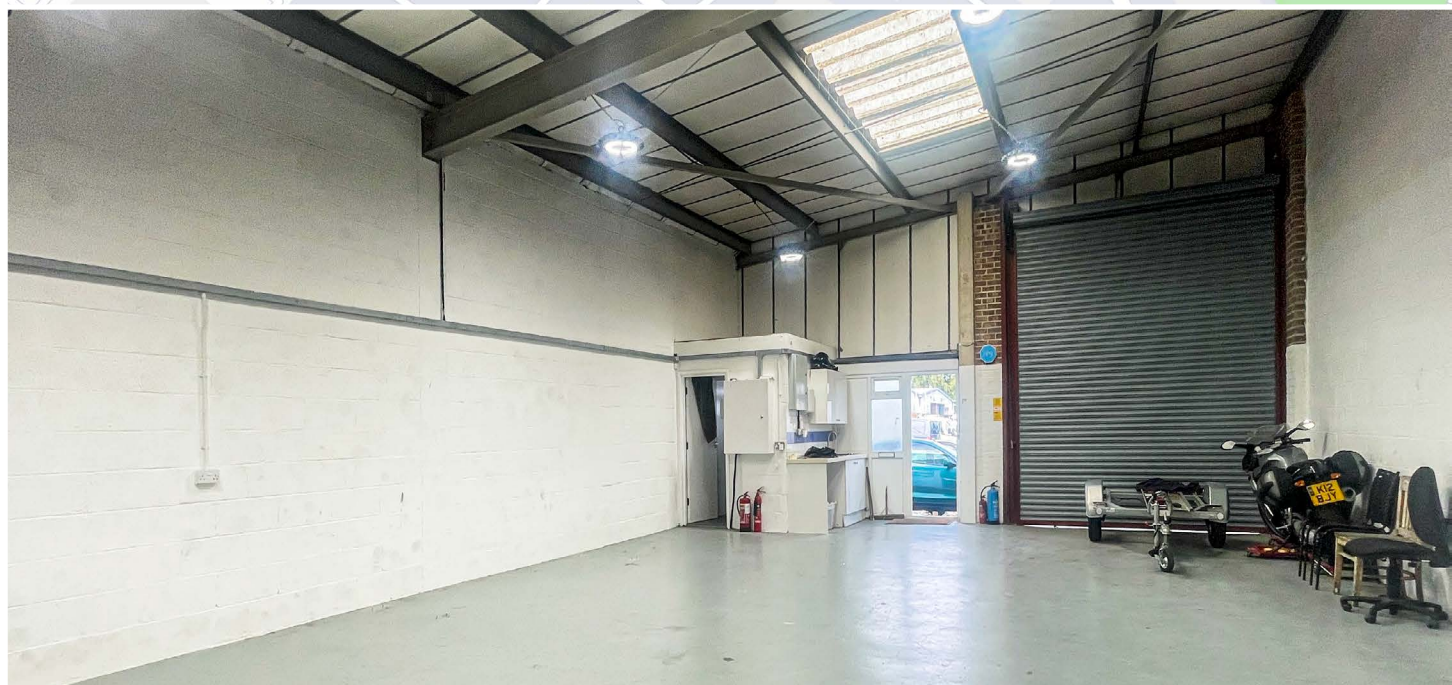
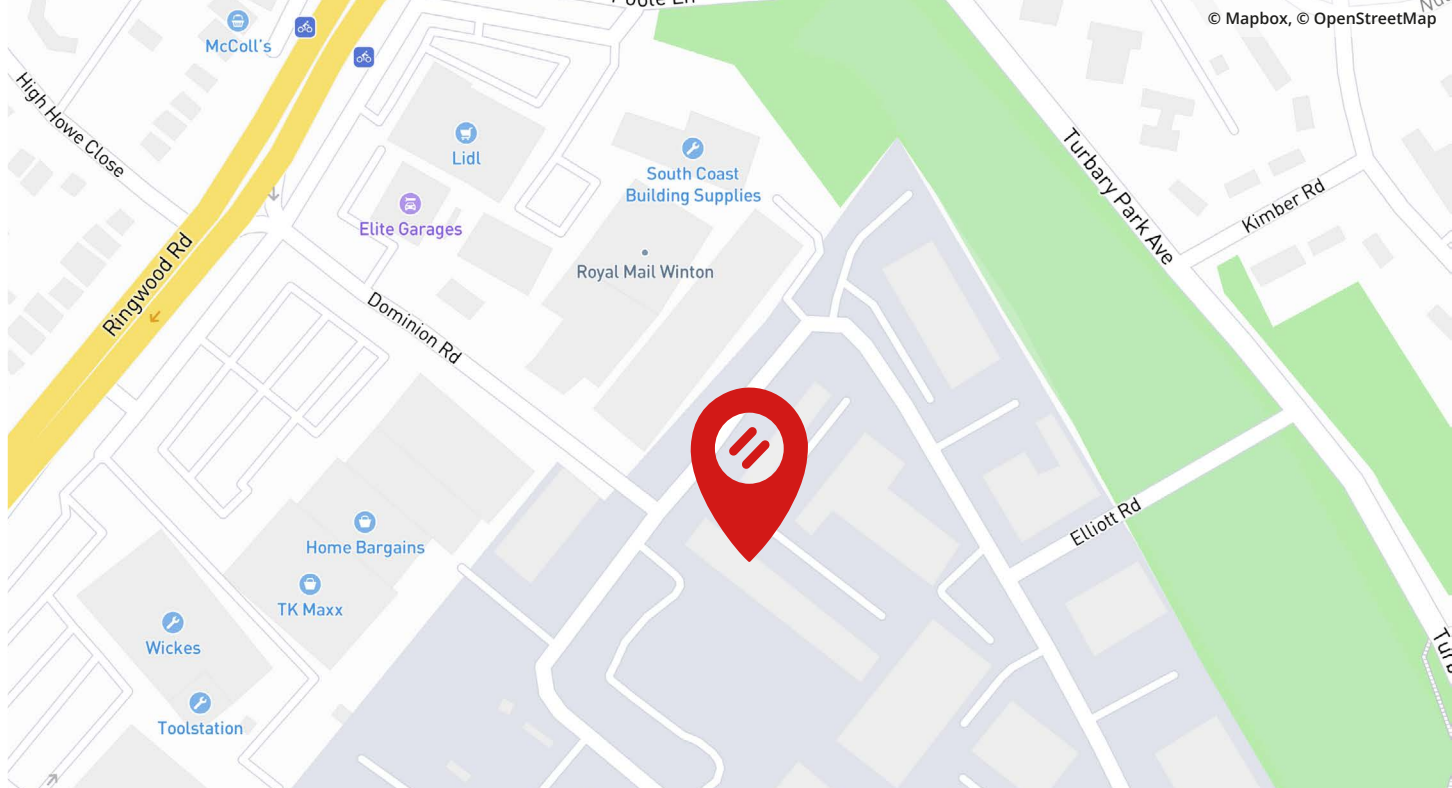
