

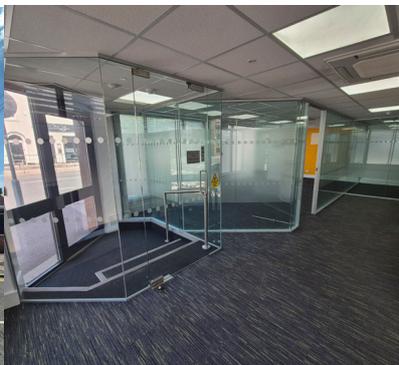

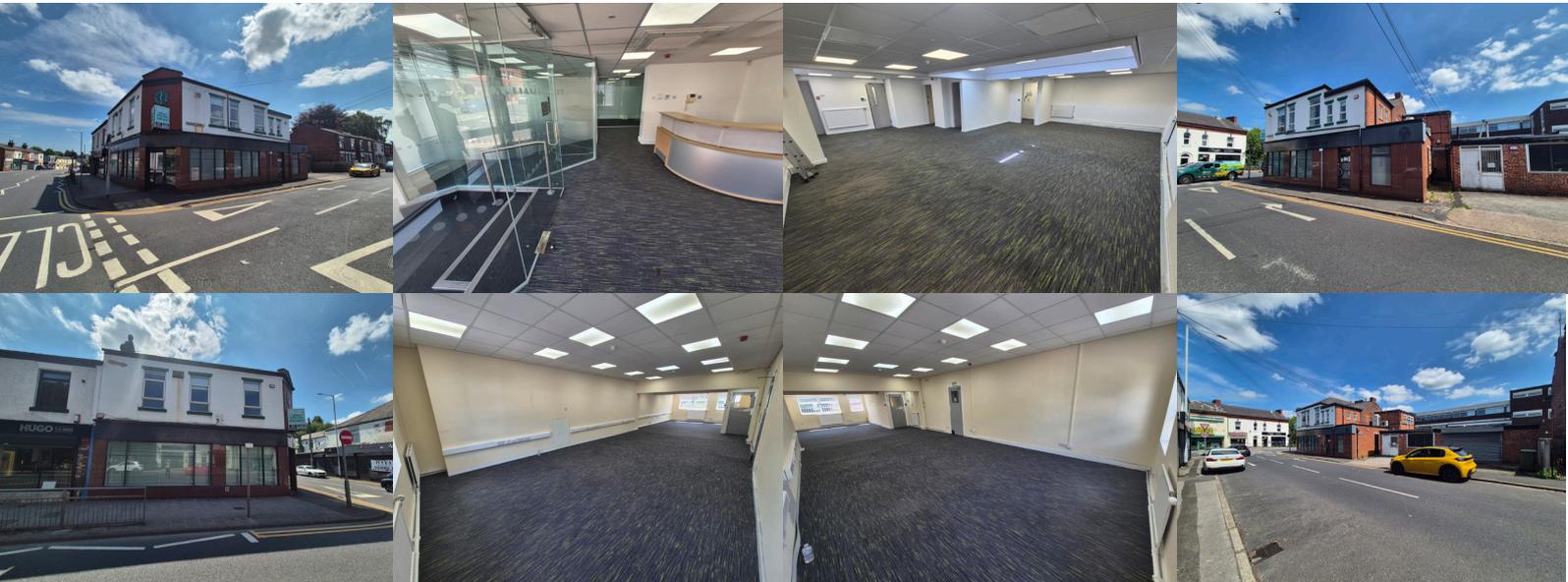

## Description/Accommodation

The property provides a part three storey retail/office with brick work elevations under a pitched slate roof and part single storey rear office with brick work elevations under a flat roof which benefits from natural light via roof lights. The property benefits from off road parking for up to three cars off Grundy Street.

The property provides a mix of open plan retail/office space at ground floor level with high quality full height glazed partitioning providing meeting rooms and private office areas along with a mix of meeting rooms, private offices & break out areas to the rear.

The first floor provides open plan and private office areas and the lower ground floor provides toilet facilities and additional storage facilities.

Features include air conditioning, LED Lighting, access control, raised floors, double glazing, return frontage and is prominently located with main road frontage onto London Road.

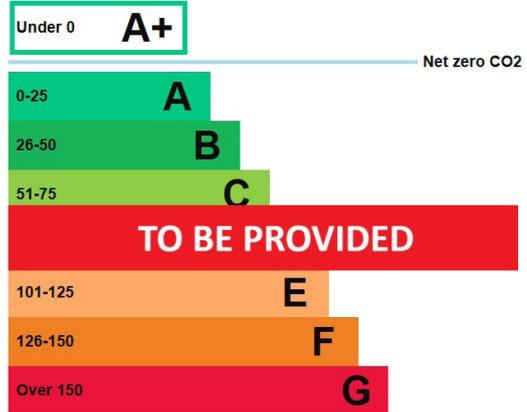
