Location

Neath Port Talbot is situated 8.5 miles east of Swansea and 33 miles west of Cardiff, Wales' Capital City.

The town has a population of approximately 142,300 (2021 census) and is positioned immediately to the south of the M4 motorway, being served by junctions 38, 39 and 41. Neath Port Talbot has a critical mass of industrial, distribution and manufacturing activity, focused around Baglan Energy Park, Baglan Industrial Estate, Seaway Parade and Kenfig Industrial Estates.

Historically known for its coal mining and steel production, the region has diversified its economic base over the years, with multiple renewable energy initiatives as well as the recently announced Celtic Freeport at Port Talbot.



Situation

Seaway Parade Industrial Estate is strategically located at the entrance to Baglan Energy Park approximately 3 miles north west of Port Talbot town centre and is recognised as an established industrial, distribution, and trade location.

The estate is accessed via the A4241, connecting to Junctions 41 & 42 of the M4 motorway via the A48 dual carriageway.

The semi-detached subject units occupy a self-contained site with frontage onto the main estate road, adjacent to the main entrance roundabout at the A4241.

Excellent road communications are provided to Junctions 41 & 42 of the M4 motorway, within 2 miles of the property. Swansea is located 7 miles to the West via the A48 and A483 trunk roads.

Occupiers in the immediate vicinity include Swansea NHS Trust, Speedy Hire, Plumbase, Network Rail and Holt ICB.

Description

The property comprises two semi-detached industrial units of steel portal frame construction, on a self-contained site.

Externally the units are clad with profiled steel sheet cladding. There are loading doors to the front elevations (4.26m wide x 4.93 high), which provide vehicular access to each of the units. There is pedestrian access to each unit via uPVC entrance doors.

Internally, the floors are of concrete slab with block work walls sub-dividing the individual units. There are toilets within and offices to the first floors.
