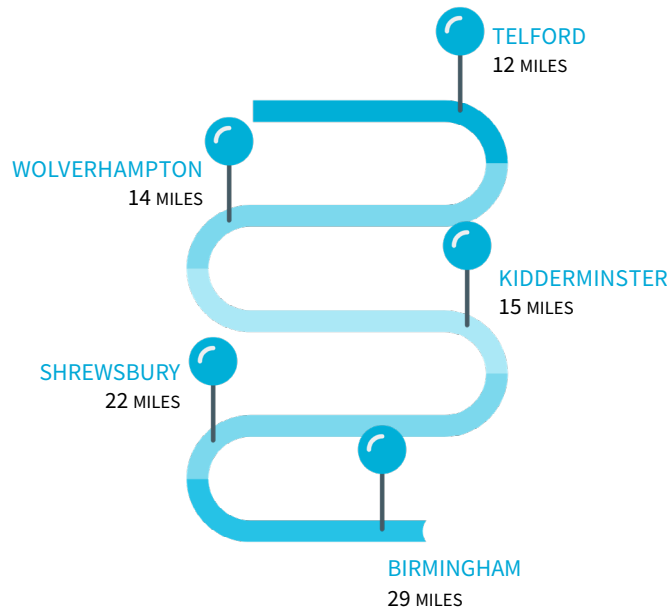
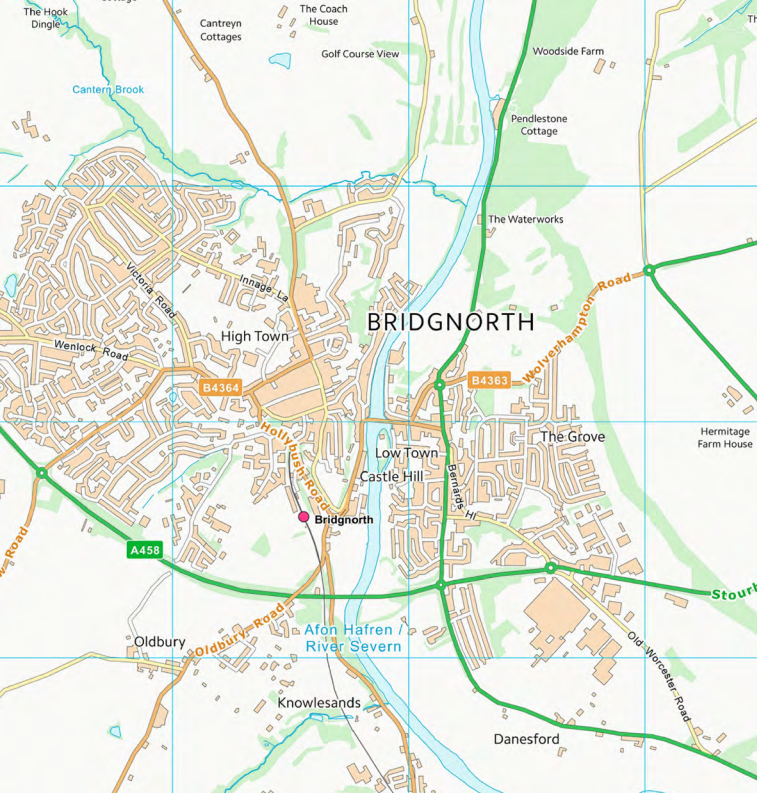

LOCATION

The property is prominently situated fronting onto Stourbridge Road and onto Old Worcester Road on the edge of the town of Bridgnorth. The property is located in an established commercial area where the surrounding occupiers include Craven Dunhill, SNG and Bridgnorth Aluminium.

The property is located approximately 1 mile from Bridgnorth town centre, where all local amenities are available.

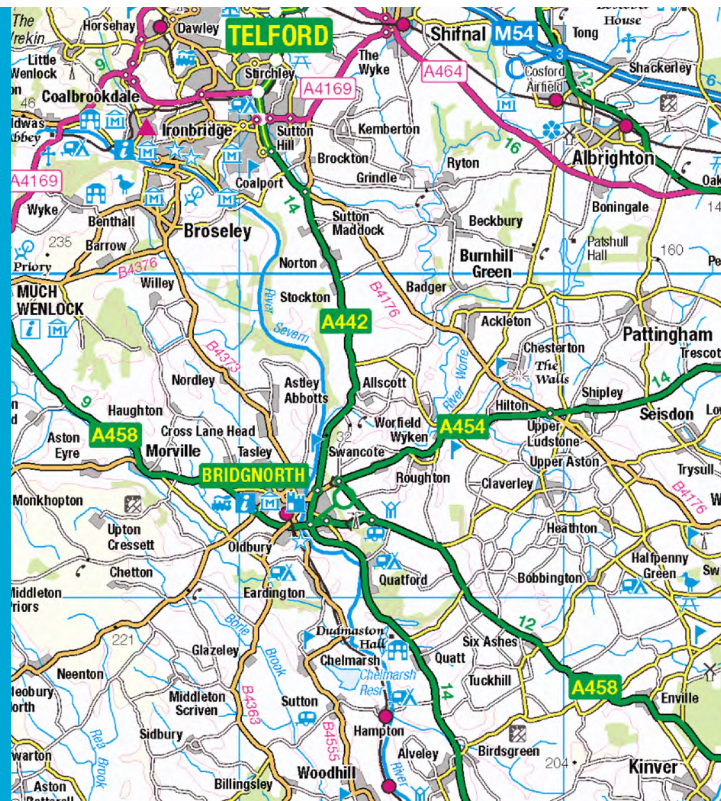
The market town of Bridgnorth is located on the River Sever and the River splits the town into High Town and Low Town and is the third largest town in Shropshire by population.

Bridgnorth is a key crossing point of the River Sever. The A458 provides links west to Shrewsbury (22 miles) and east to Stourbridge (16 miles) and towards Birmingham (29 miles). The A442 heads north to Telford (12 miles) and South to Kidderminster (15 miles). The A454 provides a direct link east to Wolverhampton (14 miles).

DESCRIPTION

The property comprises of a former council depot that provides a variety of commercial property structures together with a commercial yard area and the property provides a Total Site Area of approximately 1.02 acres (0.41 hectares).

The property is arranged as an office building that provides a Total Gross Internal Floor Area of approximately 1,550 ft sq (143.98 m sq), warehouse and stores with a Total Gross Internal Floor Area of approximately 4,368 ft sq (405.8 m sq) and an open sided stores structure with a Total Gross Internal Floor Area of approximately 1,395 ft sq (129.6 m sq).

The property benefits externally from a surfaced external area providing commercial yard and car parking and benefiting from access onto both Stourbridge Road and Old Worcester Road. The property would lend itself to a variety of commercial uses.

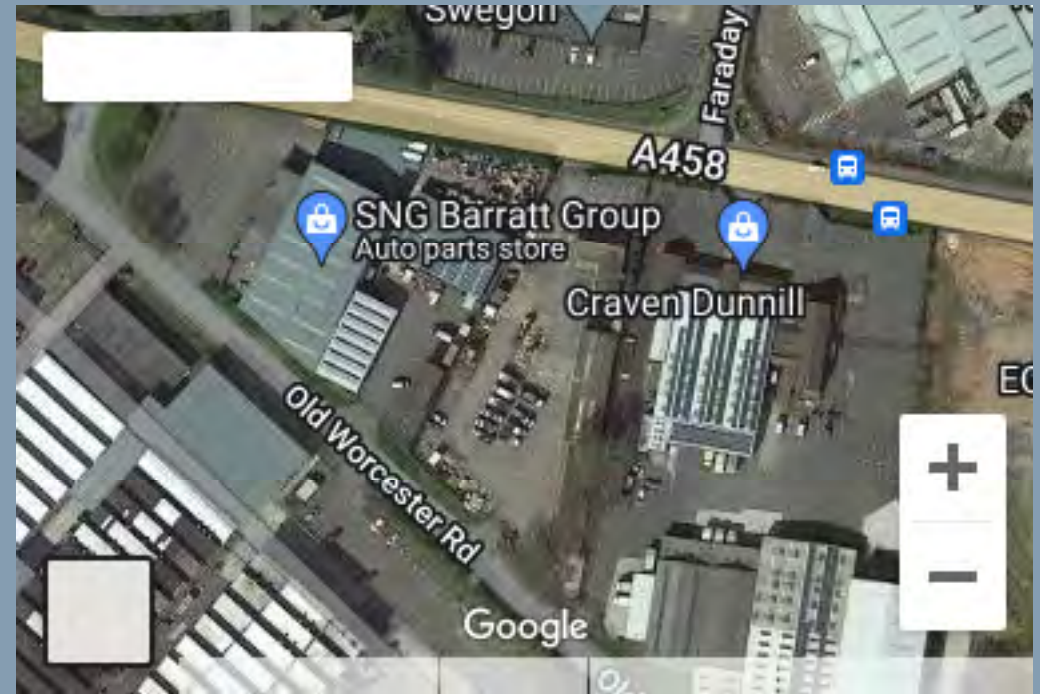
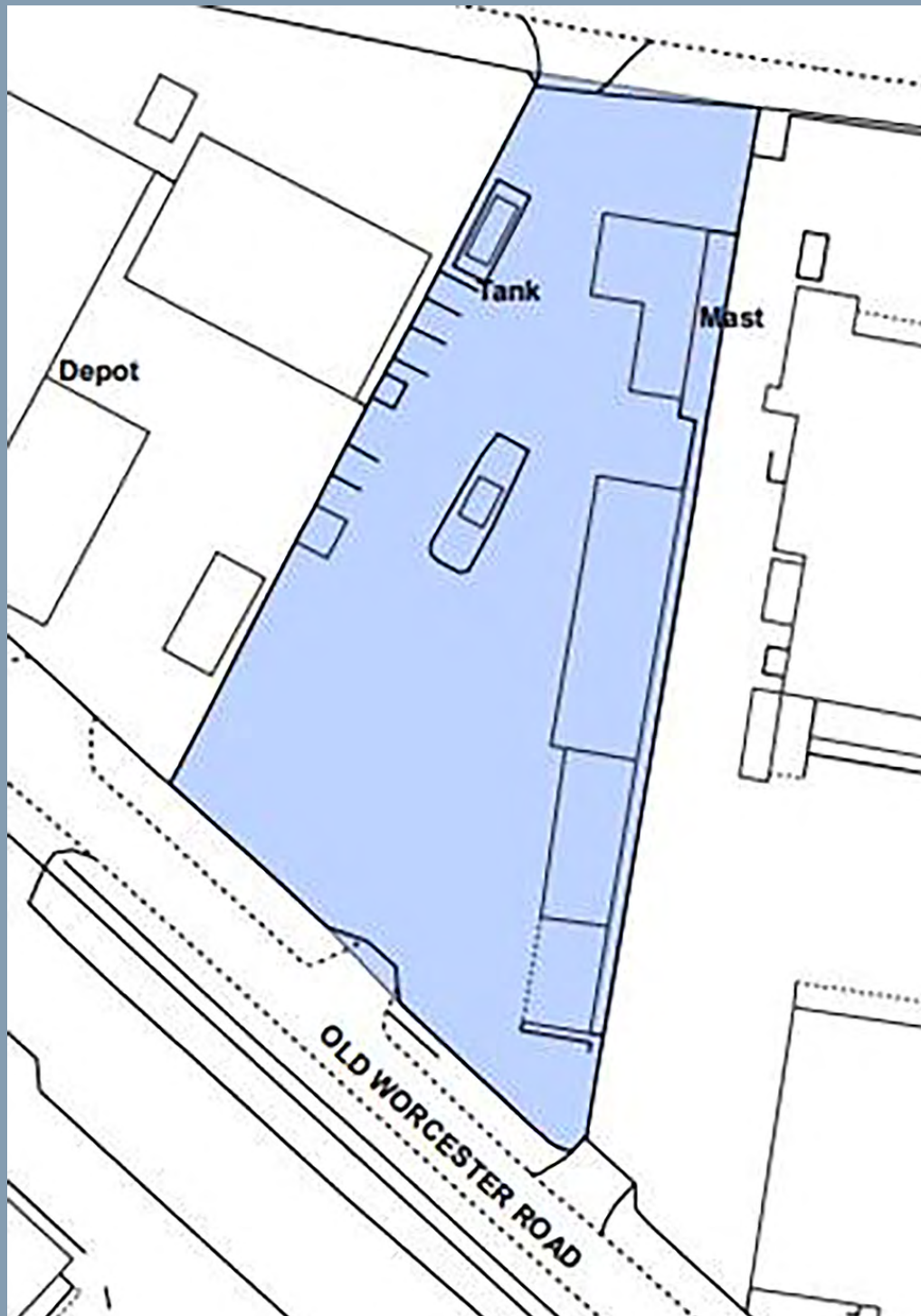
