## LOCATION:

The city of Dundee has a population of approximately 150,000 and is situated on the north bank of the Firth of Tay approximately 25 miles north east of Perth. Dundee benefits from a mainline railway station sitting on the East Coast Line with a further rail link to Perth and the Central Scotland network. The city also has the benefit of excellent road links to Aberdeen to the north with access to the main motorway network via the M90 and M9 to the south and east.

Dundee's waterfront redevelopment has transformed the face of the city, centred around the Victoria & Albert Museum, RRS Discovery and new railway station to celebrate Dundee's rich past and innovative future. The city is also thriving with a strong student presence, home to the University of Dundee and Abertay University.

The premises itself is located on the west side of Reform Street and surrounded by various national and local occupiers at ground floor level with mainly office accommodation at tenement level above. Reform Street has recently transformed into a hub attracting national hot food providers with neighbouring occupiers including GDK, Heavenly Desserts, Chaiiwallah, CUPP, McDonald's and Taco Bell. Other notable retailers include Boots, Chisholm Hunter and Santander. The popular Overgate Shopping Centre is also situated directly behind the subjects.

## DESCRIPTION:

The subjects are arranged to provide retail premises on the ground floor of a four storey building of traditional stone construction, beneath a pitched and slated roof.

The property benefits from a timber framed display window fronting to Reform Street and a recessed, timber/glazed pedestrian entrance door. Internally, the unit provides an open plan sales area with tea prep, WC facilities and fire exit to the rear.

The Unit has been fully cleared providing flexible open plan space that can be adapted/fitted to suit an occupiers specific requirements.


