



Location

The property is located on the popular Ellough Industrial Estate. The estate is located to approximately 2 miles to the east of Beccles, 20 miles to the east of Norwich and 7 miles to the west of Lowestoft. The Estate is located within close proximity of the A146. Other occupiers on the Estate include **Orwell Housing**, **Hughes Electrical** and **MH Goals**.

Description

The property comprises a mid terrace light industrial unit, of steel portal frame construction under an insulated pitched metal roof, with a combination of brick and profile sheet elevations. The unit has the following specification and features:

- Forecourt parking for 2 cars
- Roller shutter loading door
- Office, with kitchen and WC
- Min eaves to 3.6m

Accommodation

The property has gross internal area of **973 sq ft (90 sq m)**.

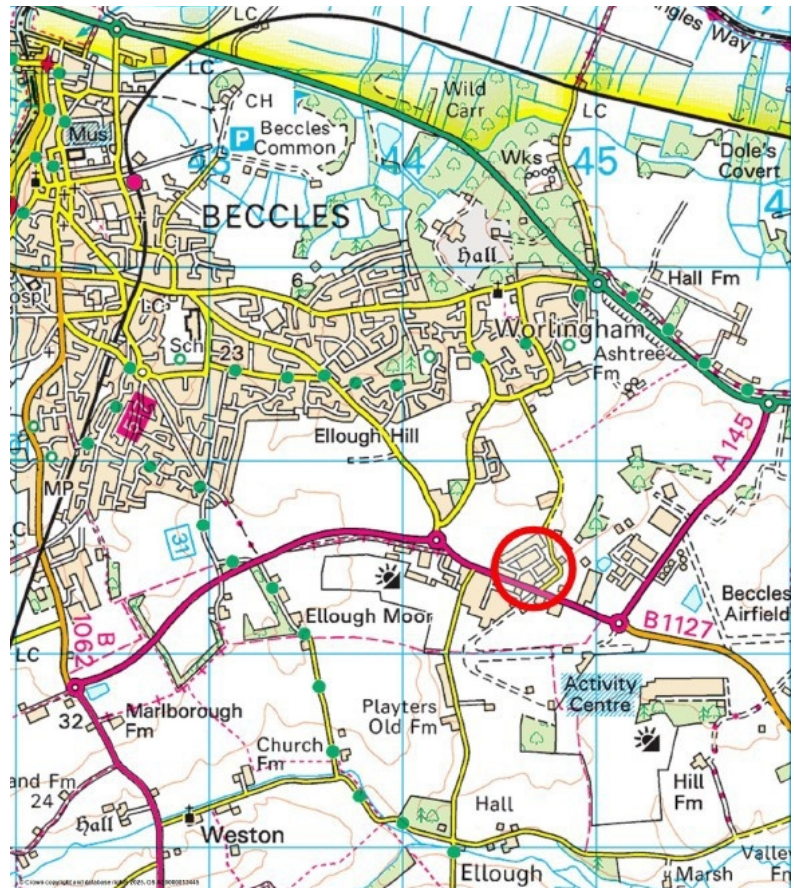
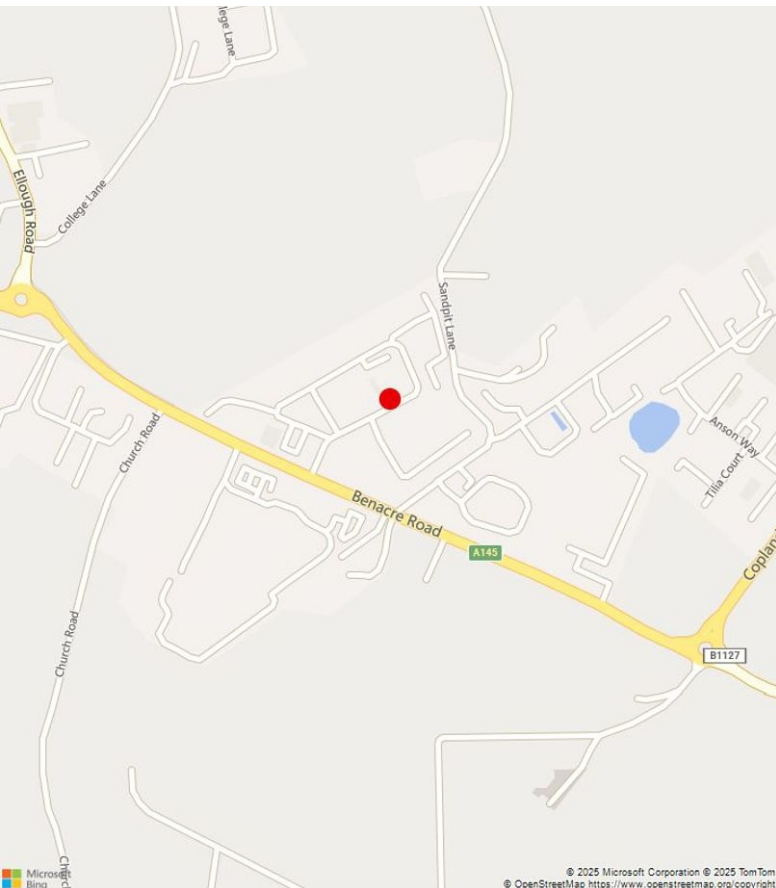

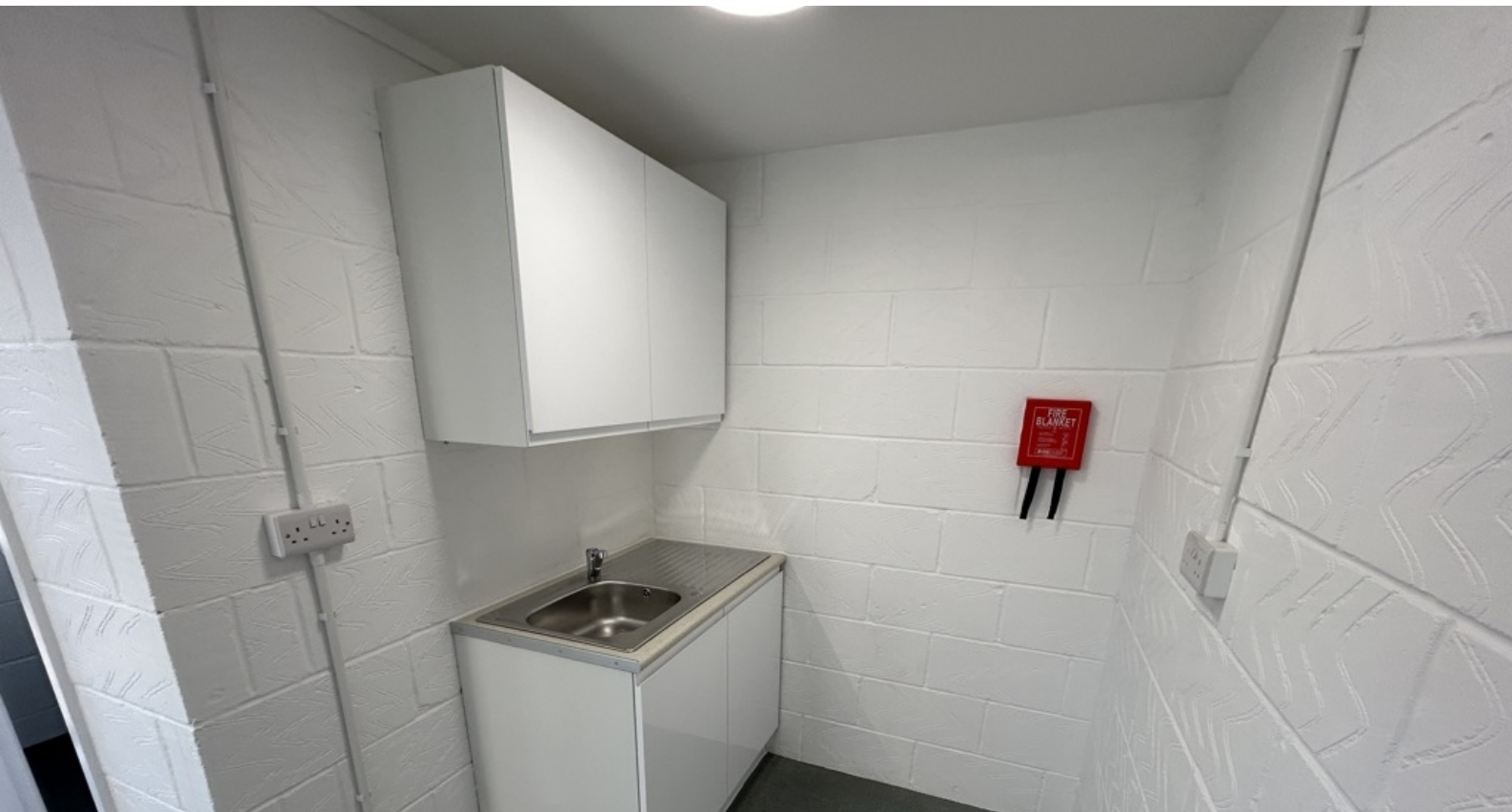
