LOCATION

Scotia Road Business Park is accessed from Scotia Road (A50) via Fitzgerald Way in Burslem. The site is located at the entrance of the business park. Surrounding occupiers include UPS, Royal Mail and Travis Perkins.

Burslem is one of the 5 towns of Stoke on Trent with the main dual carriageway A500 (D Road) within close proximity (1.5 miles) providing links to the remaining towns and Newcastle under Lyme. The A500 provides connections to the A50 to the East and M6 Motorway Junctions 15 to the South (approx. 8 miles) and 16 to the North (approx. 7.5 miles).

DESCRIPTION

The premises comprise of a former timber merchants of steel portal frame construction with profile clad elevations. The site benefits from

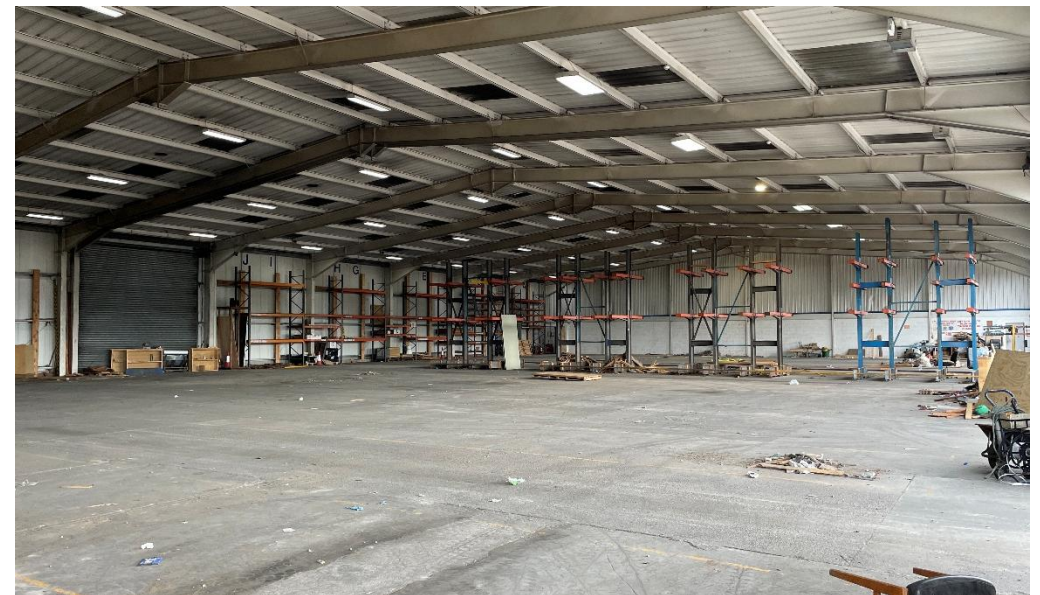

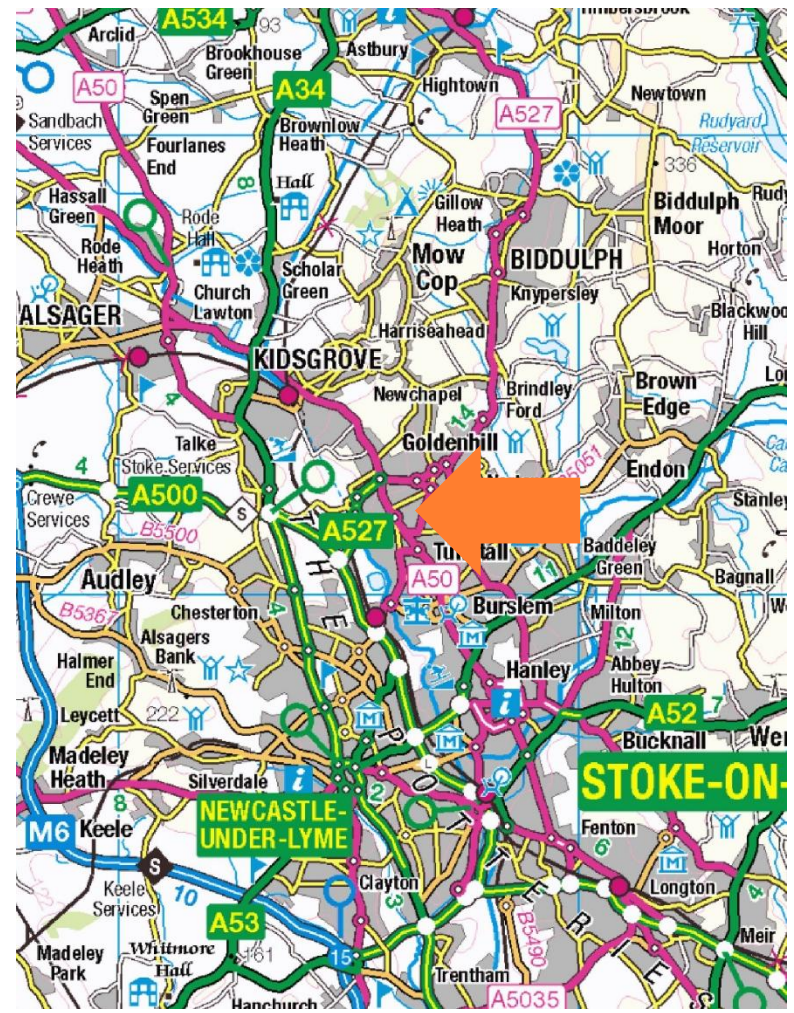
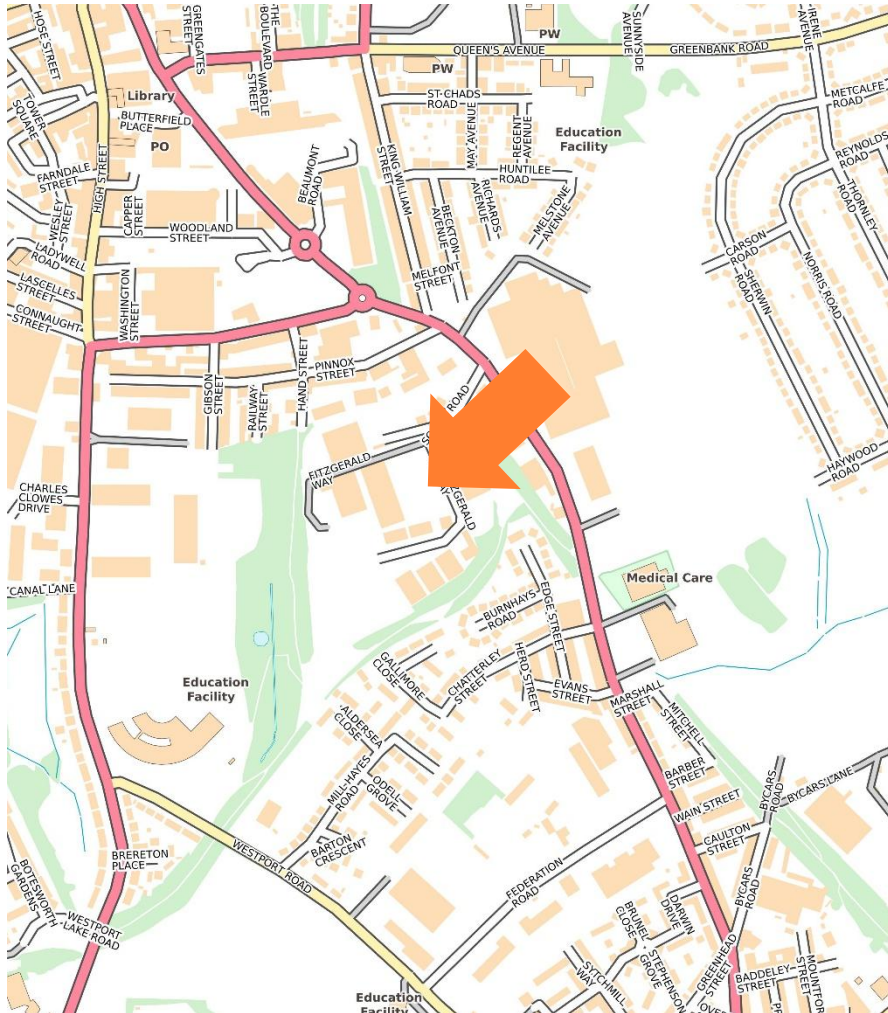
