

DESCRIPTION AND LOCATION

Located in a busy vehicular location on Springfield Road, with pedestrian traffic passing en route to and from Bond Street and Chelmsford centre. This well-presented ground-floor retail unit offers an opportunity to secure a prominent spot opposite Tesco and adjacent to Iceland.


