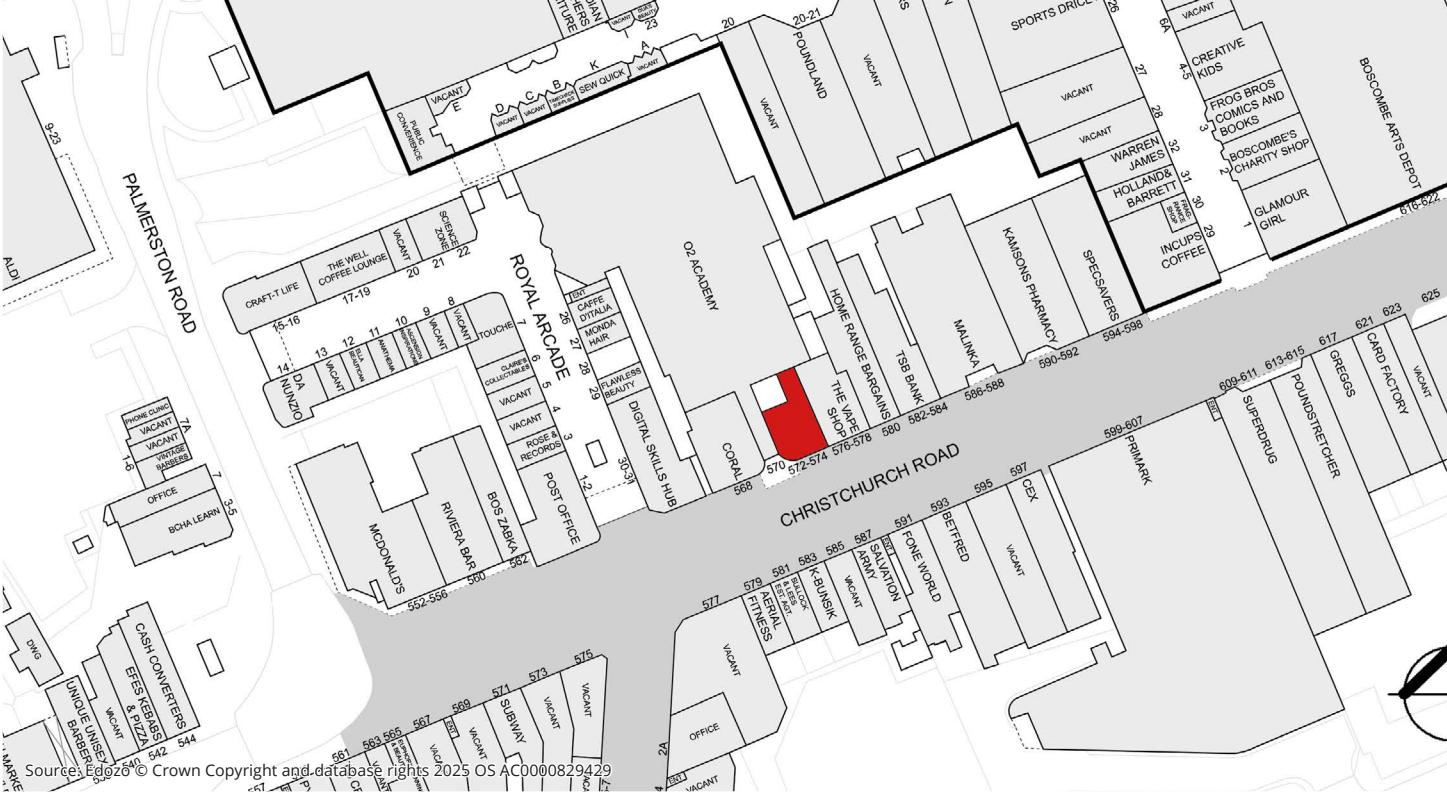
## Location
