

> Location

York North is conveniently positioned 5 miles from York Outer Ring Road at Clifton Moor, which connects to the A59 and in turn provides fantastic connectivity leading directly to A1(M) J47 giving efficient access to the wider motorway network.

> Description

Units 7 and 14 lie within York North, a purpose built multi-let industrial estate which has been developed over the past 4 decades across 28 separate units. The estate consists of 8.20 acres, which is situated within a well maintained, landscaped environment with perimeter palisade fencing, a gated entrance and tarmac estate roads.

The units are of steel portal frame construction with brick / block and metal clad elevations. The property has been fully refurbished to provide a hybrid unit of office and industrial accommodation.
