Through door into **Sandwich Bar** with wooden laminated floor, 2 breakfast bars, 4 high stools, price menu display boards, concealed ceiling lighting, air conditioning unit, large glass fronted chiller display, chilled salad bar display unit, open drinks chiller cabinet, hot cupboard, servery area, laminated work top surface, paper towel dispenser, stainless steel wash up, coffee machine, coffee grinder, Epos till, double panini maker, extraction, paper towel dispenser, storage cupboards, toaster, bin. Through into **Kitchen** with non slip floor, 2 upright freezers, 2 upright fridges, Falcon oven, electric oven, assorted stainless steel tables, storage cabinet, stainless steel shelving, microwave, insectocutor, deep fat fryer, 6 burner electric range, double oven under, extraction system above, part tiled, shelving, double deep bowl double drainer stainless steel sink unit, paper towel dispenser, terminals for Just Eat, Uber and Deliveroo. Through door into **Lobby** with upright fridge. Door into **Cloakroom** with low level WC, wash hand basin, hot water tank.

Trading & Business

The owners inform us that they currently trade Monday to Friday from 9am until 3pm. The sandwich bar business is operated by the 2 full time owners. The unit benefits from low overheads and its central position amidst offices and shoppers in the town centre. We are currently awaiting accounting information for this business, however at the time of writing, the takings we are told are averaging £1,500 per week.

Rateable Value

£10,750 at the Uniform Business Rate of 49.9p in the £ for 2025/26. For the year 2025/26 small businesses with a rateable value up to £12,000 will receive 100% rates relief. Information taken from the Valuation Office Agency website.

Tenure

LEASEHOLD. The owners inform us that the premises are held under a 6 year lease from 7th December 2021. We understand that the rent is £11,500 per annum. We have not had sight of this lease documentation.
