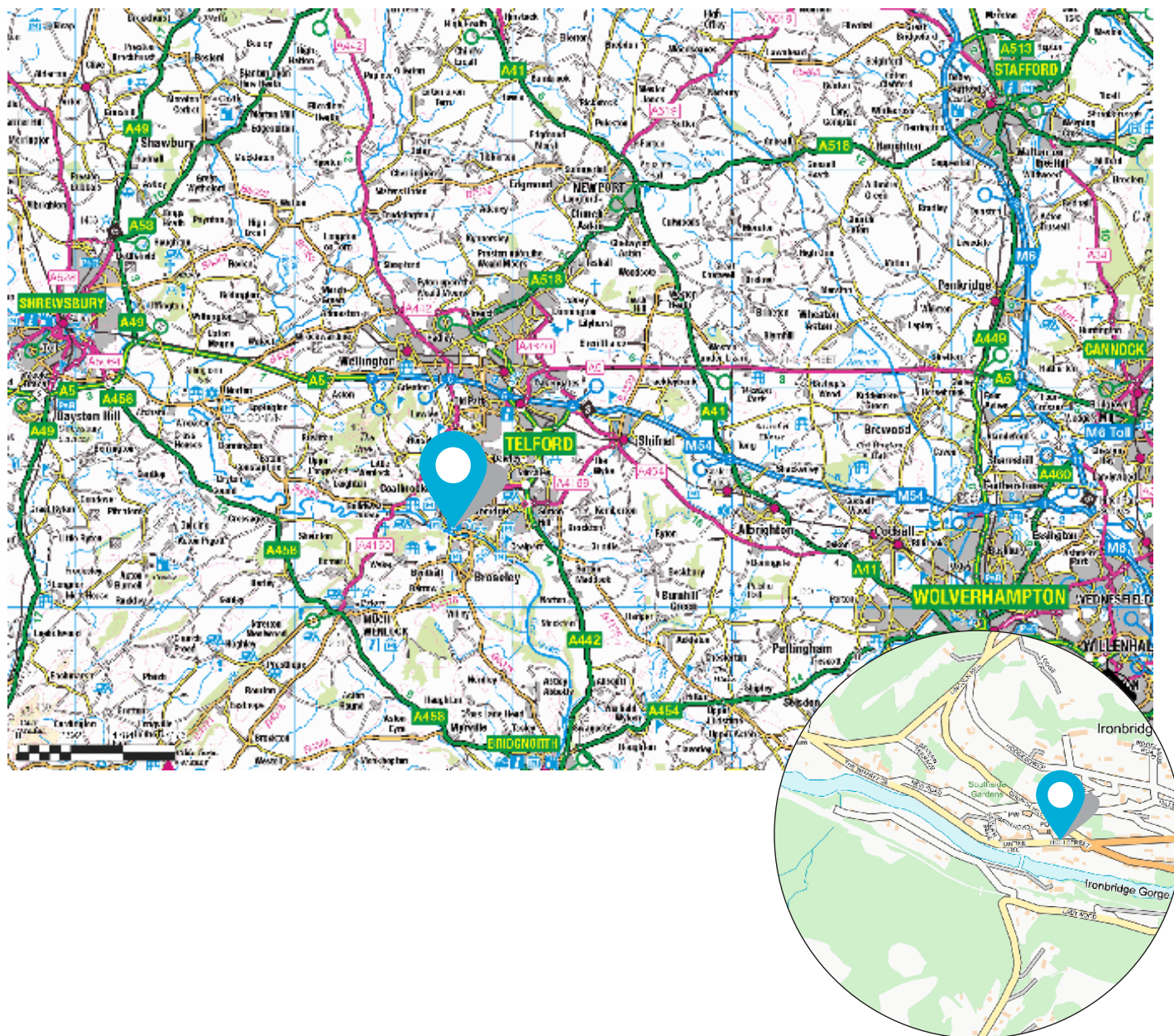
### LOCATION

The business trades from a prominently located property in the centre of the sought after and historic town of Ironbridge. The business is situated fronting onto High Street and benefiting from proximity to the historic Ironbridge and River Severn. The town of Ironbridge is a popular tourist centre and the town offers all local amenities.

The town had a population of 2,582 at the 2011 census. The Ironbridge Gorge Museums Trust owns and operates 10 museums throughout the Ironbridge Gorge World Heritage Site. The town is located approximately 5 miles south of the town of Telford, 14 miles south east of the County Town of Shrewsbury and approximately 9 miles north of the town of Bridgnorth.

### DESCRIPTION

The business trades from a fully fitted out ground floor bar/restaurant area that is arranged as seating with toilets, commercial kitchen and above ground floor cellar area. There is a first floor private seating area with a bar. The property has the benefit of an outside seating area for 40 people. The property benefits from a generously sized glazed frontage and an internal inspection of the business is recommended to appreciate the quality of the property from which the business trades.





### BUSINESS

The business has been traded by the existing proprietors for over 4 years and is only reluctantly offered for sale due to retirement. The business is run by the proprietors with 2 full time staff and a variety of part time staff. The business trades as a cafe with a food offering from the fully fitted commercial kitchen.

The business benefits from an established local trades supplemented by the tourist trade generated.
