McCue House provides superior office space within a building that was fully refurbished five years ago. A secure fob entry system leads in to a welcoming reception area which in turn provides access to the individual offices. The office space is complimented by a luxury cafe-style lounge / break-out area, meeting room and board room. There are tea stations and toilet facilities on each floor.

There is forecourt parking and a larger rear car park.



Location

McCue House is situated on Wilton Road which forms part of the Wilton Road Industrial Estate on the southern outskirts of Grimsby and benefits from easy access to the neighbouring town of Cleethorpes and the outlying villages of New Waltham and Humberston.

There is a limited supply of managed office space to the south of the town centre, but nothing of this quality.

Wilton Road Industrial Estate is home to a variety of occupiers including Screwfix and Howdens. Hewitts Retail Park is a short distance away and is anchored by a Tesco superstore.

The offices are a short walk from a bus route.

The available offices are of a range of sizes starting at 113 sq ft for single occupancy up to larger rooms capable of accommodating up to six people.
