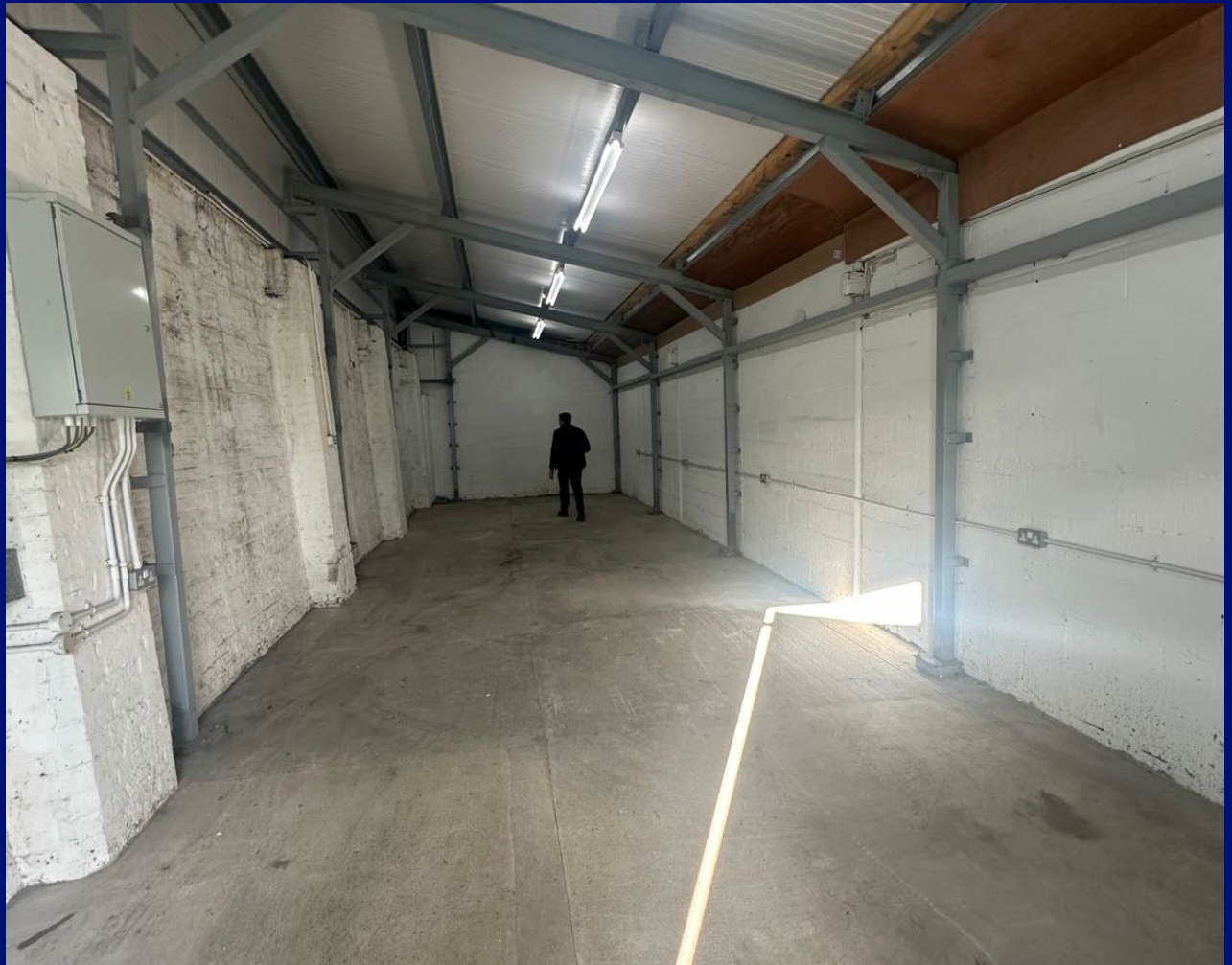


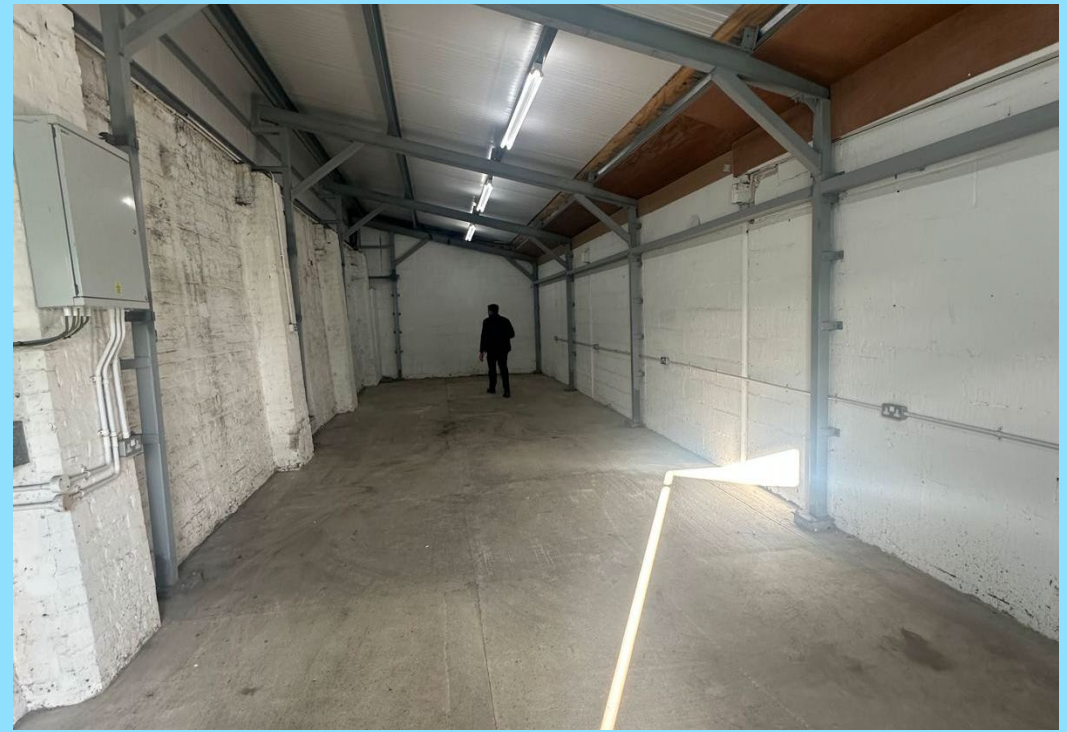

LOCATION

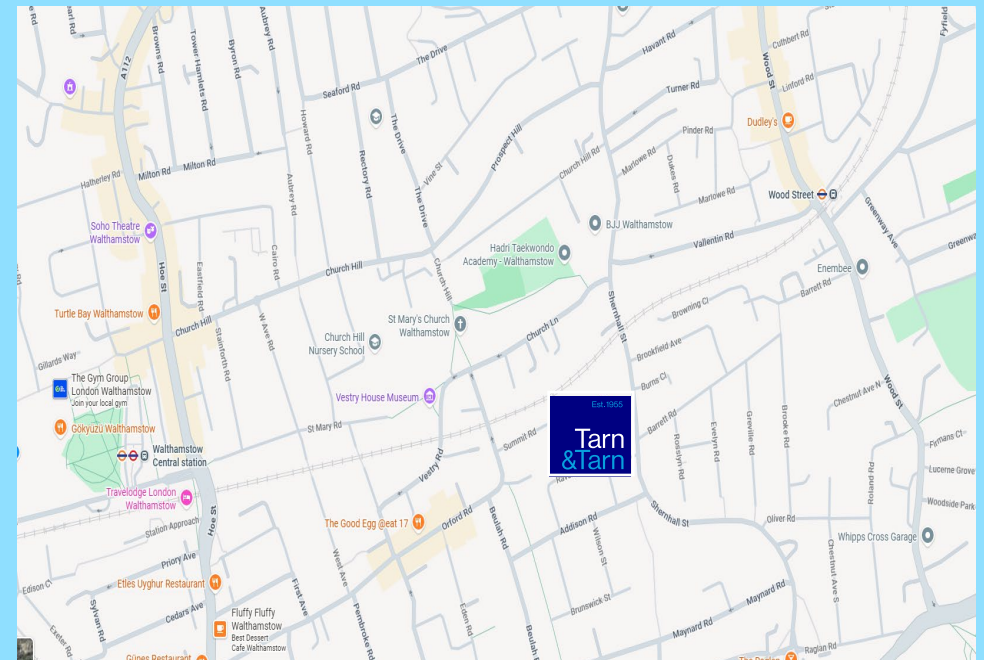
THE AREA
