Station Parade forms the centre piece of what has become known as Kew Village and is perfectly situated to benefit from the significant footfall between Kew Gardens Station and The Royal Botanic Gardens (UNESCO World Heritage Site attracts 2.1m visitors a year).

DESCRIPTION

The subject freehold property is an income producing high-street retail investment which forms part of Station Parade which is a handsome terrace of shops and maisonettes designed by John Hamilton in 1893.
