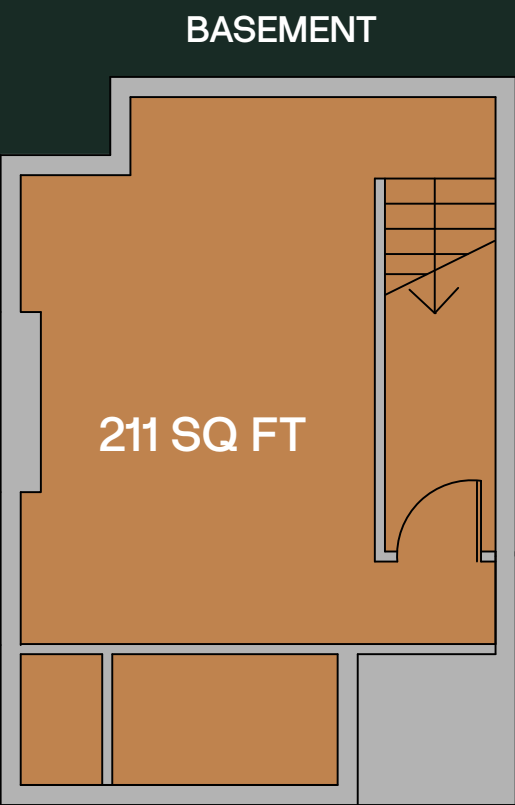
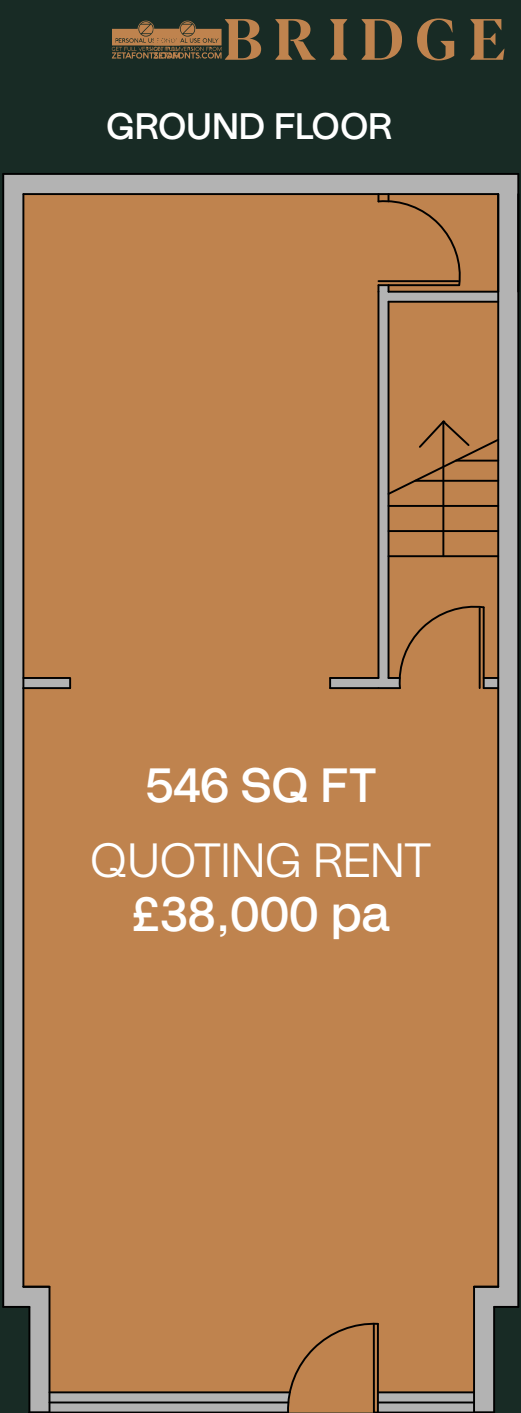
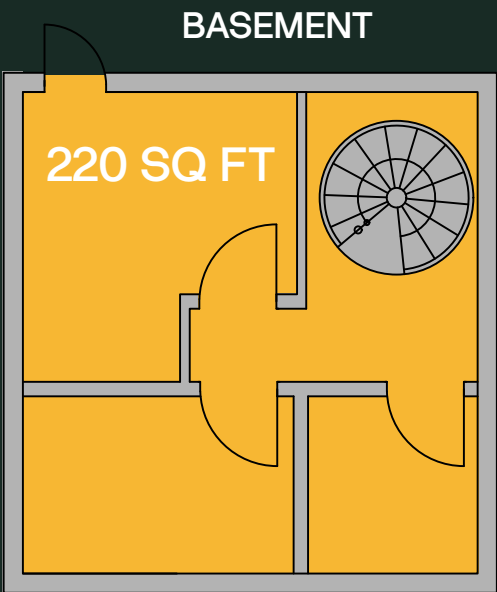
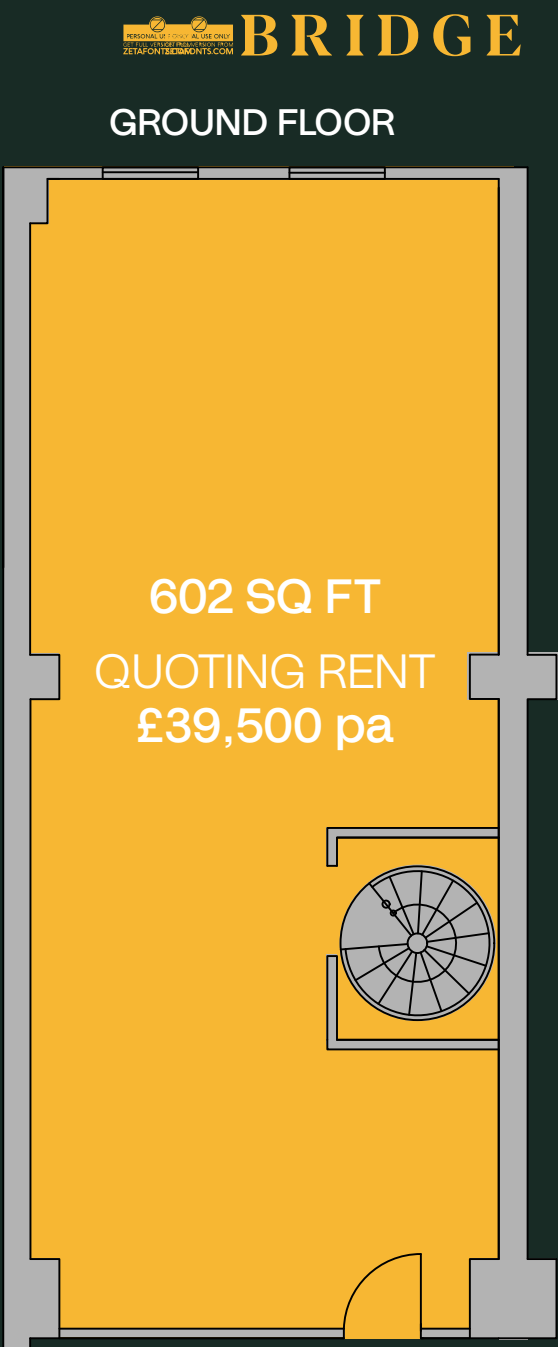
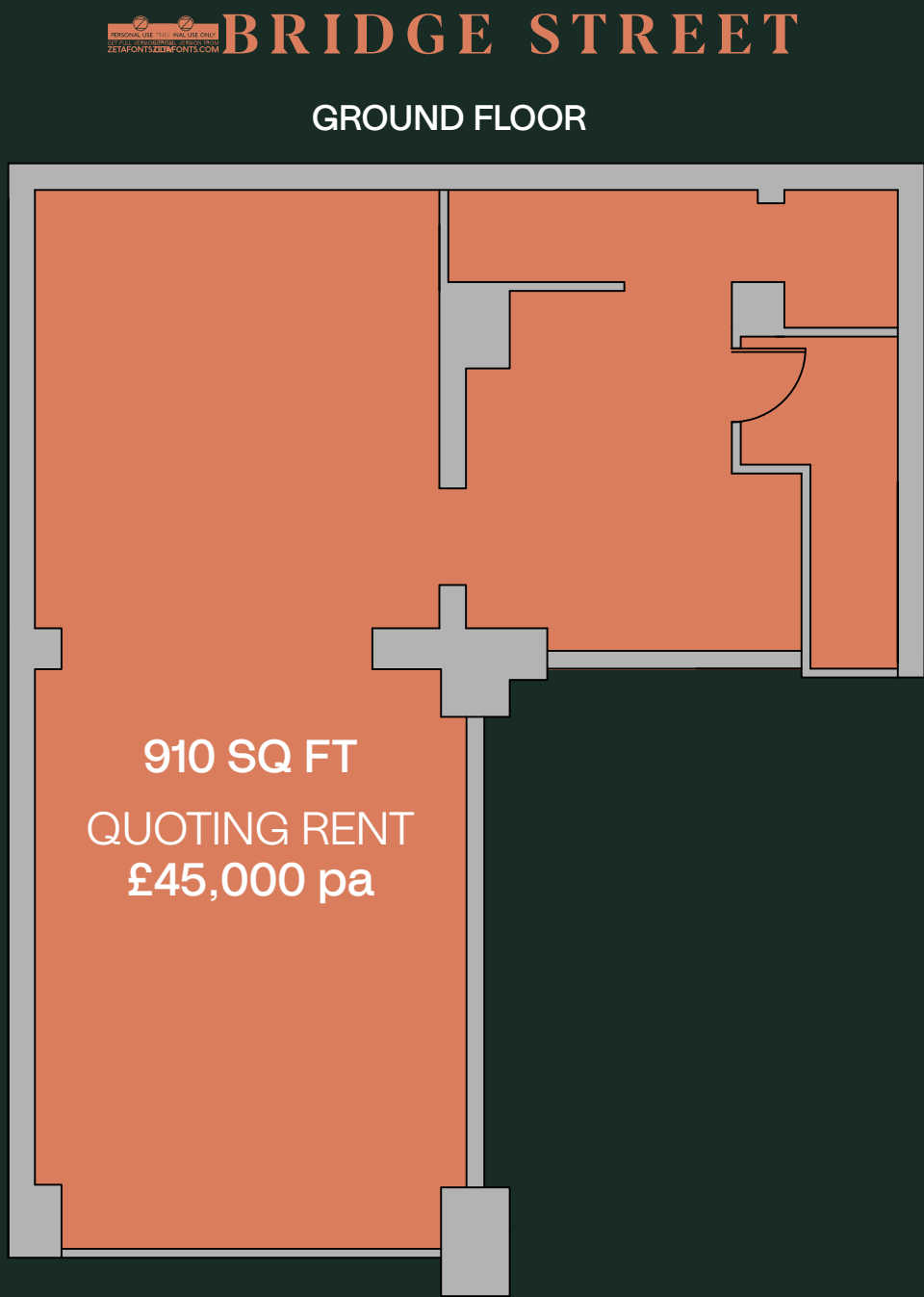
Bridge Street Chambers is a Victorian era building constructed in the late 19th Century. The building occupies a prominent position in close proximity to Deansgate and Spinningfields. Bridge Street boasts an array of national operators such as Sainsburys, Dishoom, Honest Burger and Co-op convenience store that are complemented by quality local operators including Stow and Kaji, two highly rated restaurants, and Doherty Evans and J Wippel and Co, two high end fashion retailers.



REFURBISHMENT
