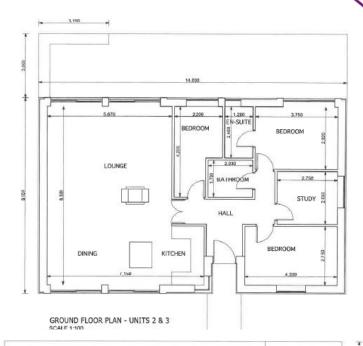


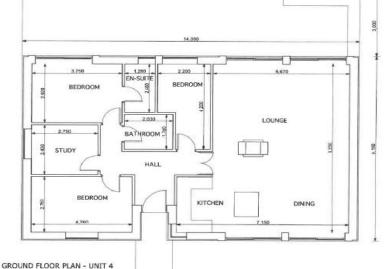


ACCOMMODATION

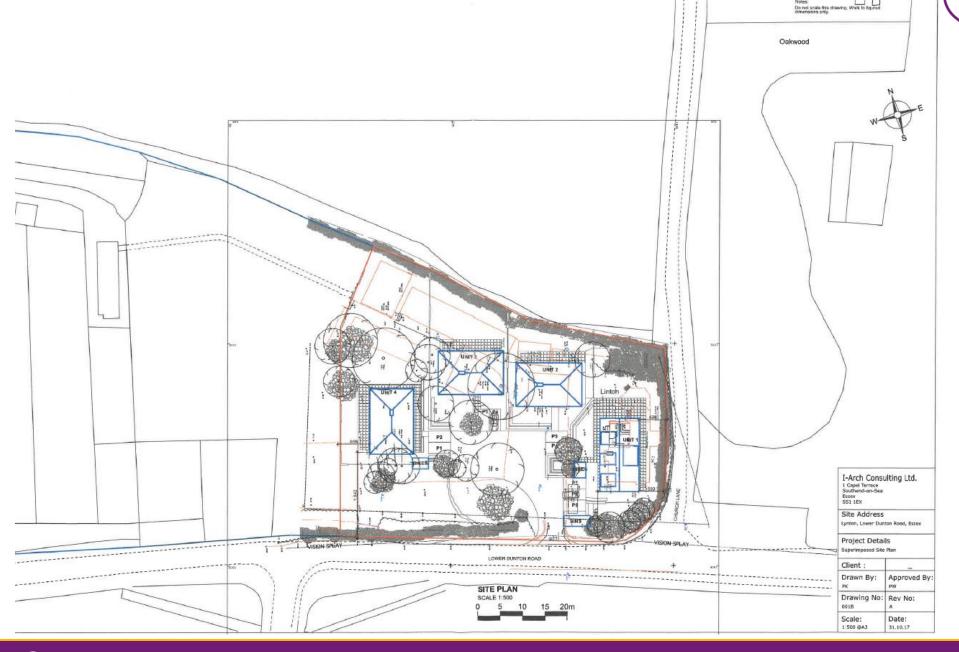
















SECTION A-A (WEST ELEVATION)
