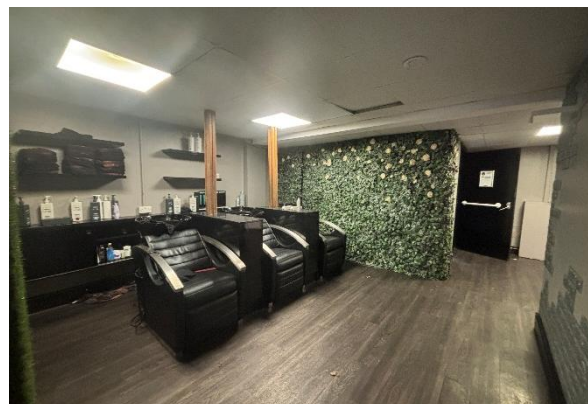
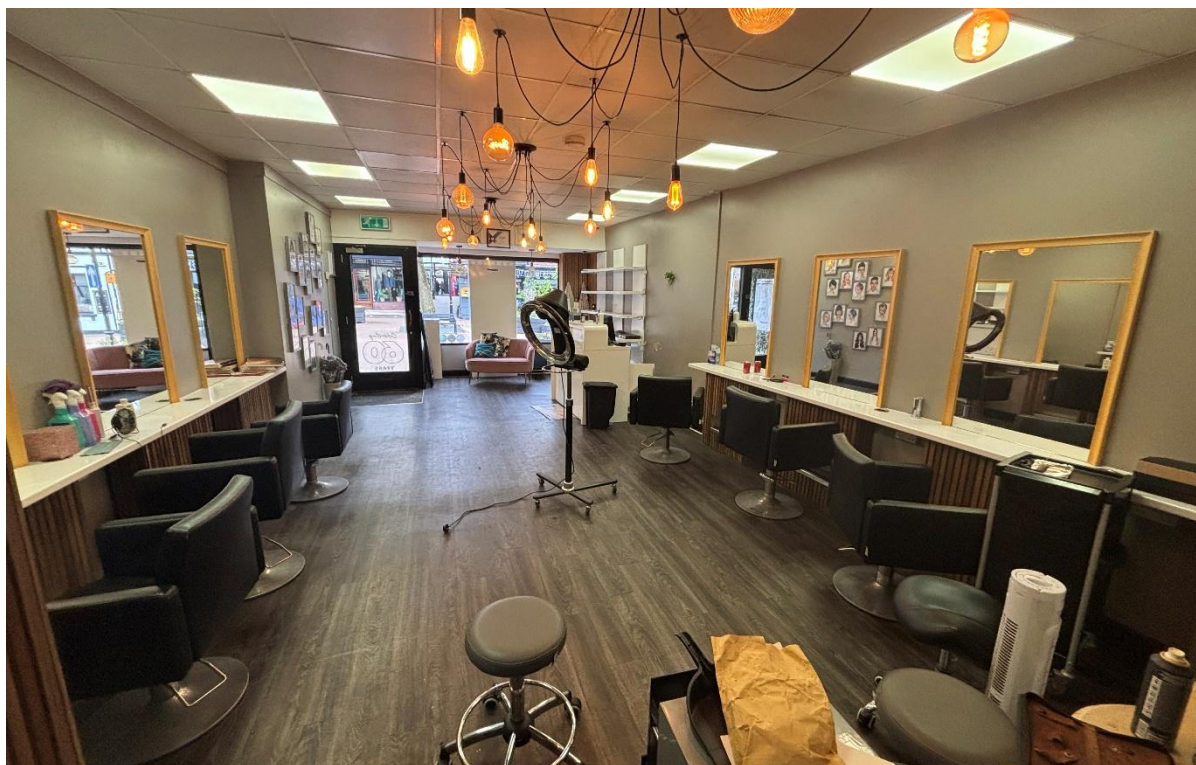

LOCATION

The property is located in the Town centre in a central location on Ironmarket, with nearby occupiers including Keele In Town, cafes, eateries, retailers and Newcastle Borough Council offices. There is also recent development of residential units at Queens Gardens Apartments and Deakins Yard offering 273 student accommodation.

The property is 0.3 miles (a 2-minute walk) away from the High Street intersection and close to the popular trading location Castle Walk. Newcastle is a principal shopping centre within the Potteries conurbation, with a residential population in the region of 74,000 and estimated catchment population of 366,340 within 10km of the centre.

DESCRIPTION

The premises comprises a ground floor retail unit currently fitted out as a salon for a turnkey operation including 3 plumbed in backwashes. Alternative uses are considered with the fixtures removable.

The premises offers sales area, split rear retail/store area, accessible WC and kitchen. To the rear is one parking space allocated with the premises. External there is an electric roller shutter to the front and seating on Ironmarket is possible subject to the tenant obtaining the necessary licence from Newcastle-under-Lyme Borough Council.

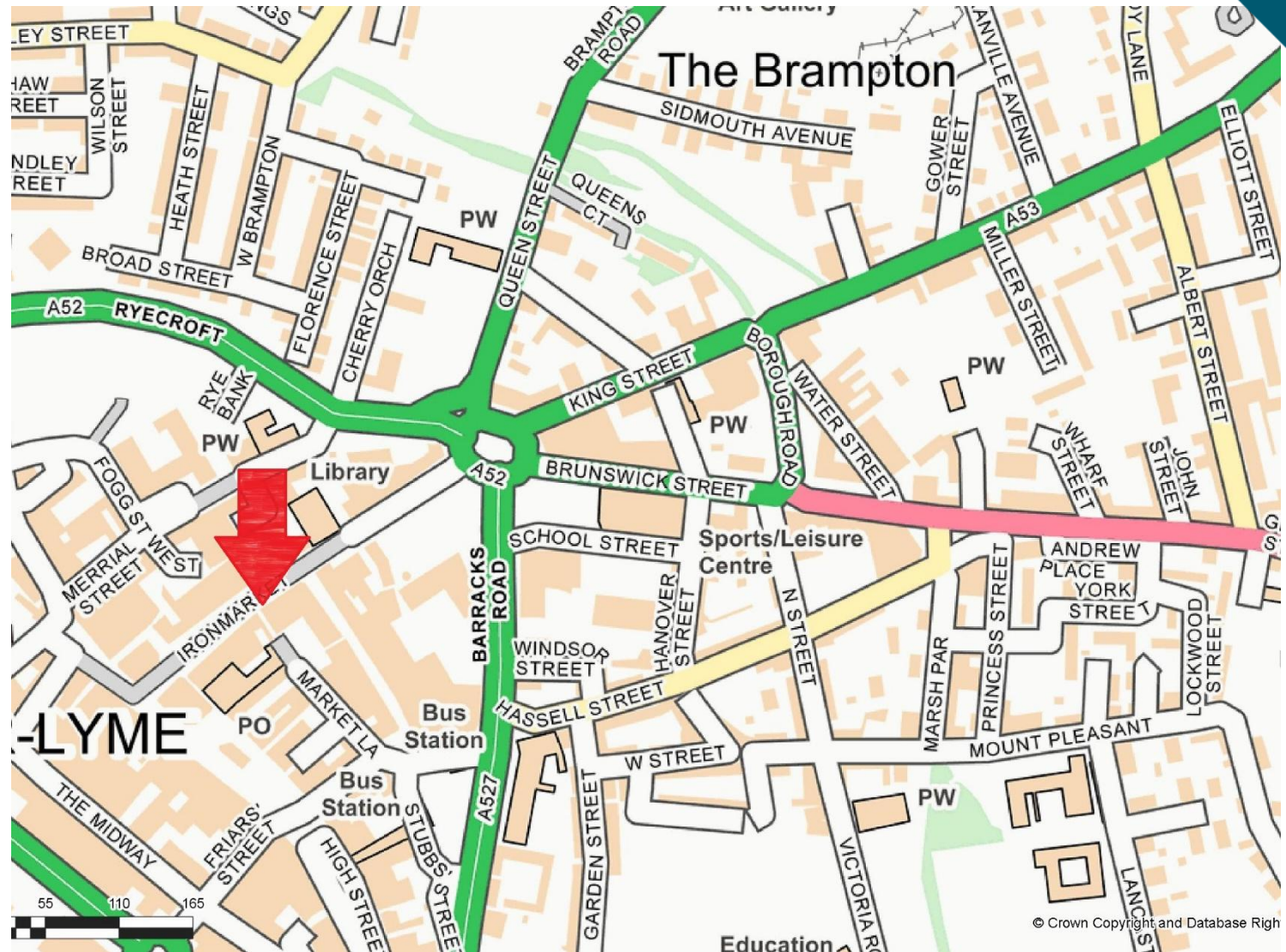
