Drummond Street is ready immediately with vacant possession.



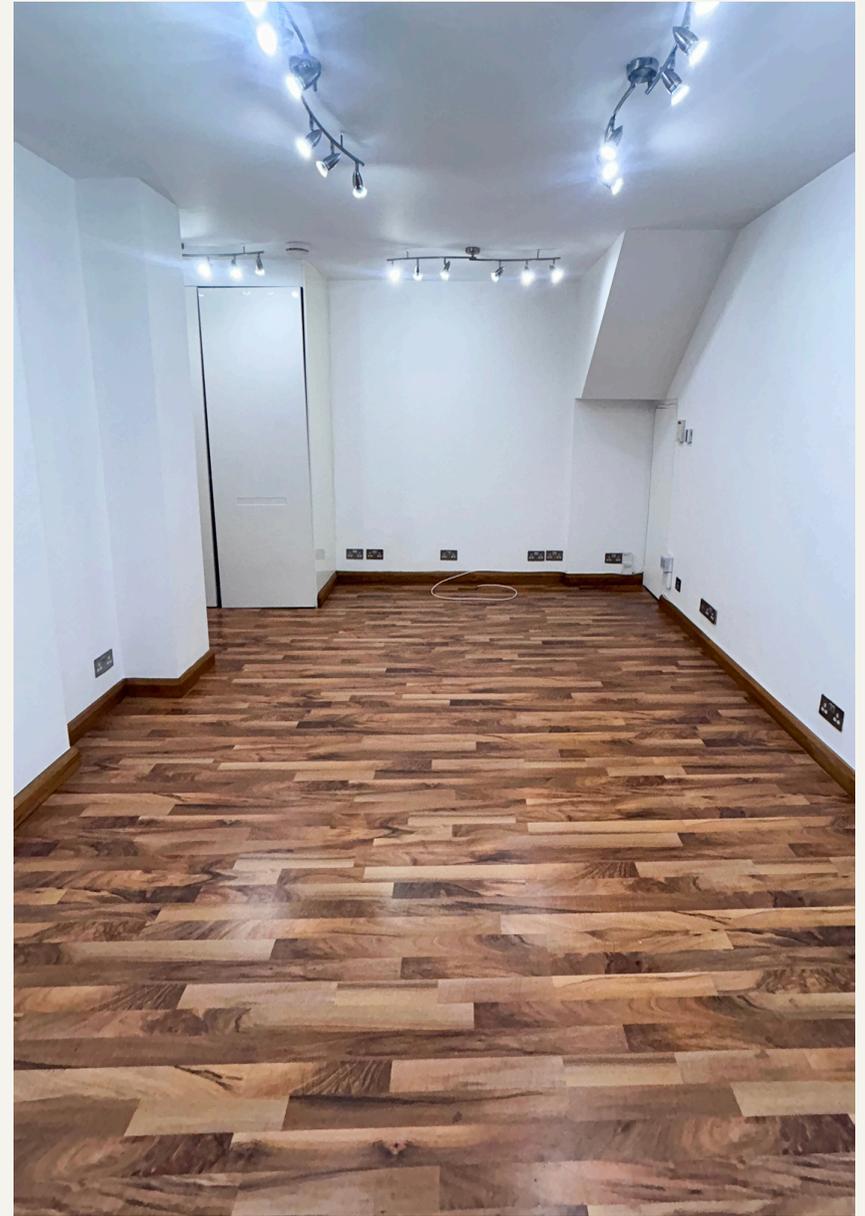
