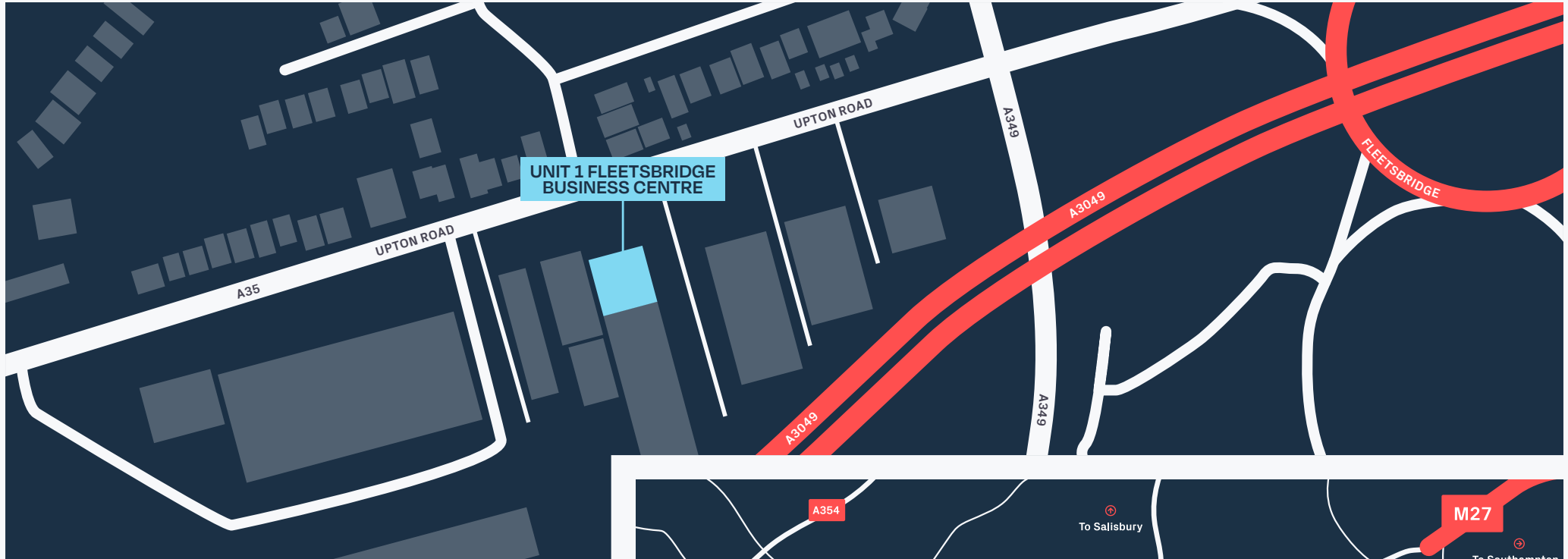

LOCATION

- The unit occupies a prominent position at the entrance to Fleetsbridge Business Centre which is accessed directly from the A35 Upton Road.

- Fleetsbridge interchange is approximately 380 metres from the business centre which connects to the A31 via the A349.
- Poole town centre is approximately 3 miles to the south and Bournemouth town centre is approximately 7.5 miles to the east.

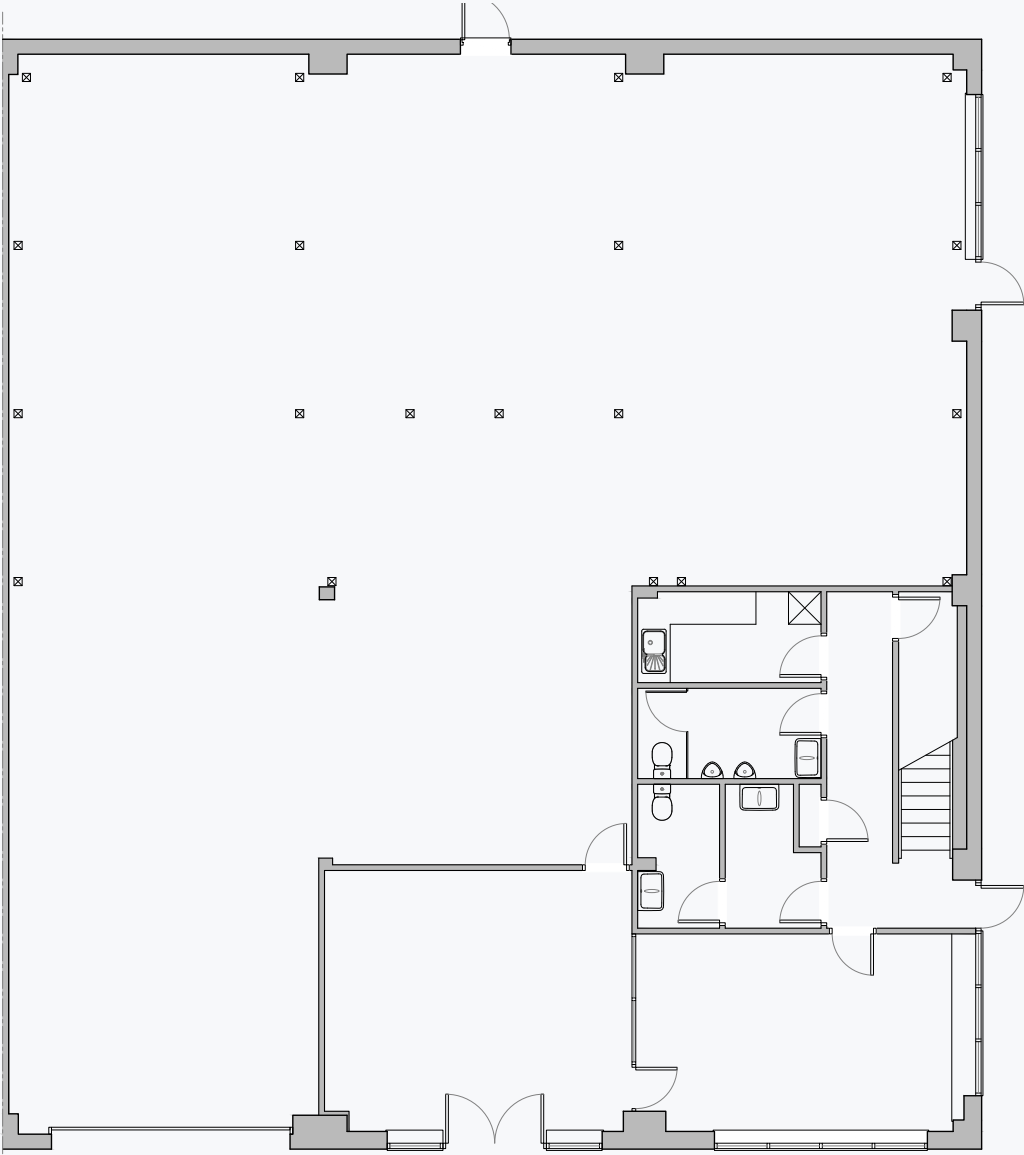

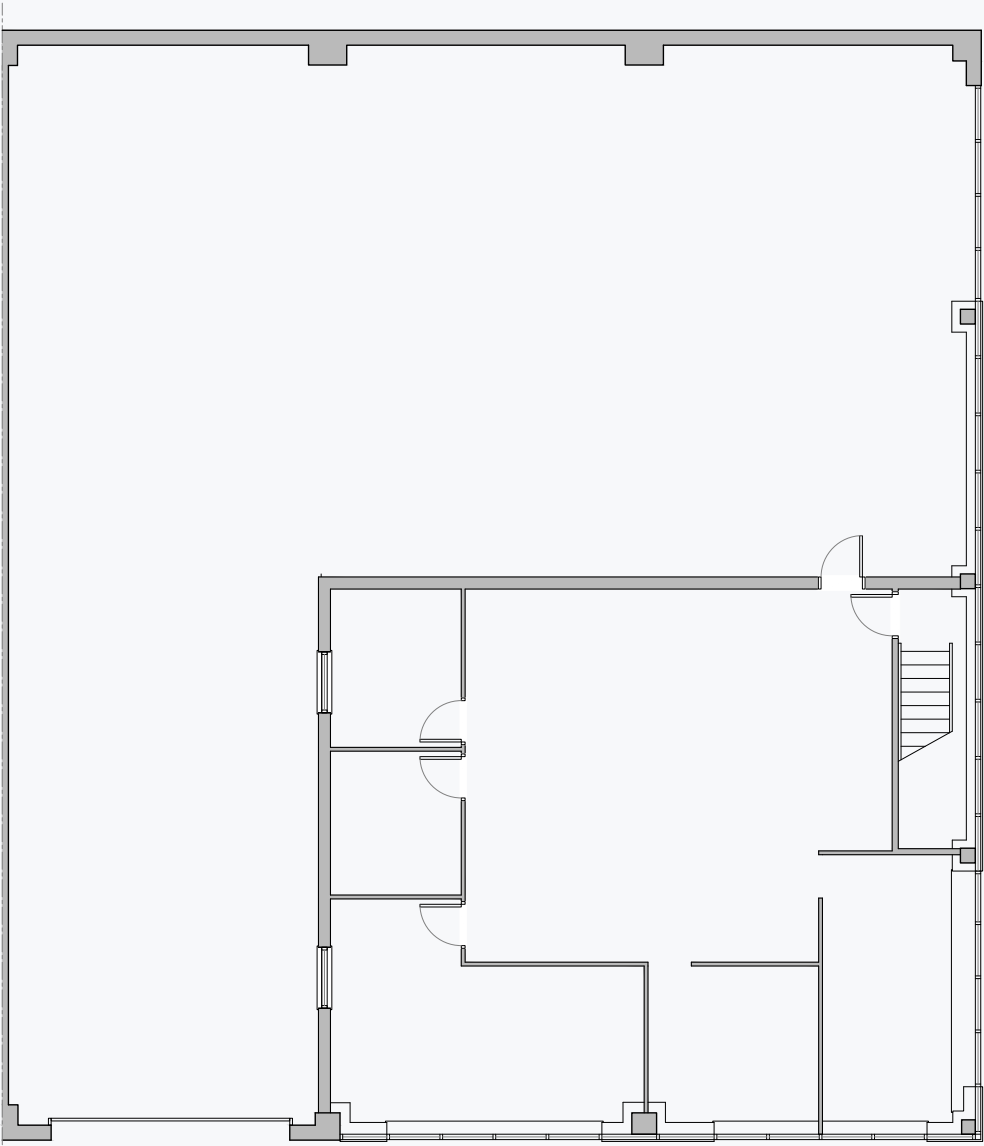
