Location

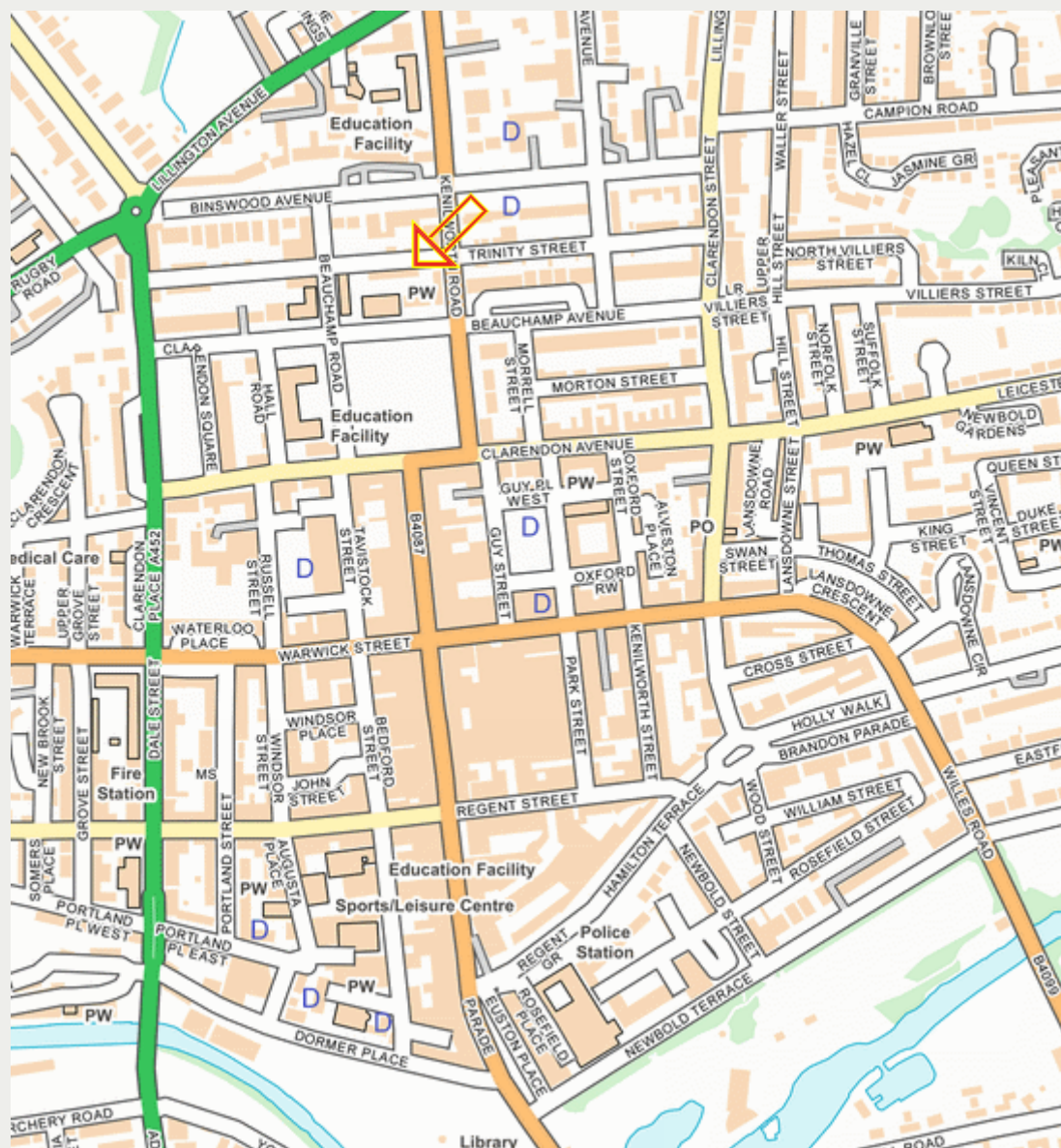

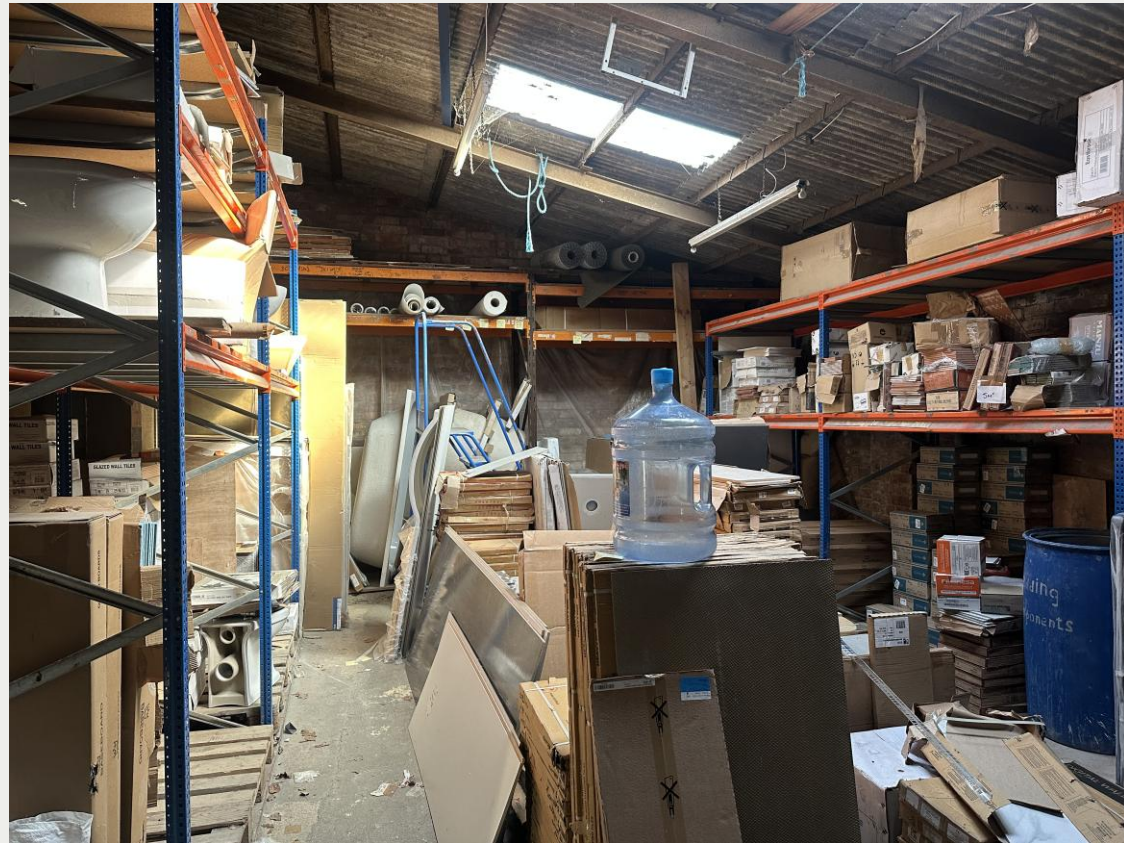

Overall, the property combines a central yet peaceful setting with outstanding access to amenities, transport links, and the wider region.



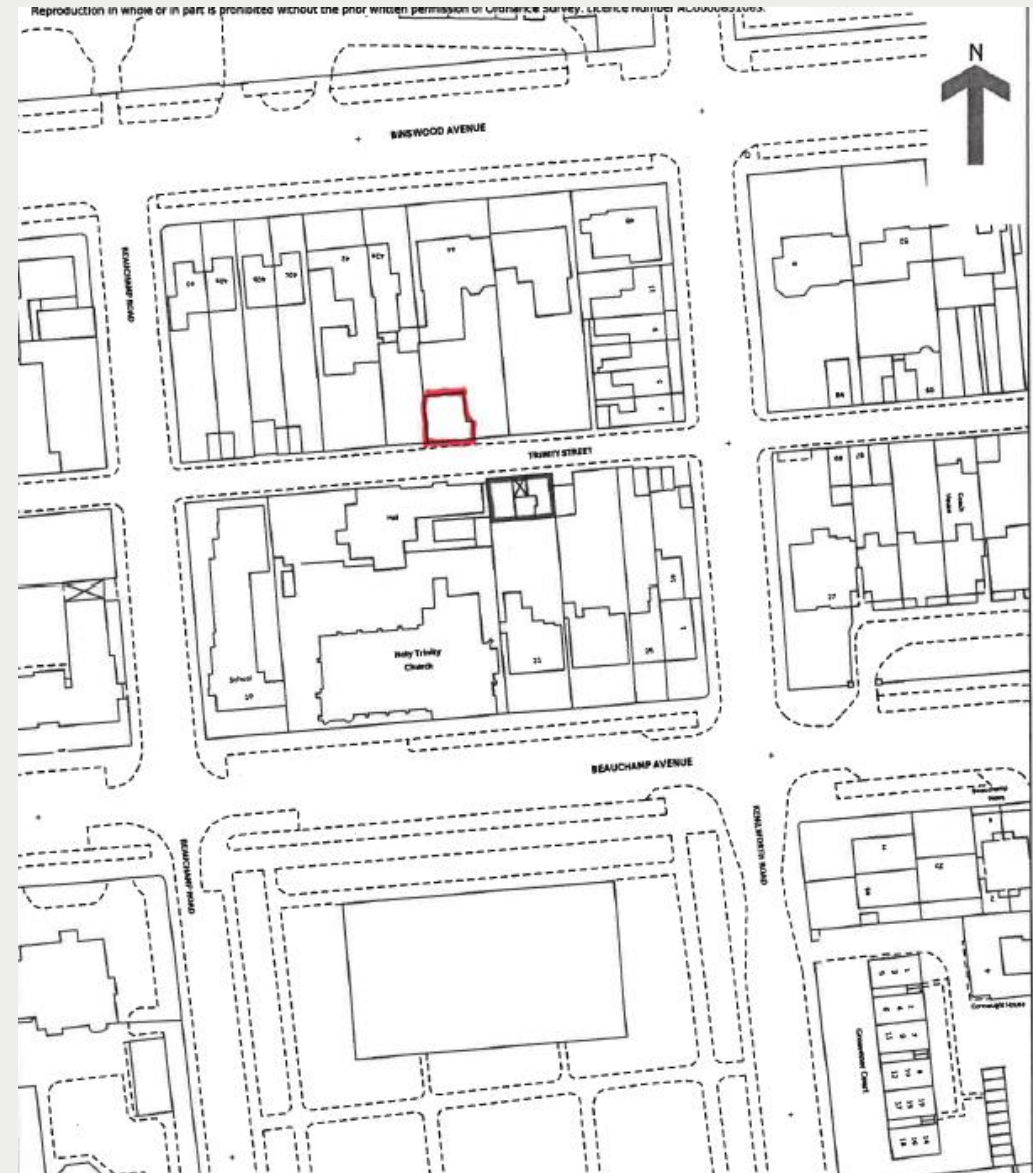
