# THE LOCATION

Located in Bromborough within easy access of Liverpool 6 miles to the North and Junction 5 of the M53 motorway to the South.

The site is located within the well established Wirral International Business Park, and is accessed directly off Pool Lane, close to the busy Docks of Birkenhead and Wallasey. Pool Lane is directly off the A41 which allows direct access to Junction 5 of the M53 motorway, providing access to the M56 motorway and the national motorway network. The A41 also provides direct links into Liverpool via the Queensway Tunnel.

The site is located within close proximity to the expansive Wirral Waters project which will further enhance and develop the local area with the creation of a new Enterprise Zone.

**DIRECT ACCESS TO JUNCTION 5 OF THE M53 MOTORWAY, WITH THE A41 ALSO PROVIDING DIRECT LINKS INTO LIVERPOOL VIA THE QUEENSWAY TUNNEL.**

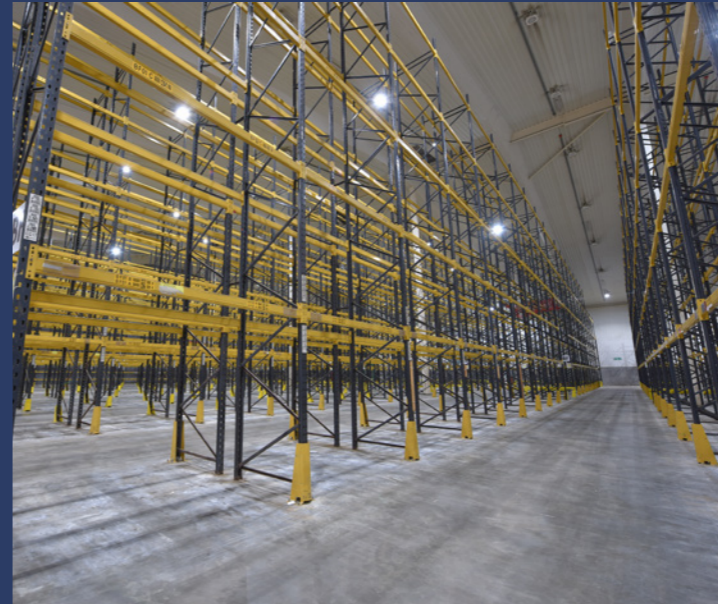

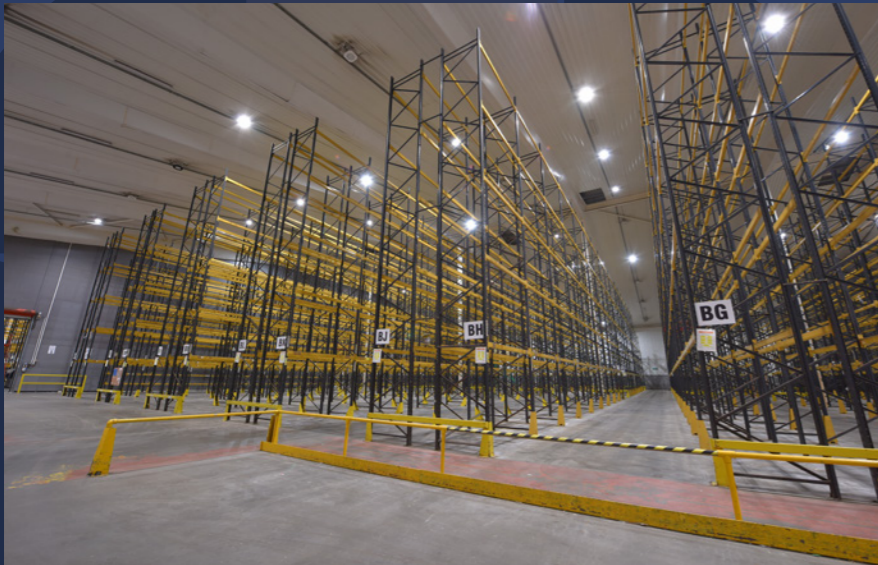
