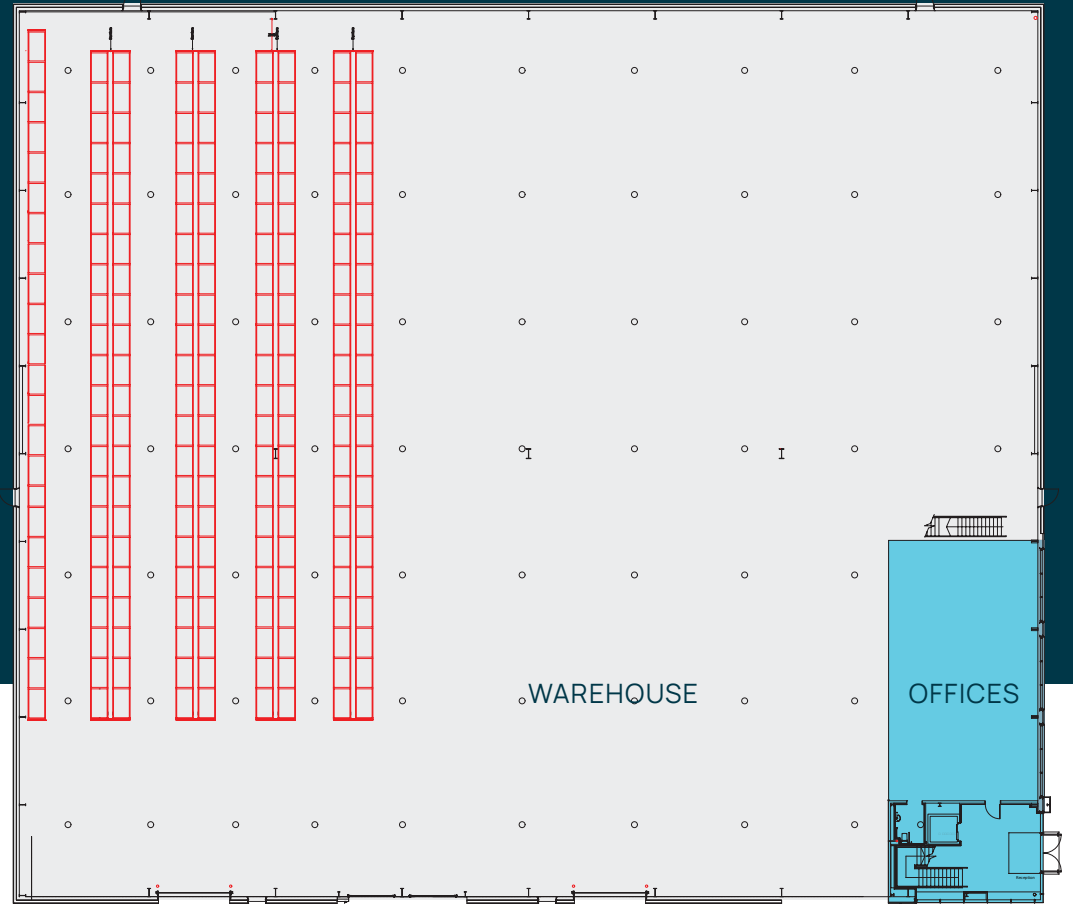




GROUND FLOOR

### Services

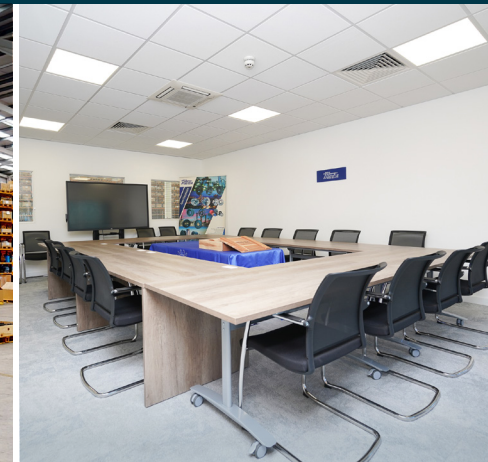
