SUMMARY

The estate in the late 1890's was occupied by Wells Brewery and subsequently taken over by Benskins, a big local brewer.

In 1959, Ray Hille bought the site in order to move and modernise the family furniture business Hille International, which originated in the East End of London. Whilst building new buildings, an original 1900's brick building was retained in the middle of the site.

The company, in the 1980's created smaller, lettable units and constructed a fifth building, all of which have been occupied by various users. A management office is retained on site.

The Hille Business Centre is just to the North of central Watford and very close to the hub of the local and national transport systems.

North Watford is attracting large scale residential developments including 'The Eight Gardens' development under construction, managed by Berkeley Homes which is on the adjacent site.

The available units offer a good opportunity for companies to accrue economical business accommodation in a living part of Watford to enable growth, so the business develops.

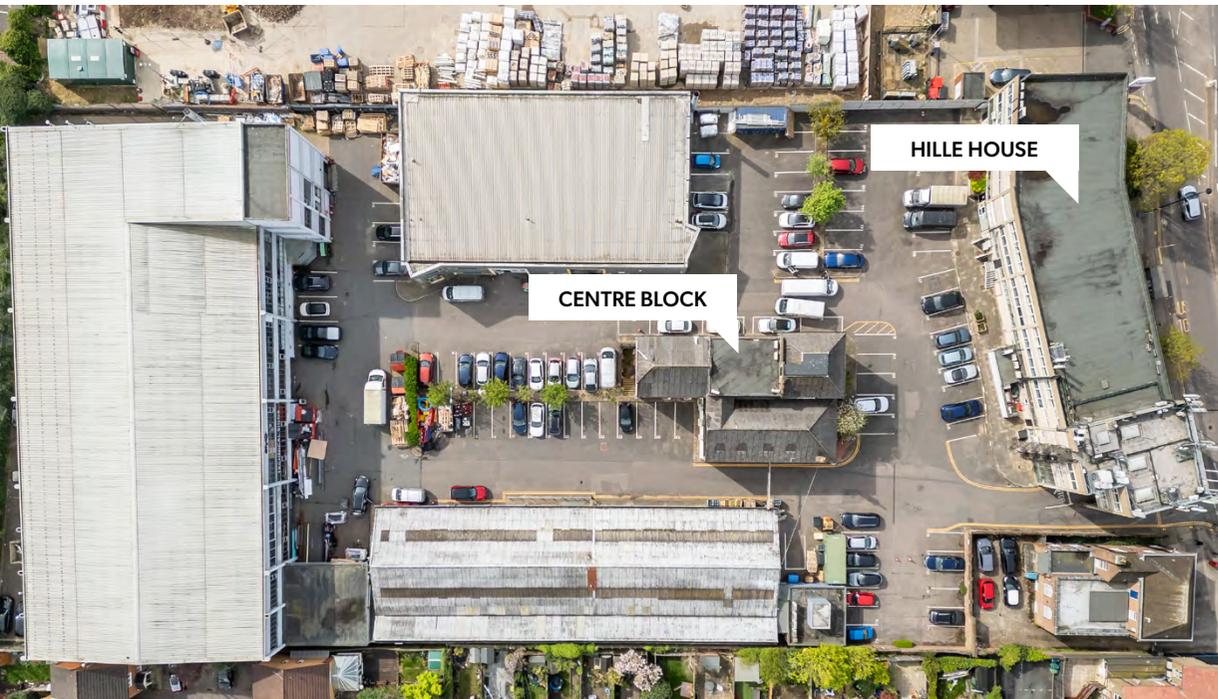
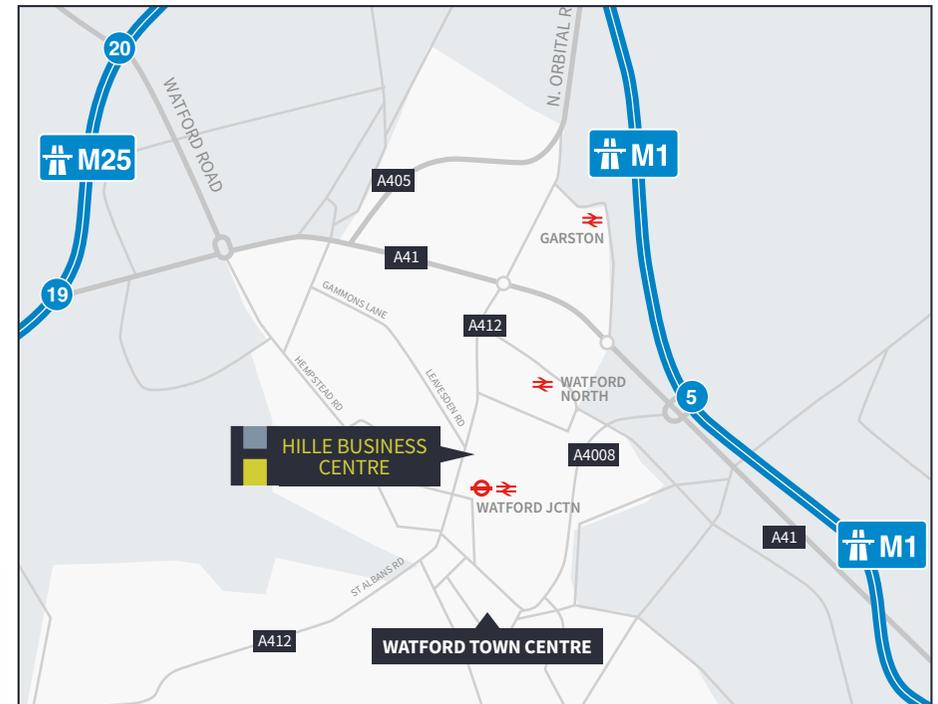
The town centre is also close by, which is well served by extensive retail facilities including the Atria shopping centre which has been significantly extended including a new multiplex cinema and bowling alley.
