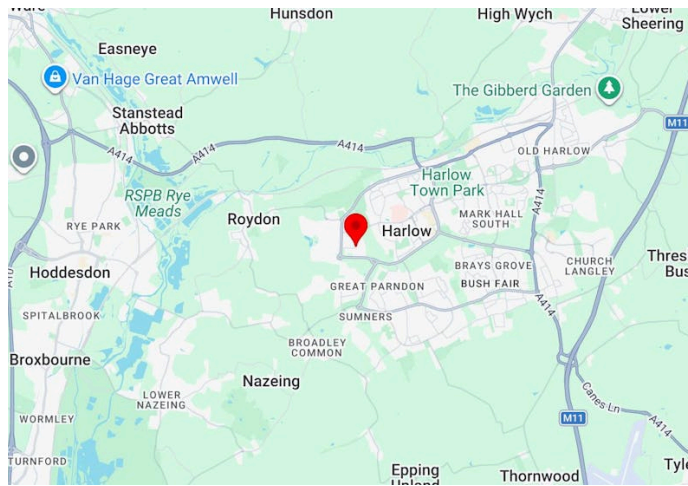

## Description

The property comprises an industrial/warehouse unit of steel portal frame construction with access via electric loading door to the rear elevation and separate office access to the front elevation via a pedestrian door. There is car parking at both front and rear. Internally there is full height warehouse/industrial space, ground floor staff facilities and an open plan first floor office.

## Location

The unit is located in the Pinnacles Industrial area close to other major occupiers such as Poundland, GlaxoSmithKline and Brake Bros.
