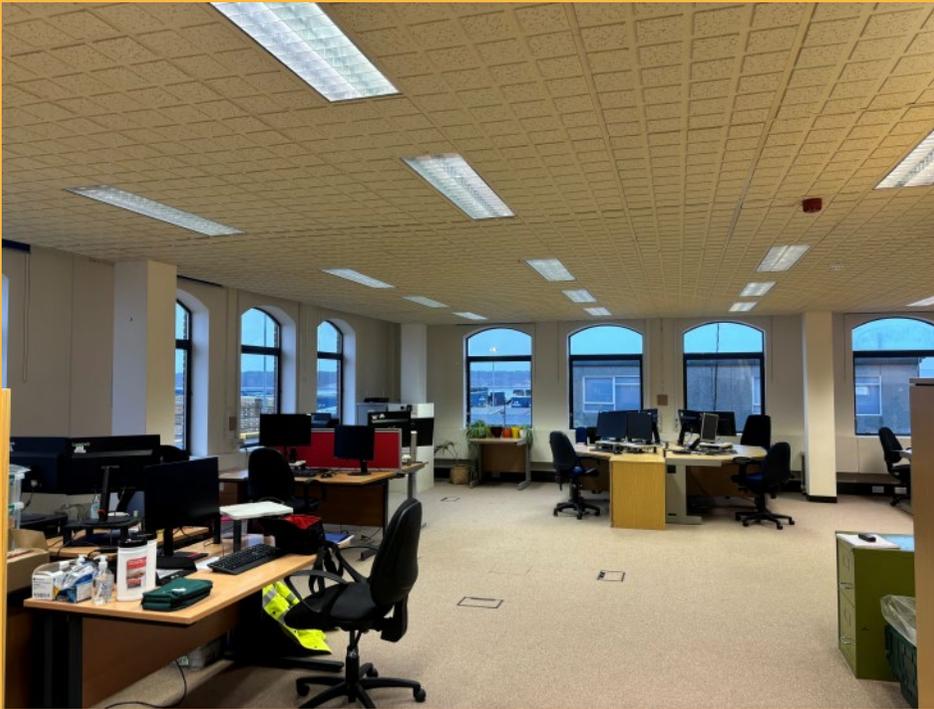

LOCATION

The property was built in 1990 and is located on New Harbour Road South within the Port of Poole. New Harbour Road connects with New Quay Road which in turn links to Bridge Approach at Poole Quay and Blandford Road (B3068). The property has excellent access to A350 Holes Bay Road which leads to A35 dual carriageway providing connectivity to both Dorchester and Bournemouth.

The Port of Poole is situated 1.5 miles to the south of Poole town centre with has both bus and train stations together with the Dolphin Shopping Centre. Poole Quay is within easy walking distance which provides a variety of hospitality and leisure facilities.

DESCRIPTION

The premises comprise the first floor of a substantial, detached office building in the Port of Poole. The accommodation is a combination of open plan and partitioned offices and benefits from good natural light.

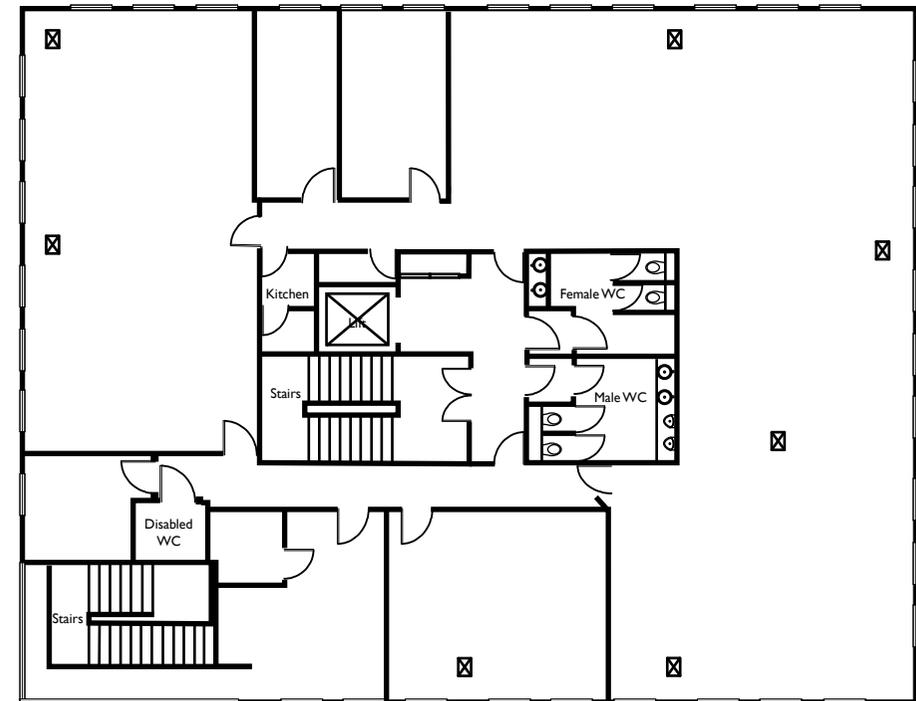
There are two entrances at the front and rear of the building and the central core provides lift and staircase access to the first floor together with male and female toilets and an additional separate WC.

There is a small kitchenette on the first floor but the premises also have shared use of a large kitchen on the top floor together with break-out/recreation space and a conference/meeting room. There are balconies on the top floor providing external space with excellent views of Brownsea Island and Poole Harbour.

The first floor comprises approx. 386.4 sq m (4,160 sq ft) and has 8 allocated parking spaces within the secure car park.
